INDEPENDENT AUDITORS' REPORT

To the Administrative Committee and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pettinaro Construction Co., Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pettinaro Construction Co., Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pettinaro Construction Co., Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

The accompanying financial statements have been prepared on a going concern basis. As discussed in Note 1 to the financial statements, the Administrative Committee of the Pettinaro Construction Co., Inc., the Plan's sponsor, voted in 2022 to merge the Plan into a pooled employer plan. Effective December 31, 2022, all of the assets were transferred to that plan, which indicates the Plan is not a going concern. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pettinaro Construction Co., Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. The Plan

General – The following description of the Pettinaro Construction Co., Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering certain employees of Pettinaro Construction Co., Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Trustees are responsible for the oversight of the Plan.

Plan Merger – On September 9, 2022, the Plan sponsor signed a pooled plan service agreement with Pentegra Services, Inc. (Pentegra”) whereby the Plan will become part of a pooled employer plan The Gratitude Pep and Pentegra will become the plan administrator. Effective December 31, 2022, the Plan was merged with The Gratitude Pep and the assets of the Plan totaling \$9,837,237, including participant loans of \$20,347 and investment income receivable of \$9,096, were transferred to a new trustee and custodian, Benefit Trust Company, on or about this date. Empower Retirement will provide recording keeping and administrative services effective on the later of January 1, 2023 or the date of the receipt of the first contributions from the Plan. As a result of the merger the Plan has terminated.

Eligibility – Employees of the Company who have 12 months of service with 1,000 hours worked and are 21 or older are eligible to participate in the Plan. Members of certain bargaining units, non-resident aliens, employees acquired in an acquisition, merger or similar transactions, and leased employees are not eligible to participate. Effective July 1, 2021, the minimum service requirement for eligibility for full-time employees to make elective deferral contributions changed to two months of continuous employment (with no minimum number of hours of service to be credited within the specified number of months). Additionally, the minimum service requirement for long-term part time employees is to allow employees who complete at least 500 hours of service during three consecutive years to have met the eligibility requirements to make elective deferral contributions.

Contributions – Each year, participants may contribute an amount of eligible pre-tax annual compensation as well as after-tax Roth contributions to the Plan subject to limitations determined by the Internal Revenue Service (“IRS”), which shall be deemed the Participant’s Deferral Contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) even if they are not yet eligible to participate.

The Company may elect to make certain safe harbor contributions to the Plan annually, including non-elective and matching contributions. During 2022, the Company elected to make safe harbor matching contributions to the Plan of 100% of participant’s deferral contributions up to the first 3% of eligible participant’s compensation, plus 50% of participant’s deferral contributions in excess of 3% up to 5% of eligible participant’s compensation. Participants are generally eligible to receive employer contributions after 1 year of service. The Company may also make additional discretionary contributions to the Plan, including qualified non-elective, matching, and profit sharing contributions.

Participants direct the investment of their deferral contributions and any Company contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options.

Participant Accounts – Each participant’s account is credited with the participant’s deferral contribution, as well as allocations of the Company’s contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their elective deferral contributions, rollover, and Company safe harbor contributions and qualified non-elective contributions plus actual earnings thereon. Participants become vested in the Company’s discretionary matching and profit sharing contribution portion of their accounts upon attainment of normal retirement age, suffering certain total and permanent disability, death or termination of employment after completion of service subject to the following vesting schedule:

Participants are credited with a year of service for vesting purposes upon completion of 1,000 hours of service during the Plan year.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$10,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at any time except for the purpose of refinancing an existing loan. Loan terms generally range from one to five years. The loans are secured by 50% of the vested balance in the participant’s account and generally bear interest at prime plus 1% as defined in the Plan. Principal and interest are generally paid ratably through payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or normal retirement, a participant may elect to receive an amount equal to the full value of the participant’s account in a lump-sum or other forms of payment available under the Plan. For distributions made for other reasons, including certain in-service and hardship withdrawals, a participant may only receive the value of certain vested interests in his or her account. If a participant has terminated employment for reasons other than early retirement, death, or disability, and his or her vested account balance is less than \$5,000, a mandatory distribution will be made and, if greater than \$1,000, an involuntary direct rollover into an Individual Retirement Account or Annuity may be made.

Forfeited Accounts – At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$-0- and \$9,569, respectively. Forfeited accounts may be used to reduce future Company contributions or pay Plan administrative expenses, or they may be allocated to other participants in accordance with the provisions of the Plan. Forfeitures were not used to reduce future company contributions or pay Plan expenses, for the year ended December 31, 2022. Forfeitures of \$11,067 are included in the assets transferred in connection with the Plan Merger.

Plan Amendment – Effective January 1, 2021, the Plan was amended and restated to include, among other things, the applicable provisions of the CARES and SECURE (“Setting Every Community Up for Retirement Enhancement”) Acts.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments – The Plan's investments are stated at fair value. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and third-party administrators. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. A provision for doubtful accounts has not been recorded as of December 31, 2022 and 2021. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in administrative fees. Certain administrative fees are paid with revenue sharing credits from the custodians, which are included in administrative fees in the accompanying financial statements. Such amounts are not material to the financial statements.

3. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820 establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument’s categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. ASC 820 establishes three levels of inputs that may be used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access;

Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities;

Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investments

During 2022, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year), depreciated in value by \$3,025,133.

Interest and dividend income on investments for the year ended December 31, 2022 was \$287,386.

5. Certification Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022 and 2021, net depreciation in the fair value of investments, and interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by AdvisorTrust, the custodian of the Plan.

6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Effective December 31, 2022, the Plan was terminated and merged into a pooled employer plan (see Note 1).

7. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and the related trust as evidenced by a prototype document, are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan's Trustees and the Plan's third-party administrator believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

8. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments include money market accounts with MG Trust (Matrix), a sub custodian of the Plan. Therefore, these investment transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA. Additionally, certain fees incurred and paid to the custodian, investment advisors, and third-party administrators as well as loans to participants are also exempt party in interest transactions.

9. Risks and Uncertainties

The Plan invests in various investment instruments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the value of investment instruments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

Subsequent events have been evaluated through September 28, 2023, the date that the financial statements were available to be issued.
