As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance

with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the financial statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation



and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Plan Merger

As further discussed in Note 1, Iron Mountain Incorporated acquired ITRenew, Inc. and decided to merge the Plan into The Iron Mountain Companies 401(k) Plan on December 31, 2022 in accordance with the provisions of ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the ITRenew, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

In January 2022, Iron Mountain Incorporated acquired ITRenew, Inc. ("the Company") and decided to merge the Plan into The Iron Mountain Companies 401(k) Plan on December 31, 2022. Plan assets in the amount of \$10,779,326 which included notes receivable from participants were transferred to Fidelity Management Trust Company, the custodian of The Iron Mountain Companies 401(k) Plan in accordance with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

General - The Plan was a defined contribution plan that was established on January 1, 2012 by the Company covering all eligible employees of the Company as defined in the Plan agreement. Effective April 22, 2022, the Plan was amended to exclude certain classes of employees as defined in the Plan agreement from plan participation. The Plan is subject to the provisions of ERISA.

A Plan Committee ("the Committee") managed the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company contracted with Reliance Trust Company ("RTC") to act as trustee and custodian. A third-party administrator ("TPA") processed and maintained the records of participant data.

Contributions - Each year, participants could contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. The Plan allowed for ROTH deferral contributions. Participants who were age 50 or older could elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participant's contributions receivable of \$56,365 as of December 31, 2022 was paid in 2023 into The Iron Mountain Companies 401(k) Plan. Participants could also contribute amounts representing distributions from other qualified eligible plans.

The Plan allowed for an employer safe harbor matching contribution subject to certain eligibility requirements. For the years ended December 31, 2022 and 2021, the Company made safe harbor matching contributions equal to 100% of a participant's elective deferral not to exceed 4% of the participant's eligible compensation. The Company's safe harbor matching contribution for 2022 was \$1,005,183 of which \$142,996 was a receivable as of December 31, 2022 and the

receivable was paid in 2023 into The Iron Mountain Companies 401(k) Plan. The Company's safe harbor matching contribution for 2021 was \$922,123, of which \$163,953 was a receivable as of December 31, 2021 and was paid in 2022. The Plan also allowed for an employer flexible discretionary matching contribution and/or discretionary nonelective contribution subject to certain eligibility requirements; none were made for the year ended December 31, 2022.

Participant Accounts - Each participant's account was credited with the participant's contribution, the Company's safe harbor matching contribution, the discretionary matching contribution (if any), an allocation of the discretionary nonelective contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of the discretionary nonelective contribution were based on participant compensation. Allocations of plan earnings and losses were based on individual participant investment choices. All investments, which includes both participant and employer contributions, were participant directed. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting - Participants were 100% vested in their contribution, safe harbor matching contribution and rollover amounts plus actual earnings thereon. Participants were fully vested in the discretionary matching contribution and earnings after one year of credited service. Vesting in the discretionary nonelective contribution and earnings was based on years of credited service based on 20% per year after 2 years and full vesting after 6 years. Participants became fully vested in the event of death, disability, retirement age, or plan termination. In connection with the merger, participants became fully vested in their accounts.

Notes Receivable from Participants - Participants were able to borrow up to 50 percent of the value of their vested account balance. The maximum loan amount was \$50,000, and the minimum loan amount was \$500. The notes were secured by the balance in the participant's account and bear interest at rates which were commensurate with prevailing rates as determined by the Plan Administrator. Outstanding notes receivable from participants as of December 31, 2022 were transferred to The Iron Mountain Companies 401(k) Plan and carried interest rates which range from 5.25% to 9.50%. Outstanding notes receivable from participants as of December 31, 2021 carried interest rates which range from 5.25% to 7.25%. Principal and interest were paid per the terms of the note and in accordance with plan provisions. The Plan Administrator established the specific terms and conditions of such notes.

Payment of Benefits - Upon the satisfaction of certain distributable events, participants or their beneficiaries could elect to receive their vested account balance and were paid in accordance with plan provisions.

Forfeited Accounts - Forfeited accounts could be used to pay plan expenses, reduce employer contributions, or reallocated to eligible participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determined the Plan's valuation policies utilizing information provided by RTC. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of December 31, 2022 and 2021. Delinquent participant notes were recorded as distributions on the basis of the terms of the Plan agreement.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") were recorded as a liability. As of December 31, 2022, excess contributions were made to certain participants to pass certain non-discrimination tests. These amounts were

refunded in 2023 by the appropriate required deadlines in 2023. As of December 31, 2021, there were no excess contributions payable.

Plan Expenses - In 2022, some plan fees were paid by the Company and these amounts were excluded from the Plan's financial statements. Investment/fund fees and certain participant transaction fees were charged to participant accounts as applicable.

Payment of Benefits - Benefits were recorded when paid.

Subsequent Events - The Plan had evaluated subsequent events through October 3, 2023, the date the financial statements were available to be issued.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022 and 2021, dividends, interest income on notes receivable from participants, and net depreciation in fair value of investments for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by RTC.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provided a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy were described as follows:

Level 1 - Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that were observable for the asset or liability;
- inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following was a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used at December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

There were no assets as of December 31, 2022. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021.

NOTE 6 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments were managed by RTC. Any purchases and sales of these investments were performed in the open market at fair value. Plan related fees were paid to RTC and the TPA. The Plan has other service providers. All of these transactions including participant notes receivable, while considered party-in-interest transactions under ERISA regulations, were permitted under the provisions of the Plan and were specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 7 - TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated October 6, 2020 from the IRS. The Plan has been amended since, however, the Plan Administrator believed that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believed the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The differences between the information reported on the financial statements and the information reported on the Form 5500 arise primarily from presenting the financial statements on the accrual basis of accounting and Form 5500 on the cash basis.
