### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of AeroCare Holdings, Inc. 401 (k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of Plan**

The following description of the AeroCare Holdings, Inc. (the Company) 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of the Company who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute pretax and post-tax annual compensation, as defined in the Plan, limited by the provisions of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the provisions of the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan offers both a pretax and Roth elective deferral. The Company may make annual discretionary matching contributions and/or profit-sharing contributions to the Plan to the extent allowable by the Internal Revenue Code (IRC).

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings. The Company's contribution portion of their accounts are based on years of continuous service. Participants prior to May 20, 2012, begin vesting in year one (25 percent) and vesting increases ratably until fully vested in year four. Participants joining the plan after May 20, 2012, begin vesting in year two (20 percent) and vesting increases ratably until fully vested in year six.

**1. Description of Plan (continued)**

**Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

**Payment of Benefits**

On termination of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The participant may elect to receive a direct distribution or roll the amount over into an eligible retirement plan. If the vested account balance is less than \$1,000, a distribution may be made to the participant regardless of consent.

**Forfeited Accounts**

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$-0- and \$63,066 respectively. These accounts can be and have been used to pay administrative expenses of the Plan and reduce future employer contributions.

**2. Summary of Significant Accounting Policies**

**Date of Management's Review**

Subsequent events were evaluated through June 2, 2023, which is the date the financial statements were available to be issued.

**Use of Estimates**

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting. Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statements of Changes in Net Assets Available for Benefits are prepared on a contract value basis.

**Investment Valuation and Income Recognition**

Investments are stated at fair value (except for stable value insurance contracts, which are stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

Certain expenses of maintaining the Plan are paid by the Company. All other expenses are paid by the Plan.

**3. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Investment Contract with Insurance Company**

The Plan's investment portfolio includes a group annuity contract with Great-West Life and Annuity Insurance Company (GWL&A). The Key Guaranteed Portfolio Fund (KGPF) is a general account product of GWL&A. Because the KGPF is a general account product offered through a group annuity product, participant principal and interest are fully guaranteed by the entire general account assets of GWL&A. The annuity contract is recorded at contract value, which approximates fair value.

**5. Investment Contract with Insurance Company (continued)**

The KGPF is a stable value asset. The KGPF credits daily to the group contract holder on a portfolio basis. The credited interest rate may change or stay the same each quarter. The quarterly credited rate applies to all money deposited in the group contract holder's KGPF account, regardless of when it was deposited.

General account products within retirement plans are offerings through which insurance companies guarantee both principal and interest to participants invested in the products. This affords participants the ability to both preserve capital and receive a generally higher credited rate than what is offered by money market funds in most interest rate environments.

Contract value, as reported by GWL&A to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Based on GWL&A's trading policy, participant transfers may be restricted up to 30 days in the event of excessive participant trading. KGPF transactions are processed after the resolution of closed or disrupted financial exchanges or markets.

The contract value of the investment contract at December 31, 2022 was \$-0-.

Certain events limit the Plan's ability to transact at contract value with GWL&A. Such events may include, but are not limited to the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (c) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value. Examples of such events may include: (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**6. Related Party Transactions and Party-In-Interest Transactions**

Certain plan expenses, such as auditing and accounting, are paid by the Plan's participating employer. These payments are considered related party transactions since the plan received services from the plan sponsor and no accounting recognition is made. However, these transactions are not prohibited transactions under ERISA.

**7. Tax Status**

The Company adopted a PayChex Prototype Non-standardized Profit-Sharing Plan with a cash or deferred arrangement. The prototype plan sponsor obtained a favorable opinion letter from the Internal Revenue Service, amended date May 20, 2012, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator has adopted all Plan provisions within the prototype document and believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Plan Merger**

On January 20, 2022, the Plan was merged into the AdaptHealth Corporation 401(k) Profit Sharing Plan and Trust - EIN #45-5553972 Plan 001. All Plan assets were transferred into the new plan as of December 31, 2022.
