Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jason Employee Savings & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 DESCRIPTION OF PLAN

The following description of Jason Employee Savings & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 1986. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective July 31, 2022. The Plan excludes leased employees, nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of Jason Group Inc. (Company, Sponsor or Employer) are eligible to participate as of the first business day of the month following the completion of 60 days of continuous service, the completion of six months of employment and 500 hours of service, the completion of 12 months of employment and 1,000 hours of service, or the completion of 1,000 hours of service in any Plan year.

Contributions

Each year, participants may contribute up to 50% of their defined annual compensation. Participants may elect to have any portion, or all of their contributions designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision where-by all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. Unless elected otherwise, each January the automatic deferral amount will increase by 1% capping at 10% of eligible compensation. The Company may, at its discretion, make a matching contribution to the Plan. The Company matches 50% of the first 6% of a participant's salary deferral contributions to the Plan.

The Company remits participant contributions and Employer matching contributions to the Plan on a bi-weekly basis.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company's matching contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions, and any earnings thereon. Vesting in Employer matching contributions is based on the participant's years of continuous service. A participant is 100% vested in Employer matching contributions that have been allocated to the participant's account after three years of credited service, as defined. Participants also become 100% vested in Employer matching contributions upon a participant's death, total disability, or attainment of normal retirement age. Vesting service includes years of service with both Jason Group Inc. and its predecessors.

Benefit Payments

Active participants are eligible to withdraw all or a portion of contributions upon written request and approval of the Administrative Committee via an in-service withdrawal or an eligible hardship withdrawal. Upon receiving a hardship distribution of participant deferrals from the Plan, participants will not be able to make salary deferral contributions for six months after receipt of the distribution.

On termination of service, participants are entitled to receive, in a lump-sum, the entire value of their Employer and participant accounts upon normal retirement age (which varies by division), disability, or death. Participants who terminate for any reason are entitled to receive the entire value in their participant account and the vested portion of their Company account.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce Company contributions and administrative expenses. Forfeited nonvested accounts as of December 31, 2022 and 2021 totaled \$127,075 and \$266,957, respectively. There were \$11,250 and \$-0- of forfeitures used to offset Company contributions for the years ended December 31, 2022 and 2021, respectively. There were \$238,359 and \$27,631 of forfeitures used to reduce employer contributions and administrative expenses for the years ended December 31, 2022 and 2021, respectively.

Administration

The Company is the administrator of the Plan and has appointed Matrix Trust Company as trustee and custodian effective May 21, 2021. BMO Harris Bank N.A. was the trustee and custodian prior to May 21, 2021. OneAmerica Retirement Services, LLC is the Plan's recordkeeper. The trustee and custodian are responsible for investing and safekeeping all of the assets of the Plan. The overall responsibility for administering and oversight of the Plan rests with a group of employees from the Company known as the Administrative Committee.

Plan Transfers

Effective October 31, 2022, the net assets of Milsco Manufacturing Company Hourly 401(k) Plan merged into the Plan which totaled \$862,002. This amount is included in the Plan Transfers on the statement of changes in net assets available for benefits as of December 31, 2022.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by either the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Certain administrative expenses of maintaining the Plan are allocated and charged to participants based on participant account balances, as defined, and are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 27, 2023, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Matrix Trust Company, the qualified institution of the Plan effective May 21, 2021, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, the supplemental schedule of assets (held at end of year) as of December 31, 2022, and the related investment activity reflected in the statements of changes in net assets available for benefits for the year ended December 31, 2022 and from May 21, 2021 to December 31, 2021.

BMO Harris Bank N.A., the qualified institution of the Plan through May 20, 2021 has certified to the completeness and accuracy of all investment activity reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2021 through May 20, 2021.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds – Valued at the NAV of units held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 PLAN TAX STATUS

The Plan obtained an opinion letter, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Matrix Trust Company or BMO Retirement Services, an affiliate of BMO Harris Bank N.A, the qualified institutions of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain employees and officers of the Plan sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

NOTE 9 NONEXEMPT TRANSACTIONS

During 2022, the Company failed to timely remit 401(k) deferral contributions for certain pay periods within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. In 2023, the Company will correct the prohibited transaction by depositing the lost earnings, filing the required Form 5330 with the Internal Revenue Service, and paying the appropriate excise tax.

During 2021, the third-party administrator failed to timely process 401(k) deferral contributions for certain pay periods within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. During 2022, the Company and third-party administrator corrected the prohibited transaction by depositing the lost earnings, filing the required Form 5330 with the Internal Revenue Service, and paying the appropriate excise tax.
