Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Treatment Management 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of November 3, 2022 (liquidated) and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2022 through November 3, 2022 (liquidated), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information so held are prepared and certified to by the qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of November 3, 2022 (liquidated) and December 31, 2021 (in liquidation) and for the period January 1, 2022 through November 3, 2022 (liquidated), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, those charged with governance of the Treatment Management 401(k) Plan approved a formal plan termination on March 18, 2021. The Plan completed a liquidation of net assets available for benefits on November 3, 2022. As a result, the Plan's basis of accounting is the liquidation basis of accounting for all periods presented. Our opinion is not modified with respect to the matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the Treatment Management 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility

The Plan was established on January 1, 2017, as a defined contribution plan. The Plan was amended and restated since inception to comply with certain tax legislation. The Plan was available to eligible employees of Treatment Management Company, LLC and its affiliates (the Company, Employer or Plan Sponsor). Eligible employees were permitted to enter the Plan after completing the service requirement of one (1) month of credited service during the eligibility computation period and attaining age twenty-one (21), as defined.

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, served as the Plan's Trustee, and held the Plan's investment assets, and executed investment transactions through November 3, 2022 (liquidated date). The Company is the Plan administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Termination of Plan

On March 18, 2021, the Plan Sponsor and Plan Administrator approved a plan of termination initiating the transfer of the Plan's assets to each participant's selected plans or individual retirement accounts (IRA) and the Plan Sponsor discontinued its contributions to the Plan. No participants were allowed to enter the Plan after the date of termination. All participants were fully vested in their account balances, and the account balances were liquidated and distributed to the participants as soon as administratively practicable. As of November 3, 2022, all Plan assets available for benefits were liquidated and distributed to the participants.

Contributions

Prior to March 18, 2021, participants in the Plan could voluntarily contribute up to 90% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan's provisions also provide for Roth 401(k) elective deferrals.

Prior to March 18, 2021, the Plan Sponsor could make discretionary matching and profit-sharing contributions to the Plan. There were no Employer contributions made for the period January 1, 2022 through November 3, 2022.

Contributions were subject to certain IRS limitations.

Participant accounts

Each participant's account was credited with the participant's contributions and an allocation of: (a) the Employer's contributions (if any) and (b) Plan earnings or losses thereon, and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan.

Vesting

Upon termination of the Plan all participants became fully vested in their accounts.

Note 1 – Description of Plan, Continued

Forfeitures

Forfeited nonvested accounts may be used to offset certain Plan administrative expenses or reduce the Employer's matching contributions. There were no forfeited amounts utilized to offset certain Plan administrative expenses or reduce Employer contributions for the period January 1, 2022 through November 3, 2022 (liquidated). As of November 3, 2022 and December 31, 2021, there were no unallocated forfeitures available.

Participant notes receivable

Loans were not permitted under the Plan's provisions.

Payment of benefits

On termination of service for any reason, the participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum payment, subject to 20% withholding for income taxes, or as a direct rollover to an individual retirement account or another employer's tax qualified plan. On termination of service due to death, the participant's account was paid to the participant's beneficiary in a single lump-sum payment. In the event that the participant's vested accrued benefit was less than \$5,000, the Plan Administrator may make a single lump-sum payment or may roll over the total vested account balance to an IRA selected by the Plan Administrator without the election or request of the participant. Participants may elect to take an in-service distribution of vested funds upon becoming disabled under the terms of the Plan, reaching the age 59½ or if they incur a proven financial hardship, as defined.

In-service distributions were not permitted from Roth elective deferral amounts for hardship withdrawals.

Administrative expenses

The Plan allowed certain administrative expenses to be paid from Plan investment assets. Certain administrative expenses are paid by the Employer and are not reflected in these financial statements.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan are prepared on the liquidation basis of accounting. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (ASU) 2013-07, *Liquidation Basis of Accounting*, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences could be material.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the Plan's advisor and the Plan's Trustee.

Note 2 – Summary of Significant Accounting Policies, Continued

Investment valuation and income recognition, continued

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Payment of benefits

The Plan records benefits when paid.

Plan administration

The Employer is responsible for the administration of the Plan. Through November 3, 2022, the Plan's assets were held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, who served as the Plan's Trustee, and as such, administered the Plan's investments on behalf of the participants. Participant and Employer contributions (if any) were held by the Trustee who invested cash received, interest, and dividend income, and made distributions to participants (subject to the direction of the participants). Fees from covered service providers of the Plan are in compliance with Department of Labor's regulations regarding ERISA Section 408(b)(2).

Plan expenses

The Plan classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Plan Sponsor and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, trustee and custodian, and third-party administrator fees. Certain participant directed transactions are charged directly to participants' accounts.

Uncertain tax positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, Plan Administrator has determined it does not have any positions at November 3, 2022 that it would be unable to substantiate.

Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown on the statement of net assets available for benefits as of November 3, 2022 (liquidated) and December 31, 2021 (in liquidation);

- Net investment activity as shown in the statement of changes in net assets available for benefits for the period January 1, 2022 through November 3, 2022 (liquidated); and
- Investment information included in the Schedule H, Line 4i – Schedule of Assets (held at end of year) as of November 3, 2022 (liquidated), as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at November 3, 2022 (liquidated) and December 31, 2021 (in liquidation). During the period January 1, 2022 through November 3, 2022, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – valued at quoted market prices, which represent their daily net asset value (NAV) reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are traded on national exchanges (active markets).

Pooled separate accounts – Valued at NAV based upon the units of such pooled separate accounts held by the Plan at year-end multiplied by the respective unit value. The unit values of the pooled separate accounts are based upon significant observable inputs, which consists of securities that are actively traded on exchanges and quoted market prices are readily available.

Collective investment trust (CIT) – valued daily at NAV per unit held, by the r CIT trustee, is used as a practical expedient to estimate fair value. NAV is determined by the CIT based on the fair value of the underlying investments held by the CIT less liabilities. This practical expedient is not used when it is determined to be probable that the CIT will sell its underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Plan Termination

The Plan's Sponsor approved a termination of the Plan and discontinued its contributions on March 18, 2021 (as described in Note 1). On November 3, 2022 (liquidated), the Plan liquidated all assets available for benefits subject to the provisions of ERISA. Participants became fully vested in the Employer contribution portion of their accounts as of the termination date.

Note 7 – Tax Status

The Non-Standardized Pre-Approved Profit-Sharing Plan with CODA that the Plan adopted received a favorable opinion letter from the IRS on November 30, 2020, stating that the form of the Non-Standardized Pre- Approved Profit sharing Plan with CODA was designed in accordance with the provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel, believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

Note 7 – Tax Status, Continued

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 8 – Fidelity Bond

The Plan has complied with the fidelity bonding requirements of ERISA.

Note 9 – Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan's investments included shares of mutual funds, a pooled separate account and a collective trust fund, issued, managed and administered by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company who served as the Plan's Trustee and Custodian and, therefore, these transactions qualified as party-in-interest transactions.

Certain administrative functions are performed by officers and representatives of the Company. No officer or representative receives compensation from the Plan for these services.

Such transactions are exempt from the prohibited transactions rules.
