## Retirement

All employees are assumed to retire on their normal retirement date, or immediately if already beyond that date.

## Disability

No disability rates are assumed.

## Spouses

85% of active male participants and 70% of active female participants are assumed to be married with wives assumed to be 3 years younger than husbands.

## Benefit Accrual

For new employees, 0.75 year in each year of projected service; for prior employees still active, for each projected year of service while active, the same credit as the ratio of past credited service to past elapsed time.

## Expenses

Expenses paid from the trust were assumed to be \$68,000, which is equal to the last two years of expenses rounded to the nearest \$1,000.

## Asset Valuation Method

The averaged value is then further constrained to be no more than 110% of the market value of assets plus discounted receivable contributions and no less than 90% of the market value plus discounted receivables.

## **Summary of Plan Provisions as of October 1, 2022**

### **1. Type of Plan**

The plan is a non-contributory, defined benefit plan.

### **2. Effective Dates**

The Plan became effective January 1, 1980 and was restated in its entirety effective October 1, 1989 and most recently effective October 1, 2006. The Plan was most recently amended effective October 1, 2010 (benefit multiplier), December 31, 2014 (freeze participation) and December 31, 2019 (freeze benefit accruals).

### **3. Eligibility for Participation**

Any Company employee who is a member of a collective bargaining agreement with IBEW Local 375 (formerly Local 1319) will become eligible on the October 1 closest to his completion of one Year of Service and his attainment of age 21. Any employee hired after December 31, 2014 is not eligible to join the Plan.

### **4. Definitions:**

**(a) Plan Year:** A Plan Year is a 12-month period beginning on October 1 and ending on September 30.

**(b) Company:** Service Electric Cable TV, Inc.

**(c) Plan Administration:** A Committee, consisting of not less than three persons appointed by the Board of Directors of the Company, supervises and administers the plan.

**(d) Year of Service:** Credit is given for any plan year in which an employee is employed by any of the group of companies under common control and works 1,000 hours or more. A break-in-service occurs if in any plan year an employee works less than 501 hours.

**(e) Year of Benefit Service:** Only service with the Company while a member of the bargaining group shall be recognized as Benefit Service. Solely for purposes of determining benefit amounts, .5 of a Year of Service shall be credited with respect to each plan year during which exactly 1,000 hours of service are credited, .75 for each year where more than 1,000 but less than 1,500 hours of service are credited and 1.0 for each year where at least 1,500 hours are credited. No service is credited after December 31, 2019.

**(f) Accrued Pension:** A participant's accrued benefit is calculated under the normal retirement formula, based on the participant's years of Benefit Service and dollar amount in effect at the date of termination. All benefits are frozen as of December 31, 2019.

**5. Retirement Benefits**

- (b) **Early Retirement:** Early retirement may take place at any time after age 55 and completion of 5 Years of Service. The accrued pension will be payable at normal retirement date. The benefit shall be reduced actuarially for each month by which the payment date precedes his normal retirement date, if early commencement is elected.
- (c) **Postponed Retirement:** A participant may continue in service beyond his normal retirement date. Upon actual retirement he will receive a late retirement benefit based on service to his actual retirement date.

**5. Retirement Benefits (cont'd)**

- (d) **Retirement Window:** From October 1, 1992 and for only a few months thereafter, participants aged 55 or over with at least 5 Years of Service could elect to retire with an enhanced benefit:
- The \$30.00 benefit unit applied immediately.
  - Benefit Service was rounded up to the higher year.
  - Immediate payment could be elected (subject to actuarial reduction).

**6. Termination Benefit:**

Any participant may terminate his employment after 5 Years of Service and be entitled to a deferred benefit payable at his NRD. Such pension will be equal to his Accrued Benefit at the date of termination of employment.

**7. Death Benefits**

(a) **Pre-retirement Spouse's Benefit**

**Eligibility:** A participant who dies in active service after completing 5 Years of Service or who dies after terminating with a vested benefit and who leaves a spouse will be considered to have retired on his date of death.

**Spouse's Benefit:** The surviving spouse will receive a lifetime pension equal to 50% of the accrued pension payable from the earliest permitted retirement date, reduced for early commencement.

- (b) **Post-retirement Spouse's Benefit:** None, except as provided by the election of an optional form of payment.

- (c) **Death Benefit for Single Employee:** Effective October 1, 2012, an unmarried participant who was an active employee at or after age 55, who has a vested benefit, and is credited with at least one Hour of Service after October 1, 2012, will be eligible for a death benefit. The benefit is equal to 50% of the lump sum benefit the participant would have received but payable to the estate.

**8. Disability Benefits**

Permitted upon total and permanent disability after completion of 10 Years of Service. A pension equal to the participant's full Accrued Benefit at time of disablement is payable immediately without reduction for early commencement of benefits.

**9. Transfers of Employment**

Transfers of employment within the Company or to an affiliate not covered by this plan shall not break continuous service for vesting; however, credit for determining benefit amounts shall only be given for service in this plan.

## **10. Form of Benefit Payment**

- (a)** If the value is \$1,000 or less, payment as a single lump sum is automatically paid.
- (b)** If a participant is married at the time of retirement, the pension will be paid in the form of an actuarially reduced joint and survivor monthly annuity with 50% of the participant's reduced payment continuing to his spouse for life, if surviving at the participant's death.
- (c)** If a participant is unmarried at the time of retirement, the pension will be paid in the form of a single life annuity, with payments to be made in equal monthly installments until the participant's death.
- (d)** Monthly payments are made at end of month.

## **11. Optional Payment Forms**

At any time prior to the commencement of benefit payments, subject to spousal consent if relevant, and provided that an automatic lump sum is not paid, a participant may elect to receive his pension in some other permitted form which is the actuarial equivalent of the payment form prescribed.

Permitted forms are:

- (a)** A single-life annuity
- (b)** A joint and 50% or 75% survivor annuity
- (c)** A single-life annuity with 10-year guarantee
- (d)** A lump sum payment (not available for disability retirements)

In the case of a married participant, spousal consent is needed for election of payment in other than the normal form.

## **Major Changes in Plan Provisions Since Prior Valuation**

The plan terminated in 2022.

## **Shortfall Amortization Charges for 2022/2023**

Schedule C shows development of the Shortfall Amortization Charge (SAC), which is the sum of the annual payments of the amortized Shortfall Amortization Bases (SAB). Under ARPA, all existing bases are set to zero, and the new (unfunded) base is amortized over 15 years.

To determine the Plan Funding Percentage for the Shortfall Amortization Base Exemption, plan assets are reduced by the Prefunding Balance, as shown below.
