Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ethanol Products, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 27, 2022 and December 31, 2021, the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 27, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 27, 2022 and December 31, 2021, and for the period from January 1, 2022 to December 27, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Merger

The Plan was merged into the POET Biorefining 401(k) Plan effective December 27, 2022. As discussed in Note 7 to the financial statements, an amendment to the Plan document was adopted by the Plan and the POET Biorefining 401(k) Plan on December 6, 2022, to merge the Plan into the POET Biorefining 401(k) Plan effective December 27, 2022. All assets of the Plan were physically transferred on December 27, 2022 and December 29, 2022; however, the POET Biorefining 401(k) Plan assumed legal control and responsibility of the transferred plan assets as of December 27, 2022, the effective date of the merger. Accordingly, these financial statements reflect all activity from January 1, 2022, through December 27, 2022, for the Plan and the transfer out of its assets on December 27, 2022. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following is a brief description of Ethanol Products, LLC 401(k) Plan (the Plan) and is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan sponsored by Ethanol Products, LLC, d/b/a POET Ethanol Products (the Company). The purpose of the Plan was to provide retirement benefits for employees of the Company and their beneficiaries. The Plan was merged into the POET Biorefining 401(k) Plan effective December 27, 2022.

The Plan was available to substantially all employees who were employed by the Company and had completed one hour of service within one month of employment and had attained the age of 18. Employees were able to enter the Plan on the first day of the month coinciding with or following the date the eligibility requirements were satisfied. Employees were automatically enrolled in the Plan at a 6% deferral rate once the eligibility requirements were met, unless the employee elected a different deferral percentage or opted out of the Plan. Employees contributing to the Plan were eligible for employer matching contributions upon the same day they began contributing to the Plan and Company profit sharing contributions upon completion of one year of employment. Participants had to be employed on the last day of the Plan year to receive the profit sharing contribution.

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors was responsible for oversight of the Plan. The Plan's 401(k) Investment Advisory Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Board of Directors.

Contributions: Participants were permitted to contribute up to 100% of their pretax or after-tax annual compensation, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code (IRC). Participants were also permitted to make rollover contributions from other qualified plans. Additional employer matching and profit sharing amounts could be contributed at the option of the Board of Directors. Certain participants received a discretionary employer matching contribution equal to 100% of the first 6% of employee compensation and certain participants received a discretionary employer matching contribution equal to 50% of the first 6% of employee compensation contributed for the period ended December 27, 2022. There were no profit sharing contributions for the period ended December 27, 2022.

Participant accounts: Each participant's account was credited with the participant's contributions and discretionary employer matching and profit sharing contributions, if any, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses paid by the Plan (if not paid with forfeitures). Allocations were based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment options: Upon enrollment in the Plan, a participant could direct contributions in a variety of investment options. All funds varied in types of investments, rates of return, and investment risk and were described in more detail in the Plan's literature. Participants could elect on a daily basis to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

Note 1. Description of the Plan (Continued)

Vesting: Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon was based on a graded scale over six years of continuous service at any recognized POET-managed facility. A participant was 100% vested after six years of credited service. A participant became 100% vested upon death or permanent disability.

Notes receivable from participants: Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding note balance during the prior 12-month period or 50% of their account balance. Notes receivable from participants were measured at their unpaid principal balance plus any accrued, but unpaid interest. The notes were secured by the balance in the participant's account and bore interest at prevailing interest rates charged by persons in the business of lending money for notes which would be made under similar circumstances. Principal and interest were paid through payroll deductions. There were no notes receivable outstanding as of December 27, 2022, as balances were transferred to POET Biorefining 401(k) Plan (see Note 7). No allowance for credit losses was recorded as of December 27, 2022 or December 31, 2021.

Notes receivable from participants were classified as an investment for Form 5500 reporting purposes and, accordingly, were included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Benefit payments: Upon death, permanent disability, retirement or other termination of employment, participants, or their beneficiaries, were entitled to receive the vested balance of their account. Vested benefits were distributed in the form of a lump-sum amount, installment payments, annuity contract or any combination of these options. The Plan included an early retirement option for participants age 55 or older with at least five years of service. The Plan allowed in-service distributions after the age of 59½. The Plan also allowed hardship distributions subject to certain restrictions. Distribution of benefits upon termination was automatic if the participant's account balance was less than \$5,000. Participants with an account balance less than \$5,000 would have their account balance rolled over into an individual retirement account (IRA) unless they elected to receive a lump-sum payment.

Forfeitures: Forfeited nonvested accounts were used to restore previously forfeited balances, pay Plan administrative expenses or fund employer contributions. Approximately \$34,000 and \$94,000 of forfeitures were used during 2022 to pay Plan administrative expenses and fund employer matching contributions, respectively. The available amount of forfeited nonvested accounts to be used to fund employer contributions or pay Plan administrative expenses was approximately \$62,000 as of December 31, 2021.

Plan termination: Although it had not expressed any intent to do so, the Company had the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination, all participant accounts would have become fully vested. See Note 7 regarding a merger of the Plan as of December 27, 2022. This was not considered a Plan termination.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Investment Advisory Committee determined the Plan's valuation policies, utilizing information provided by the Plan's investment advisors and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits: Benefits were recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Investment-related expenses were included in net depreciation.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 2, 2023, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Minnesota Life Insurance Company

The following is a summary of the Plan's asset information as of December 31, 2021, and for the period from January 1, 2022 to December 27, 2022, included throughout the Plan's financial statements, obtained by management and agreed to or derived from information certified by Minnesota Life Insurance Company, the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements related to the following assets as of December 31, 2021:

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Pooled separate accounts were primarily valued at net asset value (NAV) per share used as a practical expedient, based on quoted market prices for the underlying securities or similar instruments.

In accordance with Accounting Standards Codification Subtopic 820-10, the pooled separate accounts held by the Plan were not classified in the fair value hierarchy table that prioritizes the inputs to valuation techniques used to measure fair value because they were measured at NAV per share as a practical expedient.

The method described above may have produced fair values that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believed its valuation methodology was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments held during the period from January 1, 2022 to December 27, 2022, and as of December 31, 2021, were pooled separate accounts managed by Minnesota Life Insurance Company, the custodian, as defined by the Plan; therefore, these transactions qualified as party-in-interest transactions.

Note 6. Tax Status

The Plan adopted a Cycle 3 defined contribution pre-approved plan sponsored by Minnesota Life Insurance Company. The pre-approved plan provider has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the form of the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the pre-approved plan was adopted subsequent to the date of the IRS opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Transfer Out to POET Biorefining 401(k) Plan

An amendment to the Plan document was adopted on December 6, 2022, to merge the Plan into the POET Biorefining 401(k) Plan effective December 27, 2022. All assets of the Plan were physically transferred on December 27, 2022 and December 29, 2022; however, POET Biorefining 401(k) Plan assumed legal control and responsibility of the transferred plan assets as of December 27, 2022, the effective date of merger. Accordingly, the Plan recognized a transfer out to the POET Biorefining 401(k) Plan of \$47,511,076 in its statement of changes in net assets available for benefits for the period from January 1, 2022 to December 27, 2022.
