## Independent Auditors' Report

To the Plan Administrator of  
Houston Symphony Society Musicians and  
Staff Employees' Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Houston Symphony Society Musicians and Staff Employees' Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 1, 2023 (in liquidation) and May 31, 2022 (ongoing), and the related statements of changes in net assets available for benefits for the period from June 1, 2022 through March 1, 2023 (in liquidation) and the year ended May 31, 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 1, 2023 and May 31, 2022 and for the period from June 1, 2022 through March 1, 2023 and the year ended May 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be

independent of Houston Symphony Society Musicians and Staff Employees' Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Basis of Accounting**

As discussed in Note 2 to the financial statements, the Board of Governing Directors of the Houston Symphony Society approved a plan of liquidation as of the end of the day on May 31, 2022, and management determined liquidation is imminent. As a result, the plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Houston Symphony Society Musicians and Staff Employees' Retirement Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

Notes to Financial Statements for the period from June 1, 2022 through March 1, 2023 (in Liquidation) and the year ended May 31, 2022 (Ongoing)

---

### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Houston Symphony Society Musicians and Staff Employees' Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan was a defined benefit pension plan covering employees of Houston Symphony Society (the Society) other than leased employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 31, 2017, the Houston Symphony Society Staff Employees' Retirement Plan (the Staff Plan) was merged into the Houston Symphony Society Musicians Retirement Plan (Musicians Plan) and the Musicians Plan's name was changed to Houston Symphony Society Musicians and Staff Employees' Retirement Plan.

Effective October 31, 1997, the Musicians Plan was frozen. As a result, benefit accruals were frozen for all participants as of October 31, 1997, and no additional employees were eligible to participate in the Musicians Plan after October 31, 1997. In connection with the merger, all participants under the Staff Plan immediately before the effective date of the merger became an eligible participant in the Plan on May 31, 2017; benefit accruals were frozen for all participants of the Staff Plan as of May 31, 2017, and no additional employees were eligible to participate in the Staff Plan after May 31, 2017.

Pension benefits – Participants were entitled to monthly pension benefits beginning at the earlier of normal retirement age (65) with five years of service or age 60 with 30 years of service. Benefit payments were determined based upon the number of years of credited service and were subject to certain minimum and maximum amounts as set forth in the Plan. Participants received the value of their accumulated plan benefits as a life annuity with payments guaranteed for ten years or, if married, as a qualified joint and survivor pension. A participant was eligible for a special normal retirement benefit if the total of his or her age and years of vesting service equaled 85 or greater. The Plan permitted early retirement at the age of 50 with reduced benefits provided a participant had completed ten or more years of vesting service and the participant was not receiving disability pension benefits.

Effective December 1, 2021, the Plan was amended to allow for lump sum distributions after severance from employment, regardless of when the severance of employment occurred.

In September 2021, the Society approved the termination of the Plan effective May 31, 2022. In April 2022, the Plan purchased annuity contracts from Mutual of Omaha for approximately \$13.8 million for all participants and beneficiaries who were currently receiving monthly benefits at May 1, 2022. The Plan entered into a deconversion holding agreement with Principal Life Insurance Company (PLIC) on January 17, 2023 to facilitate liquidation of the Plan.

Death and disability benefits – Participants could elect to receive a joint and survivor annuity, which provided for a reduced benefit for the life of the participant and a percentage of such reduced benefit for the life of the surviving spouse. A participant was eligible for a disability pension benefit if his or her employment was terminated by reason of disability before the normal retirement date.

Funding policy – The Society contributed the actuarially-determined amount necessary to meet the minimum funding requirements of ERISA and to fund prior service costs. Contributions were accrued annually when determined by the Plan’s actuary. The Society met the minimum funding requirements for the year ended May 31, 2022. The Society contributed an additional \$1,828,688 to fund the termination of the Plan during the period from June 1, 2022 through March 1, 2023.

## **NOTE 2 – PLAN TERMINATION**

Effective as of the end of the day on May 31, 2022, the plan sponsor executed an amendment to terminate the Plan. Notice of intent to terminate the Plan was filed in November 2022 with the Pension Benefit Guaranty Corporation (PBGC). All accumulated benefit obligations have been paid as of March 1, 2023. The Post-Distribution Certification for Standard Termination was filed with the PBGC on March 17, 2023.

## **NOTE 3 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting – The Plan’s 2023 financial statements have been prepared on the liquidation basis of accounting and the 2022 financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. There are no significant differences between the two bases for the Plan.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by its investment advisors and insurance company. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Benefits paid directly to participants – Benefits paid directly to participants are recorded upon distribution.

Administrative expenses – Contract administrative fees, investment management fees, and PBGC premiums are paid from the assets of the Plan and are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Other administrative expenses are paid by the Society and are excluded from these financial statements. In addition, certain investment-related expenses are included in net depreciation in fair value of pooled separate accounts presented in the accompanying statements of changes in net assets available for benefits.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, the reported amounts of additions and deductions, and the actuarial present value of accumulated plan benefits. Actual results could vary from the estimates that were used.

#### **NOTE 4 – INFORMATION CERTIFIED BY INSURANCE COMPANY**

Certain information relating to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at March 1, 2023 and May 31, 2022 and net depreciation in fair value of pooled separate accounts for the period from June 1, 2022 through March 1, 2023 and the year ended May 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by PLIC, as an insurance company of the Plan.

#### **NOTE 5 – INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Generally accepted accounting principles establish a hierarchy that prioritizes inputs used to measure fair value. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

The Plan has pooled separate accounts totaling \$6,409,682 at May 31, 2022 valued at the net asset value (NAV) of the shares. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities.

There have been no changes in the valuation method used at May 31, 2022. This valuation method may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

Investments are exposed to various risks such as interest rate, market and credit risks. Because of these risks, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.

#### **NOTE 6 – TAX STATUS**

The underlying volume submitted prototype plan received an opinion letter from the Internal Revenue Service (IRS) dated March 30, 2018, stating that the form of the Plan was qualified under Section 401 of the Internal Revenue Code (the Code). In accordance with IRS Revenue Procedures, the plan administrator had determined that it is eligible to and had chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan was being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified.
