Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1 Description of Plan

The following description of The Mifsud Group LLC 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General:

The Plan includes the following related entities collectively known as the “Company”: The Mifsud Group, LLC, TMG Performance Products (“TMG”) (prior to June 10, 2022), LLC and Montana Metal Products, LLC (“MMP”) (prior to September 6, 2021).

The Plan, which began January 8, 2009 and was restated on January 5, 2016, is a defined contribution plan covering all employees who meet the employee classification, hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective September 6, 2021, the Plan was amended to remove MMP as a participating employer which resulted in a partial termination of the Plan. Affected participants became 100% vested in their account balances as of that date.

Effective April 18, 2022, the Plan was restated to incorporate all previous amendments and to maintain compliance with required regulatory changes.

Effective July 22, 2022, the Plan was amended to remove TMG Performance Products, LLC, as a participating employer which resulted in a partial termination of the Plan, effective June 10, 2022. Affected participants became 100% vested in their account balances as of that date.

Effective October 1, 2022, the Company terminated the Plan and all non-vested participants became 100% vested. All assets were distributed from the Plan as of December 6, 2022.

Eligibility:

All employees are eligible, except for employees covered by a collective bargaining agreement, leased employees, telemarketers, and temporary or part time employees. An employee must be age eighteen or older and employed for one month.

Contributions:

Employee Contributions – Until termination of the Plan, participants could elect up to 100% of their compensation to be contributed to the Plan by the Company. Newly eligible participants were automatically enrolled in the Plan with a deferral percentage of 3%, unless they affirmatively elected otherwise. Catchup and Roth 401(k) contributions were allowed for all participants meeting the requirements. Participants could convert any part of their pre-tax employee deferral and vested employer match balance that was not part of an outstanding loan balance, to designated Roth Contributions.

1 Description of Plan, Continued

Contributions, Continued:

Employer Matching Contributions – Until termination of the Plan, the Company could make contributions to each eligible participant's account by matching a percentage of the participants' elective deferral for the Plan year. The Company contributed 50% of the participants' elective deferral, not to exceed 1.5% of the participants' compensation.

Employer Discretionary Contributions – Until termination of the Plan, the Company could also make additional profit-sharing contributions. Such additional contributions, if any, were to be allocated to each participant in proportion to his or her compensation for the calendar year. The Company made no additional profit-sharing contributions to the Plan during 2022 and 2021.

Until termination of the Plan, rollover contributions from other Plans were accepted, providing certain specified conditions are met.

Contributions were subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan. Other than TMG and MMP participants as mentioned in the General section above, plan participants are vested in employer matching contributions and employer discretionary contributions based on years of service. Until termination of the Plan, a participant was vested in company matching contributions and company discretionary contributions as follows:

Forfeitures:

Forfeited non-vested accounts totaled \$0 and \$19,352 as of December 6, 2022 and December 31, 2021, respectively. During the period from January 1, 2022 through December 6, 2022 and the year ended December 31, 2021, the Company used forfeitures to reduce employer matching contributions and to offset administrative expenses.

Other Plan Provisions:

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. Benefits are recorded when paid.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

As of December 6, 2022 and for the period from January 1, 2022 through December 6, 2022, the Plan's transactions were reported on the liquidation basis of accounting. As of and for the year ended December 31, 2021, the Plan's transactions were reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Investments held in Common Collective Trusts are valued based on their underlying investments using a variety of methodologies including pricing services, dealer quotes, and net asset per share calculated on a specific valuation date. Participants may transact with the Common Collective Trusts daily and there are no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

2 Summary of Significant Accounting Policies, Continued

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets

and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Certain administrative fees are paid by the Plan.

Risks and Uncertainties:

The Plan's investments include investments in Mutual Funds and Common Collective Trusts holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 21, 2023, which is the date the financial statements were available to be issued.

3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 6, 2022, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

3 Tax Status, Continued

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Mutual Funds:

The fair values of the Mutual Funds are based on quoted market prices.

Common Collective Trusts:

The fair values of the Common Collective Trusts are based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on quoted market prices or commercial quotation services. The Common Collective Trusts are classified in the Level 2 category of the valuation hierarchy.

4 Fair Value Measurements, Continued

Participant transactions (purchases and sales) may occur daily. Withdrawals by participants for purposes of benefit payments or transfer to a noncompeting option are processed as soon as practicable upon receipt of written notification. Transactions other than those initiated by a participant for specific purposes of a sale, purchase, transfer or benefit payment require advanced written notice in accordance with the contract.

There were no assets at fair value as of December 6, 2022.
