INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
the Continuity Global Solutions, LLC 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Continuity Global Solutions, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Other Matter

Note 1 – Description of Plan

The following description of the Continuity Global Solutions, LLC 401 (k) Profit Sharing Plan (the 'Plan') provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan and was established on January 1, 2006 covering all eligible employees of the Company who have six months of service and are age 18 or older. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). Generally, the Plan covers all employees of the Company except for employees who are:

- Union employees
- Non-resident aliens

The Company and the Plan trustees are responsible for administering the Plan.

b. Participant contributions

Each year, participants may contribute any combination of pre-tax elective deferrals and Roth elective deferrals up to 100% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contribution of \$6,500. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover).

c. Employer's contributions

Each plan year, the Company may at its sole discretion, make matching contributions to all eligible participants at a certain percentage of the participant's elective deferrals at the end of the Plan year. Moreover, the Company may contribute, as determined by the Board of Directors, to the Plan based on the total compensation of all the participants eligible to receive an allocation. The Company may at its discretion, make qualified non-elective contributions to participants who are not highly compensated employees. The qualified non-elective contributions will be allocated to the participants according to the ratio of the participant's pre-tax contributions and the participant's compensation for the plan year bears to the total compensation of all participants for such plan year. For the period ended November 28, 2022, no employer's qualified non-elective contributions were made.

d. Participant accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of investment earnings. The participant is entitled to the benefit from the vested account balance.

e. Vesting

Participants are immediately vested in their accounts with respect to participant contributions, eligible rollovers and earnings thereon. Participants vest in the Company's contributions and earnings thereon based upon the following schedule:

<u>Years of Employment</u>	<u>Vested Percentages</u>
Less than 1	0%
1 but less than 2	10%
2 but less than 3	40%
3 but less than 4	70%
4 but less than 5	100%

Participants will be fully vested with the Company's discretionary contributions in the event of death, total disability, termination of the Plan or attainment of normal retirement age while an employee of the Company.

Forfeitures, if any, are applied to reduce administrative expenses of the Plan. For the period ended November 28, 2022, no forfeitures were used.

f. Investment options

Participants can direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options and allocations on a quarterly basis.

g. Rollovers

With the approval of the plan administrator, the Plan may receive any amounts received by an employee as distribution from another qualified plan provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

h. Notes receivable from participants

Participants may borrow from their accounts. Each participant may have no more than one loan outstanding at any one time. Loan fees and interest due are paid by the participants. Minimum loan amount is \$500; the maximum loan amount cannot exceed the lesser of:

- one-half of the present value of the vested accrued benefit of the participants; or
- \$50,000 (reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is executed, over the outstanding balance of loans from the Plan on the date the loan is executed).

The maximum repayment period is generally not more than 5 years for a general purpose loan. If the loan is obtained for the purpose of purchasing a primary residence, the loan will be repaid within a period not to exceed 15 years. The loan will bear interest at the prime rate plus 1%. Principal and interest is paid ratably through each pay period. All loans must be secured by not more than 50% of the participant's vested account balance.

i. Payment of benefits

Upon separation from employment due to termination of employment, death, disability, retirement or attainment of the age of 65, the participant may receive their entire vested portion in a lump sum or in installments as elected by the participant. The frequency of the installment payments can be on a monthly, quarterly, semi-annual or annual basis but not exceeding the joint life expectancies of the participant and/or beneficiary. A participant generally has two options concerning the account balance when a distribution is made:

- The participant may elect to roll-over the vested account balance to another qualified retirement plan or to an individual retirement account; or
- The participant may elect to have the vested account balance paid directly to himself/herself and income taxes will be withheld accordingly.

If the value of the vested account is less than \$5,000 when the participant terminates his/her employment with the Company, the participant will receive a distribution of the entire vested portion of the account balance and the non-vested portion will be forfeited.

The Plan allows for hardship or in-service withdrawals but is subject to the approval of the Plan administrator.

Note 2 – Summary of Significant Accounting Policies

a. Basis of presentation

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with U.S. generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

b. Use of estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

d. Risks and uncertainties

The Plan invests in various funds that hold investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

e. Participant distributions

Benefits paid to participants are recorded when paid.

f. Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

g. Date of management's review

The Plan has evaluated subsequent events through September 19, 2023, the date at which the financial statements were available to be issued.

Note 3 – Income Tax Status

The Plan was adopted as a prototype plan, which received a determination letter from the Internal Revenue Service stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan was amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United State of America require plan management to evaluate uncertain tax positions taken by the plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 28, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statement. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 28, 2022 and December 31, 2021:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
