Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Lydall 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Lydall 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Emphasis of Matter

As discussed in Note 1 and Note 6 to the accompanying financial statements, the Plan was merged and all assets of the Plan were transferred to the Alkegen 401(k) Plan. Our opinion is not modified with respect to this matter.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Lydall 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for employees of the domestic operations of Lydall, Inc., and its subsidiaries (the Company). On June 21, 2021, the Plan Sponsor, Lydall, Inc., (Lydall) entered into a Merger Agreement with Unifrax Holding Co., (Unifrax), a global provider of specialty materials focused on thermal management, specialty filtration, battery materials, emission control, and fire protection applications. Pursuant to the Agreement, Lydall was acquired by Unifrax at a price of \$62.10 per outstanding share of common stock of Lydall in an all-cash transaction. The Merger was approved by both Lydall's Board of Directors and the Board of Directors of Unifrax and was completed on October 1, 2021.

The current Plan consists of a 401(k) deferred arrangement with matching employer contributions and is a qualified profit-sharing plan under Section 401(a) of the Internal Revenue Code (the Code). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by a committee of the Plan Sponsor. The Committee's responsibilities include managing the Lydall 401(k) Plan Investment Policy and selecting investment managers and investment funds. The Committee is a named fiduciary under the Plan with respect to management of the Plan's investments.

As further discussed in Note 6, effective December 31, 2022, the Plan was merged and the assets of the Plan were transferred to the Alkegen 401(k) Plan (formerly known as Unifrax I LLC Savings Plan).

Plan Restatement

Effective January 1, 2022, the Plan was amended and restated in accordance with the IRS Cycle 3 restatement. All plan provisions remained substantially the same.

Eligibility

All full-time employees, except nonresident aliens, of the domestic operations of the Company are eligible to participate in the Plan after completing one month of employment. Effective January 1, 2016, the Plan was amended and restated to allow part-time nonunion employees of the Company who are regularly scheduled to work at least 20 hours per week to participate in the Plan after completing one month of employment.

Plan Contributions

Prior to the merger, plan contributions include the following:

- a. Pre-Tax Employee Contributions - An employee who meets the eligibility requirements for participation may authorize the Company to reduce his/her compensation and to make a corresponding pre-tax contribution on his/her behalf from 1% to 35% of his/her compensation, up to \$20,500 in 2022. The Plan also has an automatic increase of pre-tax contributions for all participants except Green Island NY union employees, equal to 1% of eligible compensation, up to a maximum pre-tax contribution of 8% of compensation.
- b. Automatic Enrollment - Employees are automatically enrolled 60 days after the auto-enrollment notice date. The default pre-tax contribution is 5% of compensation, except for Green Island NY Union participants, for whom the default pre-tax contribution is 4%. The default investment is the T. Rowe Price Retirement Date fund series with a target retirement date closest to the employee's 65th birthday, unless the employee elects otherwise.
- c. Roth Contributions - Effective January 1, 2016, the Plan was amended to allow for designated Roth contributions.
- d. Matching Employer Contributions for Nonunion Participants - Matching contributions are made on the first 5% of compensation the employee contributes to the Plan, with the first 3% matched at 100% and the next 2% matched at 50%.
- e. Matching Employer Contributions for Union Participants - Matching contributions for Green Island NY Union employees are equal to 100% of the first 4% of compensation the employee contributes to the Plan.

Fulton NY Union employees hired before July 1, 2005 receive a matching contribution equal to 100% of the first 3% of compensation the employee contributes to the Plan. Fulton NY Union employees hired after July 1, 2005 receive a matching contribution equal to 100% of the first 3% and 50% of the next 2% of compensation the employee contributes to the Plan.

Hoosick Falls Union employees receive a matching contribution equal to 100% of the first 3% and 50% of the next 2% of compensation the employee contributes to the Plan.

Marshalltown IA Union employees receive a matching contribution equal to 100% of the first 3% and 50% of the next 2% of compensation the employee contributes to the Plan.

Beaver Falls NY Union employees receive a matching contribution equal to 100% of the first 3% and 50% of the next 2% of compensation the employee contributes to the Plan.

Plan Contributions (Continued)

- f. After-Tax Employee Contributions - Effective June 30, 1988, participants were no longer permitted to make after-tax contributions to the Plan. A participant maintains his/her interest in the Plan attributable to his/her after-tax contributions made prior to July 1, 1988.
- g. Age 50 Catch-Up Contributions - Participants who reach age 50 or older during the plan year are eligible to make additional pre-tax or Roth contributions into their 401(k) account. Eligible participants may contribute up to an additional \$6,500 catch-up contribution in 2022. Age 50 catch-up contributions are not eligible for the Company match.

Participant Accounts

Participants have separate accounts for employee and employer contributions for each investment option selected. Participants may elect to have contributions invested in any or all of the investment options. Investment income (loss) is allocated to the participants' accounts regularly. Allocations of investment income (loss) are based on a participant's account balance. The benefit to which a participant is entitled is the participant's vested account balance.

Vesting

Participants are immediately vested in all contributions, including the earnings on these amounts.

Investment Options

Participants may direct their contributions to any of the investment options offered by the Plan. All participant investments are held at Empower Trust Company, LLC (formerly Great-West Trust Company, LLC) and Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company), (collectively referred to as Empower). These funds include a variety of investment options with various objectives and degrees of financial risk.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or one-half of their account balance, reduced by their highest outstanding loan balance, if any, during the prior 12 months. Participants may only have one loan outstanding at any given time. Loan terms range from 1 to 5 years, except for loans to purchase a primary residence, which have a repayment term of up to 15 years. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate in effect on the first business day of the calendar month in which the participant applies for the loan. The notes currently bear interest at rates ranging from 3.25% to 7.00%. Generally, principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, permanent total disability, death or termination of employment, the participant shall become entitled to his/her total vested account balance. The Plan also provides for in-service and hardship withdrawals by qualified participants. Total distributions are paid in a lump sum, partial withdrawals or, if over age 55 and separated from employment, installment payments. If a participant terminates employment for any reason and his or her vested account balance is between \$1,000 and \$5,000, the Plan administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

Lump-sum distributions are not paid without the consent of the participant or, in the event of the participant's death, without the consent of the beneficiary.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan uses the accrual basis of accounting for plan transactions.

Investment contracts held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the plan document.

Payment of Benefits

Benefits to participants are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in mutual funds and an investment contract. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

In preparing these financial statements, management has evaluated subsequent events through September 26, 2023, which represents the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION BY THE QUALIFIED INSTITUTION

Information presented in the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021 and statement of changes in net assets available for benefits for the year ended December 31, 2022 for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Empower Trust Company, LLC (formerly, Great-West Trust Company, LLC) and Empower Annuity Insurance Company of America (formerly, Great-West Life & Annuity Insurance Company), (collectively, Empower, the qualified institution, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Mutual funds are valued at the quoted price of shares held by the Plan at year- end.

There have been no changes in the methodologies used at December 31, 2022 and 2021.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the transfer of assets in 2022, the Plan held no assets at fair value as of December 31, 2022. The following table sets forth, by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2021:

NOTE 5 INVESTMENT CONTRACT

The Plan has entered into a benefit-responsive investment contract with Empower. Empower maintains the contributions in a separate investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract is a traditional investment contract. In connection with the Plan merger on December 31, 2022 as further discussed in Note 6, the contract was assumed by the Alkegen 401(k) Plan as of this date and therefore, the Plan's balance in the contract is \$-0- as of December 31, 2022. The contract value of the investment contract was \$8,746,727 at December 31, 2021.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 PLAN MERGER AND TRANSFER

In October 2022, the Company authorized a resolution to merge and transfer the assets of the Plan with the Alkegen 401(k) Plan (formerly known as Unifrax I LLC Savings Plan), to be effective January 1, 2023. In connection with the merger, the Plan's investments were liquidated on December 30, 2022 and the transfer was recognized in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022. The final payroll contribution for the year ended December 31, 2022 was deposited directly into the Alkegen 401(k) Plan's trust at Fidelity Management Trust Company, the trustee of the Alkegen 401(k) Plan, in January 2023 and as such have been included as part of the transfer recorded during 2022. See below for a summary of assets transferred out of the Plan on this date:

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and a guaranteed investment contract managed by Empower. Empower is the trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Investment and administrative expenses paid by the Plan to Empower totaled \$168,220 for the year ended December 31, 2022. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

NOTE 8 INCOME TAX STATUS

The Plan obtained its latest determination letter on June 5, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
