**NOTE 1 DESCRIPTION OF PLAN**

The following description of Colle & McVoy 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally established by Colle & McVoy LLC (the Company) on January 1, 1988, to provide retirement income to its employees. The Plan has been restated and amended throughout the years. The Plan was last amended and restated effective April 1, 2022. All employees, except for those covered by a collective bargaining agreement, are eligible to participate in the Plan and may enter the Plan on the first day of each month. The Plan is subject to ERISA. The Plan administrator is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors performance, and reports to the Company's Board of Directors.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. Eligible participants may also contribute after-tax Roth contributions. Participants age 50 or older are permitted to make catch-up contributions to the Plan. Participants are auto-enrolled at a 3% deferral rate, unless elected otherwise.

Company matching or discretionary nonelective contributions may be made at the discretion of the Company's Board of Directors. The Company did authorize a 3% matching contribution for the years ended December 31, 2022 and 2021. The Company also authorized a 2% discretionary nonelective contributions for the year ended December 31, and 2021. There was no discretionary nonelective contribution declared for the year ended December 31, 2022. The Plan requires participants to be employed on the last day of the Plan year to be eligible for the Company discretionary nonelective contribution.

Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of contributions into the various investment options offered in the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's discretionary contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are fully vested in their contributions and actual earnings thereon. Participants are fully vested in the Company matching and discretionary nonelective contribution accounts following the completion of six years of service (based on a graded vesting schedule), attainment of normal retirement age (59½), death, or disability.

**Payment of Benefits**

Termination or retirement benefits are paid in accordance with the provisions of the Plan. A participant will receive a lump sum amount or installment equal to the value of his or her account. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. Distributions from a participant's 401(k) or rollover accounts are also allowed in the event of a financial hardship, death, or disability. The Plan also allows for in-service distributions at age 55.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the third-party administrator. Principal and interest is paid ratably through payroll deductions. All notes receivable from participants were transferred to an affiliated plan (see Note 9).

**Forfeitures**

If a participant terminates employment and is less than 100% vested, the nonvested Company contribution portion of the account is forfeited. Forfeitures are retained in the Plan and used to reduce future Company contributions or pay Plan expenses. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$258,154 and \$436,302, respectively. Forfeitures of \$-0- and \$304,955 were used to reduce Company contributions for the years ended December 31, 2022 and 2021, respectively. There were no forfeitures used to pay Plan expenses for the years ended December 31, 2022 and 2021. The balance in the nonvested forfeiture account at December 31, 2022 was transferred to an affiliated plan (see Note 9).

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Valuation of Investments and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the agent for the trustee of the Plan. See Note 4 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of benefits paid, notes receivable from participants and other administration are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses, including any revenue sharing credits, are included in the net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 2, 2023, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Reliance Trust Company, the trustee of the Plan and qualified institution, has certified to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, the related activity reflected in the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2022.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Collective Fund:* Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since relying on the prototype opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by Reliance Trust Company (the trustee), DST Retirement Solutions, LLC (the Plan's recordkeeper), and T. Rowe Price (mutual fund manager). Therefore, the investment transactions and recordkeeping services qualify as party-in-interest.

**NOTE 9 DUE TO AFFILIATED PLAN**

Effective January 1, 2023, the Plan merged and transferred all assets into the Stagwell Global 401(k) Plan ("Stagwell Plan") and adopted the Stagwell Plan as a participating employer. As of December 31, 2022, the Plan had a balance due to the affiliated Stagwell Plan of \$26,210,515.
