### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of DRB Systems, LLC 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended December 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following description of the DRB Systems, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering significantly all employees of DRB Systems, LLC and Affiliates (the "Company", "Plan Sponsor", or "DRB"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective 11:59 EST on December 30, 2022, the Plan was merged (the "Merger") into the Vontier Retirement Savings Plan (the "Savings Plan"). Pursuant to the Merger, all assets and liabilities of the Plan were transferred to the Savings Plan upon the effective time of the Merger. Employees who were participants in the Plan on December 30, 2022 maintain the same benefits under the Savings Plan.

Eligibility:

Employees are eligible to participate in the Plan following attainment of age 18.

Contributions:

Participants may voluntarily contribute a minimum of 1% to a maximum of 75% of their compensation on a pre-tax or post-tax ("Roth") basis subject to limitations in the Internal Revenue Code ("IRC"). The Company is the Plan's administrator. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The types of employer contributions are as follows:

*Discretionary Employer Matching Contribution* – The Company annually declares a percentage of the employee salary deferral contribution that it will match and contribute to the Plan for each participant. For the period ended December 30, 2022, the Company matched 50% of each dollar of employee contribution up to 6% of participants' annual compensation. Discretionary employer matching contributions of \$1,184,758 were made for the period ended December 30, 2022.

*Qualified Employer Matching Contribution* – The Company may elect to make a qualified matching contribution to comply with non-discrimination requirements of the IRC. A "qualified matching contribution" is allocated as a match of employee salary deferrals subject to Plan limits. No discretionary qualified matching contributions were declared for the period ended December 30, 2022.

*Discretionary Non-Elective Contribution* – The Company may elect to make a discretionary non-elective contribution. Employees must be employed as of the last day of the Plan year to be eligible for any non-elective contributions that may be made for that Plan year. No discretionary non-elective contributions were declared for the period ended December 30, 2022.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 1. Description of Plan (Continued)**

Contributions (Continued)

*Qualified Non-Elective Contribution* – The Company may elect to make a qualified non-elective contribution to comply with non-discrimination requirements of the IRC. A qualified non-elective contribution is allocated to only non-highly compensated participants based on compensation. No qualified non-elective contributions were declared for the period ended December 30, 2022.

The Plan also permits certain rollover contributions from other qualified retirement plans.

Participant Accounts:

Each participant's account is credited with the participant's contributions, employer contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their allocation of contributions or transfer money between investment options any time during the year.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Participants employed prior to November 15, 2019 were also immediately vested in the Company's contributions, plus actual earnings thereon. Participants employed after November 15, 2019 are vested in the Company's contribution portion of their accounts based on years of continuous services. A participant is 100% vested after two years of credited service (0% in year one and 100% in year two), or in the event of death, total and permanent disability, or obtaining normal retirement age as defined by the Plan.

Notes Receivable From Participants:

Participants who had loans in the plans from previous Company acquisitions were permitted to retain existing loans. No other loans are allowed under the Plan.

Payment of Benefits:

Upon termination of service, death, disability, retirement, or other reasons, a participant may elect to receive his or her account balance as a lump-sum payment or in periodic installments, as defined. Participants terminated are entitled to receive their benefits as soon as administratively feasible. The plan administrator may automatically make a lump-sum distribution for account balances less than \$5,000. Distributions from a participant's account may be authorized at any time by the plan administrator under certain hardship conditions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 1. Description of Plan (Continued)**

Forfeited Accounts:

Any forfeited non-vested accounts may be used to pay administrative fees or reduce future employer contributions. At December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$-0- and \$27,507, respectively. During the period ended December 30, 2022, \$60,668 was forfeited by non-vested participants. Additionally, during the period ended December 30, 2022, forfeitures of \$21,621 were utilized to offset employer contributions, \$38,911 were utilized for fees and other adjustments, and \$27,643 were transferred.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.
- B. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- C. Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investments advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- D. Payment of Benefits – Benefits are recorded when paid.
- E. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon terms of the Plan document. The loans are secured by the balance in the participant's account and bear interest at a rate determined at the time the loan was taken. Principal and interest are paid ratably through payroll deductions.
- F. Administrative Expenses – Administrative expenses, including third party administrative expenses and investment management fees, are paid by the Plan or the Company at the option of the Company. Fees attributable to distributions are paid by the affected participants.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 3. Unaudited Information**

Fidelity Management Trust Company ("Fidelity"), Trustee of the Plan, held the Plan's investment assets and executed transactions therein.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 30, 2022 and December 31, 2021, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the period ended December 30, 2022, and the investment related information the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 4. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 – Unobservable inputs in which little or no market data exists.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used from 2021 to 2022.

- Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.
- Common/Collective Trust: The investments in the common/collective trust, which include fully benefit-responsive contracts, are held and managed by Putnam Investments. The fair value of investments held in these accounts is based on their reported NAV. The NAV is primarily based on observable inputs and the market value of the underlying investments and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Party-in-Interest Transactions**

Certain investments held by the Plan are managed by Fidelity, the Trustee. Fidelity also receives administrative fees from the Plan. As such, these investments and the related transactions qualify as party-in-interest transactions.

**Note 6. Income Tax Status**

The Plan uses a Volume Submitter Plan Document offered by the Trustee. The Internal Revenue Service has informed the Trustee by letter dated June 30, 2020, that the form of the Plan is acceptable under applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 30, 2022, there are no uncertain tax positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.
