NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Millard Group, Inc. 401(k) Plan and Trust (the “Plan”) provides only general information.

Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan with a 401(k) provision covering all employees not covered by a collective bargaining agreement of The Millard Group Inc. and affiliates (the “Employer” and the “Plan Administrator”). Employees of the Employer become eligible upon completion of one year of service and having attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Plan Termination

On October 20, 2021, the board of directors of The Millard Group, Inc. approved the termination of the Plan with an effective date of October 20, 2021.

The Company had the right under the Plan to terminate the Plan subject to the provisions of ERISA and subject to the terms of the Plan. As a result of the Plan’s termination, the Plan’s net assets were to be allocated for payment of Plan benefits to the participants in accordance with ERISA, applicable regulations, and the Plan document. Beginning in February 2022, all the participants of the Plan were required to elect one of the following options with respect to their participant account balances: 1) single lump-sum distribution, or 2) rollover to another qualified retirement plan. Participants not electing one of the above options had their account balances transferred to an investment retirement account. As of December 12, 2022, all plan assets were fully liquidated.

Prior to Plan termination and liquidation, provisions of the Plan were as follows:

Contributions

Participants may elect to defer up to 75% of eligible compensation, as defined in the Plan, subject to maximum amounts established by the Internal Revenue Code (the “Code”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Employer may make discretionary matching contributions based on a formula, as defined in the Plan. Additional amounts may be contributed at the option of the Employer’s board of directors as profit-sharing contributions. Discretionary contributions and forfeitures, if applicable, are allocated as of the last day of the Plan year.

Participants’ Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s matching contribution, and allocations of the Employer’s discretionary profit-sharing contribution and Plan earnings and is charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. Forfeited balances of terminated participants’ non-vested accounts are used to pay Plan expenses or reduce future Employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments

Participants can direct their account balances among the various investments offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching and discretionary profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of credited service. A participant vests 20% per year in years two through six of participation and is 100% vested after six years of service. However, if an active participant dies or becomes disabled prior to attaining the normal retirement age, the participant becomes 100% vested. Upon Plan termination effective October 21, 2021, all participants in the Plan became 100% vested.

Notes Receivable from Participants

Participants may borrow (subject to certain restrictions) from their funded accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. As of December 12, 2022, there were no outstanding loans given the Plan liquidation in the current year. The interest rates ranged from 4.25% to 5.50% at December 31, 2021.

Party-in-Interest Transactions

Administrative and investment expenses are charged against the Plan's investment income. Various administrative, legal, and accounting services are performed by Employer personnel on behalf of the Plan for which no charges are made to the Plan, and the Employer's management has no plans to obtain reimbursement of these expenses from the Plan. Certain Plan investments are shares of mutual funds managed by Transamerica Financial Life Insurance Company, a related party of Transamerica Life Insurance Company ("Transamerica" or "Custodian"); therefore, these transactions qualify as party-in-interest transactions.

Payments of Benefits

On termination of services, a participant (or their beneficiary) may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability, or retirement elect to receive annual installments not to exceed the participant's life expectancy. Upon death, disability or retirement, a participant's account balance becomes fully vested and distributed, as defined. Additionally, participants may take a distribution of their vested benefit in the case of a hardship, as defined in the Plan.

Forfeitures

There were forfeited nonvested account balances of \$0 and \$2,294 as of December 12, 2022 and December 31, 2021, respectively. Forfeited nonvested discretionary contribution account balances may be utilized to reduce the Employer's contributions to the Plan or to pay for Plan expenses. The Plan used \$2,294 to offset employer expenses for the period from January 1, 2022 through December 12, 2022.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The liquidation basis of accounting was

used as of December 12, 2022 and December 31, 2021 and for the period from January 1, 2022 through December 12, 2022. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts.

Estimates and Assumptions

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of the Plan attributable to a fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for discussion of the Plan's fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2021.

Benefit Payments

Benefits are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements are complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 12, 2022 and December 31, 2021;
- Investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through December 12, 2022.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are both unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 12, 2022 and December 31, 2021.

Pooled Separate Accounts

Valued NAV of units held by all investment units held under the contract. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV of a fund unit as of a business day is equal to the value of the assets in the fund at the end of that day divided by the number of fund units held by the Plan and any other contract holders at the start of the day. The market value will always equal the sum of all investment units held under this contract.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include (1) transfers of assets from the fund into a competing investment option and (2) when total distributions and transfers in the fund exceed certain levels. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. Although the Plan has been

terminated, distribution requests and settlements will remain at contract value and there are no adjustments as a result of the termination.

NOTE 6 - TAX STATUS

The Plan is currently under a national Internal Revenue Service (IRS) approved volume submitter plan sponsored by Transamerica that has received a favorable opinion letter dated March 31, 2014, under the applicable provisions of the Internal Revenue Code (IRC). Companies who adopted this plan without changes could rely on the sponsor's opinion letter. The Company adopted the Transamerica volume submitter plan without any changes. However, the Plan has been amended since the latest opinion letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 12, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits and the statement of changes in net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

Plan management evaluated its December 12, 2022, financial statements for subsequent events through October 5, 2023, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.
