Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rancho Pacific Electric Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 – DESCRIPTION OF PLAN

The following description of Rancho Pacific Electric Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2010, is a safe harbor defined contribution plan covering substantially all employees of Rancho Pacific Electric Inc. as well as a participating employer, Rancho Pacific Electric Construction, Inc. (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees who have completed one year of service, or equivalent, and who are at least 18 years of age are eligible to participate in elective deferrals to the Plan. Employees are immediately eligible to participate in prevailing wage contributions to the Plan. The Plan allows employees to begin participating immediately upon reaching eligibility.

Contributions

The Plan permits eligible participants to contribute up to 100% of compensation, subject to certain Internal Revenue Code limitations (\$20,500 and \$19,500, respectively, for 2022 and 2021, \$27,000 and \$26,000, respectively, for employees over the age of 50 for 2022 and 2021). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). All contributions to participants’ accounts are participant-directed in the different investment options offered by the Plan.

The Plan provides for employer safe harbor matching contributions equal to 100% of the amount a participant contributes to the Plan up to 4% of eligible plan compensation. The Plan also provides for discretionary employer profit sharing contributions. As of December 31, 2022 and 2021, discretionary safe harbor match contributions totaled \$107,705 and \$87,167, respectively.

The Company also provides prevailing wage contributions on behalf of each participant. Prevailing wage contributions will be an amount equal to the balance of the prevailing wage defined bona-fide fringe benefit amount based on the participant’s employment classification as designated on the prevailing wage determination appropriate for that classification. Prevailing wage contributions are not subject to any age, service, or employment condition requirements.

NOTE 1 – DESCRIPTION OF PLAN, CONTINUED**Participant Accounts**

Individual accounts are maintained for each of the Plan's participants to reflect each participant's contributions and any employer contributions, as well as the participant's share of his investment income or loss, less an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Subject to safe harbor requirements, participants are immediately vested in safe harbor matching contributions. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in discretionary matching and discretionary profit sharing Company contributions after six years of credited service. A participant is immediately vested in the Company's prevailing wage contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for up to five years. The vested balance in the borrower's Plan account secures the loans. Interest rates are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid by automated clearing house payments by the participant.

Hardship Withdrawals

A withdrawal from a participant's account may be permitted if the participant has a financial hardship as defined in the Plan document.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount or substantially equal installments equal to the full or partial value of his or her vested account balance, to roll over the vested balance into another qualified plan, or to leave the vested balance in the Plan if greater than \$1,000. An involuntary distribution is made for participants with a vested account balance less than \$1,000 upon termination. Participants may also elect an in-service distribution after attaining age 59½.

Forfeited Accounts

Forfeited non-vested accounts may be allocated to reduce future employer discretionary matching or discretionary profit-sharing contributions. During the year ended December 31, 2022, no employer contributions were reduced by forfeited non-vested accounts. As of December 31, 2022 and 2021, there were no forfeitures that have not yet been allocated to employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIESBasis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 – Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2022 and 2021, no allowance for credit losses has been recorded. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain transactional fees are charged directly to the participant’s account. Investment related expenses are included in net depreciation of fair value of investments.

Date of Management’s Review

Subsequent events have been evaluated through September 21, 2023, which is the date the financial statements were available to be issued.

NOTE 3 – UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan offers a fully benefit-responsive collective investment trust contract with Minnesota Life Insurance Company (“Minnesota Life”). Minnesota Life maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The collective investment trust contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS, CONTINUED

The contract value of the guaranteed investment contract was \$630,492 and \$581,047, respectively, as of December 31, 2022 and 2021.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

NOTE 5 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value on a recurring basis in the statement of net assets available for benefits in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 – "Fair Value Measurements and Disclosures." This pronouncement defines fair value, establishes a framework for measuring fair value, enhances fair value disclosure requirements and creates a three-level valuation hierarchy for disclosure of fair value measurement. This valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels of the inputs to the valuation methodology are defined as follows:

- Level 1 – Observable, quoted market prices (unadjusted) in active markets for identical assets and liabilities that the reporting entity has the ability to access at the measurement date.

NOTE 5 – FAIR VALUE MEASUREMENTS, CONTINUED

- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data. This input level includes those financial instruments that are valued using models or other valuation methodologies where substantially all of the assumptions are observable in the marketplace, can be derived from observable market data, or are supported by observable levels at which transactions are executed in the marketplace.
- Level 3 – Unobservable inputs that are not corroborated by market data. This level of input includes financial instruments whose fair value is estimated based on internally developed models or methodologies utilizing significant inputs that are generally less readily observable from observable sources.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year end. The pooled separate accounts unit prices are quoted on a private market that is not active; however, the unit prices are based on underlying investments which are traded on active markets.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes that the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Plan sponsor and, therefore, these transactions qualify as party-in-interest transactions. No officer or employee of the Company receives compensation from the Plan. Certain Plan expenses are paid directly by the Plan sponsor.

Certain administrative functions are performed by the Plan's trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the trustee from Plan assets totaled \$29,181 for the year ended December 31, 2022 and are included in administrative expenses on the statement of changes in net assets available for benefits.

Certain investments are managed by the Plan's investment advisors of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Total fees were \$27,147 for the year ended December 31, 2022 and are included in the net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

NOTE 7 – TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated March 31, 2014 to the trustee, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, eligible participants will become 100% vested in their account balances.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
