INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust

Opinion

We have audited the accompanying financial statements of Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust, an employee benefit plan subject to the Employee Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits (cash basis) for the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (cash basis) of Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust as of December 31, 2022 and 2021, and the changes in its net assets available for benefits (cash basis) for the year ended December 31, 2022, in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2022 AND 2021

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a health and welfare plan established on May 1, 1995 to provide benefits to employees and eligible dependents of Homeland Vinyl Products, Inc.'s (the Plan Sponsor) employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

In order to comply with the provisions of The Patient Protection and Affordable Care Act (PPACA), the Plan Sponsor established a second-tier health plan for employees on May 1, 2014.

BENEFITS

The Plan provides health benefits, dental insurance, vision insurance, life insurance coverage, and disability benefits to employees and eligible dependents. Employees reasonably expected to work 30 hours per week are eligible for coverage. After an employee's separation of employment or retirement, the separated employee may elect coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). The separated employee is notified upon termination and is required to elect the coverage within a specified time. The separated employee is responsible to pay for this coverage but may be eligible for government assistance under certain circumstances.

Health benefits for three of the Plan Sponsor's locations are self-insured and processed by a contract administrator. However, the responsibility for payments is retained by the Plan and ultimately by the Plan Sponsor. The Plan Sponsor purchases insurance to cover claims exceeding annual specified amounts. Health benefits for the Plan Sponsor's various locations are provided through various insurance carriers.

CONTRIBUTIONS

Employees contribute specified amounts for health coverage based upon recommendations of the third-party administrator, and to extend coverage to eligible dependents. The Plan Sponsor pays for certain costs of health and other coverages for employees and pays a substantial portion of the costs of the Plan. Employees have the options to select their coverages by making election for such with payroll deductions. Under present law, the Plan Sponsor is not permitted to deduct amounts for future benefits to current employees.

OTHER

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are prepared on the cash basis of accounting. The cash basis differs from accounting principles generally accepted in the United States of America primarily because the Plan does not recognize claims payable, claims incurred but not reported, amounts due for insurance and fees, and amounts withheld from employees and not yet remitted to the Plan.

ACCOUNTING PERIOD

The Plan administrator has elected a calendar year ending December 31.

USE OF ESTIMATES

The preparation of financial statements in accordance with the cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

DEPOSITS

The Plan's cash balances consist of money market funds, which are stated at contract value.

INCOME TAX STATUS

There is no provision for income taxes since the Plan is a non-profit organization exempt from both federal and state income taxes. The Plan has received an exemption letter from the Internal Revenue Service granting it tax-exempt status under Internal Revenue Code 501(c)(9).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

DATE OF MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2023, which is the date the financial statements were available to be issued.

NOTE 3 - PLAN RECEIVABLES AND BENEFIT OBLIGATIONS

There are no significant employee contribution receivables as of December 31, 2022 and 2021. Benefit obligations as of December 31, 2022 for health claims incurred by active participants, but not reported or paid at that date, are estimated by the Plan's third-party administrator. The third-party administrator estimates these claims are approximately \$75,300 and administrative fees on these claims of \$8,004. Because the Plan's financial statements are prepared using the cash basis of accounting, these obligations are not reflected in the accompanying financial statements. The amounts ultimately paid by the Plan are based only on the claims actually submitted and approved for payment.

NOTE 4 - RELATED PARTY TRANSACTIONS

The Plan Sponsor maintains the ability to pay administrative fees (including accounting, tax, and auditing services) of the Homeland Vinyl Products, Inc. Employee Benefit Plan & Trust, except as follows:

The Plan has contracted with a third-party claims administrator, Blue Cross and Blue Shield of Alabama (Blue Cross), which administers the self-insured health coverage claims and provides assistance in complying with applicable laws and regulations including the PPACA, for fees based on a percentage of claims. In addition, Blue Cross receives certain access fees. The total of these fees amounted to approximately \$6,021 for the year ended December 31, 2022. These fees are considered Eligible Indirect Compensation under ERISA and are reflected in the statement of changes in net assets available for benefits.

All of the party-in-interest transactions, including the Eligible Indirect Compensations fees, are considered exempt from the prohibited transactions rules of ERISA.
