**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Simplified Investments 401(k) Plan, f/k/a the MKB Holdings, LLC Employee 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

Effective July 1, 2017, Simplified Investments f/k/a MKB Holdings, LLC (the “Company”) implemented a defined contribution plan. The Plan covers substantially all employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has been amended from time to time to comply with current legislation (most recently January 1, 2023) and management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

**Eligibility**

Employees become eligible to participate in the Plan upon completion of 90 days of service.

**Contributions**

Participants may make voluntary contributions to the Plan of up to 100% of their annual eligible compensation, but not in excess of the maximum amount permitted by the Internal Revenue Code. The Company may elect to make a matching contribution determined annually. The Company matching contribution was 50% of employee deferrals up to 5% of eligible compensation.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**Participant accounts**

Upon enrollment in the Plan, or at any time subsequent, a participant may direct contributions into any of the available investment options. Each participant's account is credited with contributions in an amount equal to the salary reduction elected by that employee, the related matching contribution and, if applicable, a portion of the special discretionary contribution for employees equal to a percentage of each eligible individual's compensation. Earnings and administrative expenses are allocated based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Each participant's account is credited with voluntary contributions and an allocation of Plan earnings based on the participant's account balance. Participants are immediately vested in their elective deferral, plus actual earnings.

Employer matching contributions vest based on years of continuous service. Specifically, employer matching contributions vest according to the following schedule:

<u>Vesting service</u>	<u>Vesting percentage</u>
Less than one year	0%
One year but less than two years	20%
Two years but less than three years	40%
Three years but less than four years	60%
Four years but less than five years	80%
Five years or more years	100%

**Forfeitures**

Forfeitures of non-vested matching contributions from terminated participant accounts are used to offset future matching contributions, or to pay expenses of Plan administration, as determined by Plan management.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**Benefit Payments**

Generally, benefits are paid to participants at termination. When the service period ends as a result of death or retirement, the participant or beneficiary will receive a lump sum distribution equal to the value of their accounts. Participants may elect to defer receipt of benefits. At December 31, 2022 and 2021, the Plan had obligations to terminated employees totaling \$484,719 and \$372,452, respectively.

**Investment Options**

All investments are participant directed among various *Reliance Trust Company* investment options.

**Loans**

The Plan does not allow participants to borrow money from the Plan.

**Administrative Expenses**

Unless elected to be paid by the Company, administrative expenses incurred in connection with the Plan shall be paid from forfeitures, except for expenses related to distributions and other participant-initiated transactions, which are charged to the account of the participant.

Certain plan administrative fees are absorbed by the Company and certain administrative fees are paid by the Plan. Administrative fees paid by the Plan totaled \$28,190 and \$4,927 during 2022 and 2021, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

All Plan investments are held by the custodian, *Reliance Trust Company*, and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for further discussion and disclosure related to fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plan's investments are included in net appreciation in the fair value of investments in the statements of changes in net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, the plan custodian shall hold the funds for distribution and distribute to the participants the full amount standing to their credit on the date of such termination, less the administrative cost to the custodian for such distribution, in accordance with the Plan provisions.

**NOTE 4 – TAX STATUS**

The Company's Board of Directors adopted the Volume Submitter Profit Sharing 401(k) Plan document. The Plan document has received an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain qualification.

**NOTE 4 – TAX STATUS (CONTINUED)**

Management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

The Plan has adopted the provisions of ASC Topic 740, *Income Taxes*, relating to uncertain tax positions. ASC Topic 740 provides a consistent framework to determine the appropriate level of tax reserves to maintain for uncertain tax positions. Specifically, the Plan must recognize a tax liability (or asset) if the Plan has taken an uncertain position that *more likely than not* would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there were no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which no compensation is received. Administrative expenses for legal, accounting and other services are rendered by parties-in-interest and are paid by the Company.

Certain plan assets are in investment funds managed by *Reliance Trust Company*. *Reliance Trust Company* is the custodian of the Plan; therefore, transactions with *Reliance Trust Company* qualify as party-in-interest transactions.

**NOTE 6 – INVESTMENTS - UNAUDITED**

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Simplified Investments 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

*Reliance Trust Company*, the custodian of the Plan, has certified the completeness and accuracy of all investment information reflected in the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, the 2022 schedule of assets held at end of year, and the related investment activity reflected in the statements of changes in net assets available for benefits for 2022 and 2021.

**NOTE 7 – FAIR VALUE OF FINANCIAL INSTRUMENTS**

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). ASC Topic 820 requires fair value measurements to be separately disclosed by level within the fair value hierarchy.

The three levels of fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: inputs to the valuation methodology are unadjusted quoted prices for *identical* assets or liabilities in active markets that the Plan has the ability to access.

Level 2: inputs to the valuation methodology include: quoted market prices for *similar* assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Valuation is generated from model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect the estimates of assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Registered investment companies* include a portfolio of financial instruments that include U.S. equities, international equities, lifestyle funds, and short and intermediate-term investment funds. These are valued based on a quoted market price for identical assets in active markets that the Plan has the ability to access. Registered investment companies are included as Level 1 assets in the fair value hierarchy.

*Fully benefit-responsive investment contracts* (FBRIC's) consist of a diversified portfolio of group annuity contracts issued by life insurance companies, banks and other financial institutions - the performance of which may be predicated on underlying fixed income investments. The principal value of these assets is designed to remain stable regardless of stock and bond market fluctuations. FBRIC's are valued at fair value using NAV per share (or its equivalent) as a practical expedient at year-end. Accordingly, under the new accounting pronouncements, the FBRIC's which are carried at fair value using the net asset value practical expedient, are no longer carried at contract value in the statement of net assets available for benefits and are not categorized within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no Level 3 (or Level 2) assets at December 31, 2022 or 2021. As a result, there are no changes in the fair value of Level 3 assets to report for either year / period.

**NOTE 8 – EMPLOYER MATCHING CONTRIBUTION ERRORS**

During 2021, the Plan sponsor did not follow the Plan terms and improperly applied the Plan's matching contribution formula - - based on 50% of employee deferrals up to 5% of eligible compensation.

In certain cases, the Plan sponsor *over-matched* employee deferrals; and in certain cases, the Plan sponsor *under-matched* employee deferrals. In accordance with the Plan terms, the Plan sponsor will make a corrective contribution (plus earnings) for or corrective distribution to participants.

Management has reviewed its matching contribution formula and compared it to what is used in operation. Based on that review, management has concluded the incorrect matching constitutes an insignificant operational error – available for self-correction under the *Employee Plans Compliance Resolution System* (EPCRS). Specifically, the Plan sponsor has applied reasonable correction methods that would put affected participants in the same position they would have been in if matching contributions were made in accordance with Plan terms.

As a result, the Plan was not required to obtain IRS approval and did not incur any penalties associated with its self-correction of the matching errors.

**NOTE 9 – EXCESS CONTRIBUTIONS PAYABLE TO PARTICIPANTS**

The Plan is subject to certain non-discrimination rules under ERISA and the Code. For the Plan year ended December 31, 2022, the Plan failed certain non-discrimination tests under the Code due to lower contribution percentages by non-highly compensated eligible employees relative to the contribution percentages of highly compensated eligible employees. In order to meet the requirements of the non-discrimination rules, the Plan refunded a portion of the contributions made by highly compensated participants, in accordance with applicable provisions of the Code.

The refund attributable to 2022 totaled \$69,107.

**NOTE 10 – SUBSEQUENT EVENTS**

In accordance with ASC Topic 855, *Subsequent Events*, the Plan's management has evaluated subsequent events through October 5, 2023, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
