- a. Mortality: The 2022 Static Mortality Tables (with no projection for mortality improvement) were used. The optional combined tables for small plans were used, separately for male and female lives.
- b. Interest: Benefits were discounted by 4.75% (first segment rate) for payments expected from January 1, 2022 – December 31, 2026, by 5.18% (second segment rate) for payments expected from January 1, 2027 – December 31, 2041, and by 5.92% (third segment rate) for payments expected on or after January 1, 2042.
