INDEPENDENT AUDITORS' REPORT

To the Board of Directors
Dynetics, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Dynetics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 23, 2023, December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 to January 23, 2023, and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Dynetics, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 23, 2023, December 31, 2022 and 2021, and for the period from January 1, 2023 to January 23, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. DESCRIPTION OF THE PLAN

The following description of Dynetics, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees, as defined by the Plan, of Dynetics, Inc. (the Company or Plan Sponsor), except for employees covered by a collective bargaining agreement, independent contractors, leased employees, nonresident aliens, hired as interns, and employees employed in Cost Pool 24 of the Company or Dynetics Technical Solutions (for the purposes of sharing in any employer contributions). Effective April 1, 2022, the Plan was amended to allow consulting employees to make elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's Investment Advisory Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On September 21, 2021, the Company acquired Spire Manufacturing Solutions and Davis Manufacturing Company. The Plan was then amended to credit any prior service with the acquired companies in determining such employees' years of service under the Plan.

On May 2, 2022, the Plan was amended to provide certain employees, who are hired as direct support for a specific named information technology contract, with credit for their prior service with respect to the contract in determining their vesting service under the Plan.

Plan Merger

On January 31, 2020, the Company was acquired by Leidos Holdings, Inc. Pursuant to the Stock Purchase Agreement. Effective January 23, 2023, the Plan merged into the Leidos, Inc. Retirement Plan (Leidos Plan), and such merged plans formed one plan within the meaning of Section 414 (1) of the Internal Revenue Code of 1986, as amended. The accumulated assets and liabilities of the Plan become assets and liabilities of the Leidos Plan. Employees of the Plan have account balances equal to the balances each participant had in the Plan and the Leidos Plan immediately prior to the merger.

Contributions

Each year, participants may contribute, on a pretax basis or in the form of designated Roth contributions, up to 50% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Employees hired after July 1, 2019, are automatically enrolled at a 5% pretax contribution deferral upon first becoming eligible to participate in the Plan, with a 1% annual increase on their anniversary date of Plan entry up to a maximum of 15%, unless an election is made for a different amount or an election is made not to participate. The automatic enrollment provision was eliminated for employees hired on or after October 1, 2022. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

1. DESCRIPTION OF THE PLAN – CONTINUED

Contributions

At the discretion of the Company's Board of Directors, the Company may contribute a discretionary profit-sharing or a discretionary matching contribution based on participant classification and their eligible compensation. Participants must have completed six months of service, as defined by the Plan, to be eligible for employer contributions. For the year ended December 31, 2022, the Company's Board of Directors elected to make a discretionary profit-sharing contribution equal to 3% of eligible compensation for certain eligible participants and a discretionary matching contribution of up to 2% of eligible compensation for certain eligible participants, as defined by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Effective January 1, 2022, the Plan was amended to remove the six-month service requirement for employer contributions and added a provision that allows participants to make after-tax and Roth contributions to the Plan. After-tax contributions may not exceed 10% of compensation and are not eligible for an employer match. After-tax contributions, plus earnings thereon, are available for hardship distribution. The amendment provides that participants may elect to contribute, in the aggregate, from 1% to 60% of compensation as pre-tax, designated Roth and/or after-tax contributions.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, as well as allocations of any of the Company's discretionary profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching, profit-sharing and non-elective contribution portions of their accounts plus actual earnings thereon is based on years of service, as follows:

Less than two years	0%
Two years but less than three	20%
Three years but less than four	40%
Four years but less than five	60%
Five years and thereafter	100%

Effective June 28, 2019, any participant who was employed by the Company in the Washington, DC Operations on the date of the sale/divestiture of the Washington, DC Operations to Thompson Gray became 100% vested in their account.

1. DESCRIPTION OF THE PLAN – CONTINUED

Vesting

Effective January 4, 2022, the Company sold its interest in Aviation and Missile Solutions, LLC (AMS). Any participant who was either employed by AMS as of March 25, 2022, or whose employment is transferred from Dynetics, Inc. to AMS as of March 25, 2022, became 100% vested in their account under the Plan as of such date.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

A participant becomes eligible for benefits upon termination of employment, death or disability. In-service withdrawals are permitted after age 59½ or due to financial hardship. Benefits are payable in a lump sum or installments. Terminated participants with a vested balance less than \$5,000 that have not elected payment will automatically be rolled into an IRA by the Plan administrator, in the absence of participant distribution instructions.

Forfeitures

Forfeitures may be used to reduce future employer contributions or pay administrative expenses. There were no forfeited nonvested accounts at December 31, 2022. Forfeited nonvested accounts totaled \$64,027 at December 31, 2021. During the year ended December 31, 2022, forfeitures of \$1,694,535 were used to fund employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Fees related to certain participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through September 27, 2023, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY TRUSTEE AND CUSTODIAN (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at December 31, 2022 and 2021 and the period from January 1, 2023 to January 23, 2023, and net depreciation in fair value of the investments, interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC (the Trustee) and the New York Life Insurance Company (the Insurance Company).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 or 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Units of participation of common/collective trust funds are valued at the NAV provided by the fund's Trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner. The funds held by the Plan at December 31 2021, did not have unfunded commitments.

Self-directed brokerage investments: Accounts primarily consist of interest-bearing deposits, mutual funds and common stocks that are valued on a basis of readily determinable market prices.

4. FAIR VALUE MEASUREMENTS - CONTINUED

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee, the Insurance Company and Ameritrade Retirement Services; therefore, these transactions qualify as party-in-interest transactions.

John Hancock Retirement Plan Services, LLC (JHRPS), an affiliate of the Trustee, provides certain administrative services to the Plan pursuant to the services agreement between the Company and JHRPS. JHRPS receives revenue sharing from investment option issuers for services JHRPS provides to the funds. This revenue is used to offset certain amounts owed to JHRPS for its administrative services to the Plan.

If the revenue received by JHRPS from such investment option issuers exceeds the amount owed under the services agreement, JHRPS remits the excess to the Plan's trust on a periodic basis. Such amounts may be applied to pay Plan administrative expenses or allocated to accounts of the participants. The Plan or Plan Sponsor may make payments to JHRPS for administrative expenses not covered by the revenue sharing.

6. PLAN TERMINATION

The Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. As discussed in Note 1, the Plan merged with the Leidos Plan on January 23, 2023.

7. TAX STATUS

The IRS has determined and informed the Company by a letter dated August 14, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
