We have performed an audit of the financial statements James Power Line Construction, LLC 401(k) Plan (the Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Notes to the Financial Statements

#### **Note 1. Description of Plan**

The following description of James Power Line, LLC, 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was amended effective February 1, 2022. See nature of amendment in Note 1.

**General:** The Plan is a safe harbor defined contribution plan that covers all employees of James Power Line Construction, LLC (the Company or Plan Sponsor) who have completed six months of service and are age 21 or older. Once the eligibility requirements are met, an employee can enroll in the Plan on the first day of the Plan quarter following the date that eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA)

**Contributions:** The Company may make safe harbor and discretionary matching and profit sharing contributions, as defined in the Plan. During 2022 and 2021, the Company contributed safe harbor matching contributions of 100% of the first 3% of eligible participant's compensation and 50% of the next 3% of eligible participant's compensation, not to exceed 5% of the participant's compensation. Contributions are subject to certain limitations. For the year ended December 31, 2022, the Company made safe harbor contributions totaling \$86,879. There were no discretionary matching or profit sharing contributions for the year ended December 31, 2022.

Participants may elect to contribute up to 100% of pretax eligible compensation, as defined. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions.

Effective February 1, 2022, Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Investment options:** Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may direct contributions and any related earnings into 22 investment options offered by the Plan. Participants may change the allocation of their existing funds and figure contributions at any time. The Plan's investment are held by the Custodian of the Plan.

**Participant accounts:** Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily. Each participant's account is credited with the participant's contribution, allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to the Financial Statements

#### **Note 1. Description of Plan (Continued)**

**Vesting:** Participants are vested immediately in their contributions, safe harbor matching contributions and actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts is based on years of continuous service. Employer discretionary matching and profit sharing contributions have a six-year graded vesting period as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

**Payment of benefits:** On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Terminated participants with vested balances less than \$1,000 are paid out as soon as administratively possible, unless elected otherwise by the participant. Terminated participants with vested balances between \$1,000 and \$5,000 have their accounts rolled over to an individual retirement account designated by the Plan Administrator, unless elected otherwise by the participant. This is also done as soon as administratively possible. Hardship withdrawals are also available subject to certain limitations.

**Forfeitures:** Participant forfeitures of nonvested balances will be used to reduce future employer contributions or pay the expenses of the Plan. During 2022 and 2021, no forfeitures were used to pay administrative expenses or to reduce employer contributions. At December 31, 2022 and 2021, unallocated forfeitures totaled \$2,067 and \$2,051, respectively.

#### **Note 2. Summary of Significant Accounting Policies**

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Notes to the Financial Statements

#### **Note 2. Summary of Significant Accounting Policies (Continued)**

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be recognized to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for disclosure of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Excess Contributions Payable:** Amounts payable to participants for contributions in excess of amounts allowed are recorded as a liability with a corresponding reduction of contributions. The Plan did not distribute the 2020 excess contributions to the applicable participants prior to March 15, 2022, and the Plan will file Form 5330 and paid the related excise tax.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through October 3, 2023, the date the financial statements were available to be issued.

**Note 3. Information Certified or Provided by Capital Bank and Trust Company, the Plan Custodian**

#### **Note 4. Fair Value Measurements**

The FASB Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820, Fair Value Measurements and Disclosures, are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices for the asset or liability that are observable
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 inputs must be observable for substantially the full term of the asset or liability. **Error! Not a valid link.** **Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

**Mutual funds:** Valued at the daily closing price as reported by the fund, Mutual funds held by the Plan are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Note 4. Fair Value Measurements (Continued)**

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 6. Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the custodian, as defined by the Plan and, therefore, these investments qualify as party-in-interest transactions.

The Company also paid certain administrative expenses related to the Plan for the year ended December 31, 2022. These party-in-interest transactions are exempt from the prohibited transaction rules or ERISA.

#### **Note 7. Risk and Uncertainties**

The Plan invests in various types of investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8. Tax Status**

The Plan has adopted a non-standardized prototype plan and trust document that received a favorable opinion letter dated March 31, 2014, from the Internal Revenue Service (IRS). The plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for plan years ending on December 31, 2017, or prior.

#### **Note 9. Subsequent Event**

Due to the recent merger of the Plan Sponsor, James Power Line Construction, into PowerGrid Services NewCo LLC, the Plan Sponsor decided to merge the records and retirement funds of the Plan participants to the PowerGrid Services NewCo, LLC 401(k) Plan as of March 1, 2023. The Plan's administrative services are provided by Principal Life Insurance Company, a member of Principal Financial Group. The last payroll contribution into the Plan was February 22, 2023. As of March 1, 2023, all assets were moved to the PowerGrid Services NewCo, LLC 401(k) Plan, and the James Power Line, LLC 401(k) Plan has no assets.






