Because the plan's termination date was before the date that would otherwise have been the valuation date for the plan year, the valuation date for the plan year had to be changed so that it fell within the short plan year pursuant to Regulation §1.430(g)-1(b)(2)(i).

This change is automatically approved under Regulation §1.430(g)-1(b)(2)(iv).
