### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Precision Tool, Die and Machine Co. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

Years ended December 31, 2022 and 2021

---

#### 1. Plan description

The following brief description of the Precision Tool, Die and Machine Co., Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions. Copies of the Plan Agreement are available from Precision Metal Works, Inc. (the Company).

**General** – The Plan is a contributory defined contribution plan covering substantially all nonunion full-time Company employees who are age 18 or older, have completed one year of service, and have a minimum of 1,000 hours of service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Contributions** – Participants may contribute up to 75% of their annual compensation, as defined in the Plan Agreement. Participants who have reached age 50 before the end of the plan year may contribute additional amounts over this limit. However, total annual deferrals for any participant may not exceed the maximum salary deferral set by law. Participants may also contribute amounts representing rollover distributions from other qualified plans, and after-tax contributions under a Roth elective deferral. The Plan requires Company matching contributions at 25% of each participant's contribution up to 10% of each participant's annual compensation. In addition, the Plan requires a 2% automatic deferral for all employees who are eligible to participate in the Plan. Those employees are subject to the automatic deferral unless they affirmatively file an election to either not participate or elect a different deferral percentage. The Plan also allows the Company to make discretionary nonelective contributions which are allocated to participants based on their annual compensation compared to all participants' compensation for the plan year. No nonelective contributions were made to the Plan for the years ended December 31, 2022 and 2021.

**Participant accounts** – All contributions are allocated by the discretion of the participant among selected investments. Each participant's interest in each of the investment accounts is accounted for in four separate accounts: one each relating to the participant's pre-tax contributions, Roth contributions, and rollover contributions, and the Company's matching contributions. Each participant's account is credited with the participant's contributions, and allocations of the Company's contributions and plan earnings, and charged with allocations of investment-related fees and administration expenses. Allocations of plan earnings, investment-related fees, and administration expenses are based on the value of each participant's account balance compared to the value of all participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their contributions and related earnings. Vesting in the Company’s matching portions of their accounts and the related earnings is based on years of credited service. A participant is fully vested with regard to the Company’s contributions and related earnings after five years of credited service and after six years of credited service related to the Company’s discretionary nonelective contributions and related earnings. Participant rollover contributions from previous plans are fully vested. A participant becomes fully vested in the event of death, disability, or attainment of early retirement age, as defined in the Plan Agreement.

**Participant loans** – Participants may borrow from their participant fund account a minimum of \$500 to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period immediately preceding the date the loan was made, or 50% of their vested balance. Participants are limited to two loans outstanding at any time. Loan terms range from twelve to 60 months unless the loan is for the purchase of a primary residence. Loans are secured by the balance in the participant’s account and bear interest at 2% over the prime interest rate available at the loan issuance date. Principal and interest are paid ratably through payroll deductions. As of December 31, 2022 and 2021, participant loan interest rates for outstanding participant loans range from 5.25% to 7.5%. Participant loan maturity dates range from January 2023 through August 2034 as of December 31, 2022.

**Payment of benefits** – In the event of death, disability, retirement, or termination, a participant’s benefit will be distributed in accordance with specific provisions of the Plan Agreement. In-service distributions and hardship withdrawals are also permitted upon meeting certain requirements as defined in the Plan Agreement.

**Forfeitures** – As of December 31, 2022 and 2021, forfeited nonvested accounts total \$203 and \$202, respectively. Nonvested portions of the Company’s matching accounts are applied to reduce the Company’s future matching contributions. The Company applied forfeitures totaling \$2,084 and \$2,480 to reduce its matching contributions for the years ended December 31, 2022 and 2021, respectively.

**Administration** – Certain administrative functions are performed by Company officers and employees. No such officers or employees receive compensation from the Plan. Certain accounting, legal, and other expenses to maintain the Plan’s records are paid by the Company and are therefore not recorded as expenses on the accompanying statements of changes in net assets available for benefits. Administration expenses reported on the accompanying statements of changes in net assets available for benefits represent investment advisory fees charged directly to the Plan by the Plan’s investment advisor, and fees charged by the Plan’s third-party administrator related to participant loans and distributions.

## 2. Summary of significant accounting policies

**Basis of accounting** – The Plan’s financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

**Estimates** – The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Contributions** – Participant contributions are recorded when the Company computes payroll deductions. Company contributions are recorded based on amounts actually received or committed to be paid for the year.

**Participant loans** – Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022 and 2021 as delinquent loans are reclassified as benefit payments. Delinquent status is based on a participant’s failure to follow the related loan’s payment terms.

**Investment valuation and income recognition** – As more fully described in Note 4, the Plan’s investments in mutual funds are valued at fair value. The Plan’s investment in the common/collective trust is considered a fully benefit-responsive investment contract under GAAP. Accordingly, the common/collective trust is reported at contract value as more fully described in Note 4. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the contract terms. Realized gains and losses on the Plan’s investments are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at period end when the carrying values of the related investments are adjusted to their estimated fair values. Net realized and unrealized appreciation or depreciation in values of the Plan’s investments includes gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Certain investment-related fees charged to the Plan are deducted from income earned on investments and are not separately reflected on the accompanying statements of changes in net assets available for benefits. Consequently, investment return is reflected net of those investment-related fees on the accompanying statements of changes in net assets available for benefits.

**Benefit and withdrawal payments** – Benefit and withdrawal payments are recorded when paid.

**Fair value measurements** – The Plan applies the *Fair Value Measurement* topic of the Accounting Standards Codification (ASC) which requires determination of fair value based on the price that would be received to sell an asset or paid to transfer a liability in an orderly

transaction between market participants as of the measurement date. The *Fair Value Measurement* topic emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and it applies in conjunction with other ASC topics that require or permit fair value measurements and disclosures. Impacted assets and liabilities are measured and disclosed in one of three categories based on the significance and source of the inputs to their valuation. The hierarchy consists of three broad levels: Level 1, Level 2, and Level 3. Level 1 inputs have the highest priority and consist of observable unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs have the lowest priority, are unobservable, and include judgments about the assumptions that market participants would use in pricing the asset or liability.

An asset's or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's management uses specific valuation techniques based on the available inputs to measure the fair values of the Plan's impacted assets and liabilities. When available, the Plan's management measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

These methods may produce fair value calculations that may not be indicative of net realizable values, or reflective of future fair values. Furthermore, while the Plan's management believes the valuation methods utilized are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair values of certain assets and liabilities could result in different fair value measurements as of December 31, 2022 and 2021.

**Subsequent events** – The Plan's management has evaluated subsequent events through October 6, 2023, the date the financial statements were available for issue.

### 3. Certified investments

The Plan's administrator has elected the method of annual reporting as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2022 and 2021, net realized and unrealized (depreciation) appreciation in fair value of investments, and dividend income for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete

and accurate by Reliance Trust Company (Reliance), the Plan's investment trustee. This information has not been audited by the Plan's independent auditors.

#### **4. Investments and fair value measurements**

The Plan's investments are credited with earnings on the underlying investments, and charged for plan withdrawals, investment-related fees, and administration expenses.

The Plan's shares in mutual funds are publicly traded and are valued at the last sale price on the measurement date for the security reported on the principal exchange on which traded (Level 1 input). The mutual funds may be redeemed on a daily basis. Unfunded commitments are not applicable to mutual funds.

The Plan's stable value investment option, issued by KeyBank National Association (KeyBank) through a common/collective trust (the Fund), invests in fully benefit-responsive investment contracts. The Fund's primary investment objective is to achieve stability while providing preservation of principal and accumulated earnings. To achieve this, the Fund typically holds fixed maturity synthetic guaranteed investment contracts (GICs), constant duration synthetic GICs, and short-term investments composed of highly liquid investments with maturities of three months or less that are not likely to be sold at amounts different from their net asset value per share. The Fund's assets are valued in the principal market where the Fund sells the particular asset or transfers the liability with the greatest volume and level of activity. In the absence of a principal market, the valuation is based on the most advantageous market for the asset (i.e., the market where the asset could be sold at a price that maximizes the amount to be received).

The Fund's net asset value is determined daily based on net assets at contract value. Sales and redemptions of participant units are transacted at such net asset values. Trusts participating in the Fund are subject to restrictions on withdrawals from the Fund. Withdrawals needed for benefit payments and loan advances of participating employee benefit plans are generally permitted daily. Withdrawals for other purposes require twelve-month advance written notice to the Fund. At its discretion, the Fund may affect these withdrawals prior to the end of the twelve-month period.

Certain events may limit the Plan's ability to transact at contract value. Such events include: employer layoffs, plant closings, bankruptcy, plan termination, mergers, or early retirement incentives; employer communications designed to induce participants to transfer from the Fund; competing fund transfer or violation of equity wash or equivalent rules in place; and changes of qualification status of employer or plan. The transactions described in Note 9 and their impact on future Company operations could impact the Plan's ability to transact at contract value. However, the Plan's trustee does not believe the occurrence of the transactions will limit the Plan's ability to transact at contract value with participants.

There have been no changes in the valuation methodologies used to value the Plan's investments as of December 31, 2022 and 2021.

## 5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Agreement to discontinue its contributions, and at any time to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

## 6. Income tax status

The Plan operates under a non-standardized pre-approved profit sharing/money purchase plan sponsored by ADP, LLC, an affiliate of Automatic Data Processing, Inc. (ADP), the Plan's third-party administrator. The Internal Revenue Service (IRS) ruled in an opinion letter dated October 6, 2020 that the non-standardized plan was qualified under applicable sections of the Internal Revenue Code (IRC). Prior to April 1, 2022, the Plan operated under a prototype non-standardized profit sharing plan sponsored by ADP, LLC. The IRS ruled in an opinion letter dated July 8, 2014 that the non-standardized plan was qualified under applicable sections of the IRC. The Plan has been amended since the date of the IRS opinion letters. However, the Plan's trustees, sponsor, and administrator are not aware of any occurrences that would adversely affect the Plan's qualified status, and believe the Plan is currently designed and operating in compliance with the applicable IRC requirements, is qualified, and the related trust is tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not

would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken, or expected to be taken, that would require recognition of a tax liability, or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes the Plan is no longer subject to income tax examinations for years prior to the year ended December 31, 2019.

## **7. Party-in-interest assets and transactions**

The Plan's investments are managed by Reliance, the Plan's investment trustee. Therefore, the Plan's investments qualify as party-in-interest assets. Participant loans also qualify as party-in-interest assets. In addition, transactions conducted by Reliance and the Company's contributions qualify as party-in-interest transactions. The Plan pays LPL Financial for investment advisory services provided to the Plan's participants and third-party administration fees to ADP which qualify as party-in-interest transactions. These transactions are permitted under the plan provisions and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## **8. Corrective distributions**

During the years ended December 31, 2022 and 2021, payments totaling \$3,794 and \$12,929, respectively, were made to certain participants to return excess deferral contributions required to satisfy the Plan's relevant nondiscrimination provisions.

## **9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate and credit risks, and overall market volatility. Market risks include global events such as pandemics or international conflicts which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that reductions in the values of the Plan's investment securities reported as of December 31, 2022 will occur in the near term and that such reductions would materially affect participant account balances and amounts reported on the accompanying December 31, 2022 statement of net assets available for benefits.

The Plan's exposure to concentrations risk is limited by diversification of investments across all investment elections. In addition, the investments within each investment election are further diversified into various financial investments.

## 10. Subsequent event

Subsequent to December 31, 2022, the Company's shareholders entered into an agreement to merge with an entity owned by the Company's primary shareholders. Shortly after the merger, the shareholders sold 100% of the existing shares in the merged entity to a third party.
