Note 1: Description of the Plan

The following description of the Munch's Supply Company, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Munch's Supply Company, LLC (Company). Employees are eligible to participate in the Plan upon attaining the age of 18 and completion of one year of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Plan Merger

On January 1, 2021, the Munch's Supply O'Connor, LLC Employees' 401(k) Plan was merged into the Plan. On December 29, 2020, net assets of the Munch's Supply O'Connor, LLC Employees' 401(k) Plan in the amount of \$5,279,733 were transferred to the Plan. The net assets transferred included \$34,285 of employee and employer contributions receivable and \$21,090 of excess contributions payable.

On May 1, 2021, certain participants of the C & L Supply, Inc. Savings and Profit Sharing Plan were merged into the Plan as a result of the Company acquiring a certain service line of C & L Supply, Inc. On May 1, 2021, \$54,434 of outstanding participant notes receivable were transferred to the Plan. On May 10, 2021, \$1,954,510 of net assets were transferred.

Contributions

Participants may elect to make pre-tax contributions of up to 75% of their compensation for the period as permitted under the Internal Revenue Code. Participants may also make an after-tax elective deferral. Participants who have attained age 50 by the end of the plan year are eligible to make catch-up contributions as permitted under the Internal Revenue Code. A participant's account may include contributions made to another plan and transferred to the Plan as part of a rollover contribution.

In addition to participant contributions, the Company will match 50% of the first 6% of compensation contributed by each participant. The Company may also make, at its discretion, a profit-sharing contribution. For the year ended December 31, 2022, no profit-sharing contribution was made to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's matching contributions, the Company's profit-sharing contributions and plan earnings (losses) and charged with administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon.

A participant becomes 100% vested in their Company's matching and profit-sharing contributions upon completion of six years of service.

Effective January 1, 2021, frozen safe harbor matching contributions were merged in from the Munch's Supply O'Connor, LLC Employees' 401(k) Plan. This frozen contribution source is immediately 100% vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a range of 4.25% to 9.00% at December 31, 2022, which is commensurate with local prevailing rates at the time of the loans. Principal and interest is paid ratably through monthly payroll deductions. See Note 2.

Benefit Payments

If a participant retires, the balance of the participant's account is payable at his/her option in either a lump sum or a rollover into a qualified plan or IRA. Hardship withdrawals are allowable, in accordance with the Internal Revenue Code. Upon death, termination or hardship of a participant, the trustee advises the beneficiary or participant of the various methods of distribution of the participant's account available to the participant or his/her beneficiary. See Note 2.

Forfeited Accounts

All forfeitures of Company-match and profit-sharing contributions shall be applied to reduce the contribution obligations of the Company and plan expenses. For the year ended December 31, 2022, forfeitures of \$22,101 were utilized to reduce Company-match contributions. At December 31, 2022 and 2021, \$0 and \$29 of forfeitures, respectively, were available for future use.

Investment Options

Participants may direct the investment of all contributions in one or more of the various investment options offered by the Plan. The Plan currently offers various registered investment companies and a common or collective investment trust, as investment options.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in registered investment companies and self-directed brokerage accounts are valued at quoted market prices. The common or collective trust fund is valued at the net asset value (NAV) of the shares held at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2022 and 2021.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the

near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Fees paid by the Plan for professional services rendered by parties-in-interest during 2022 were \$93,950 before the effect of revenue sharing amounts of \$64,089. Other administrative expenses of the Plan are paid by the Company. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services. Certain investment fees are netted in the net appreciation in fair value of investments.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Revenue Sharing

The Plan recognizes the income from revenue-sharing agreements when received. Amounts received are utilized to pay qualified plan expenses. Revenue sharing activity for the year ended December 31, 2022, is as follows:

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The fair value of registered investment companies and the self-directed brokerage account is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1). This valuation method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7: Income Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype profit sharing plan and trust sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency, and an opinion letter dated October 6, 2020, has been obtained from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Note 8: Excess Contributions

For the year ended December 31, 2022, the Plan failed certain nondiscrimination provisions resulting in excess contributions due to participants. For the year ended December 31, 2022, refunds of \$59,286 were due to certain participants to return to them excess deferral contributions in order to satisfy the relevant nondiscrimination provisions of the Plan. The amounts due at December 31, 2022, were refunded to affected participants during 2023.

Note 10: Subsequent Events

Effective January 3, 2023, the Munch’s Supply Company, LLC 401(k) Profit Sharing Plan was merged into the Marcone Appliance, Inc. 401(k) Plan at Principal Financial Group. In preparation for the merger out, substantially all assets of the Plan were liquidated and held in cash at year end.
