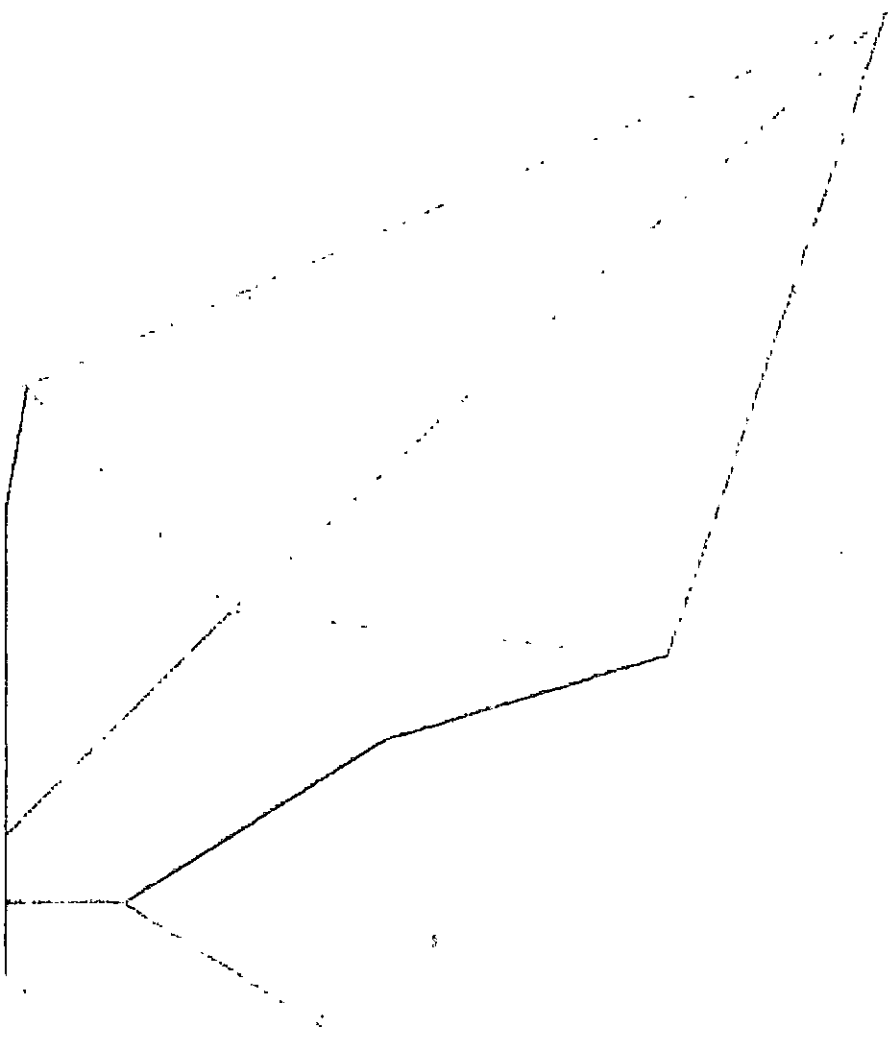

Retirement and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 14, 2022 and December 31, 2021, the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 14, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Trudell Holdings, Inc. Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1: Description of Plan

The following description of the Trudell Holdings, Inc. Retirement and Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

During 2022, Trudell Holdings, Inc., the plan sponsor, underwent a change in control. As a result of this transaction, Trudell Holdings, Inc.'s name changed to Trudell Intermediate Holdings, LLC. Trudell Holdings, Inc. and Trudell Intermediate Holdings, LLC are collectively referred to as the "Company" throughout the accompanying financial statements.

#### General

The Plan is a defined contribution plan covering eligible classes of employees of the Company who meet certain eligibility requirements. Nonseasonal employees are eligible to make deferral contributions and receive Company discretionary matching contributions after completing three months of service and attaining age 18. Seasonal employees are eligible to make deferral contributions and receive Company discretionary matching contributions upon attaining age 21 and completing at least 1,000 hours of service during an eligibility computation period. All employees eligible to make deferral contributions and receive Company discretionary matching contributions are also eligible to receive Company discretionary profit sharing contributions if they have worked at least 1,000 hours during the plan year and are employed as of the last day of the plan year. The Plan allows entry on the first of every month after eligibility requirements are met.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered at the direction of the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Plan Merger

Effective December 14, 2022, the Plan was merged into the Cox Enterprises, Inc. 401(K) Plan, with plan assets being liquidated on that date. The assets of the Plan transferred to the Cox Enterprises, Inc. 401(K) Plan totaled \$20,304,359, including \$321,733 of notes receivable from participants. Participant's vesting percentages were not changed with the merger.

On the date the notes receivable from participants transferred to the Cox Enterprises, Inc. 401(K) Plan, interest rates on existing notes ranged from 4.75% to 7.50%.

### Note 1: Description of Plan (Continued)

#### Contributions

Each year, participants may contribute to the Plan up to 100% of eligible compensation, as defined in the plan document, on a pretax or Roth basis, subject to limits established by the Internal Revenue Service (IRS). The Plan includes an auto-enrollment provision whereby all newly eligible nonseasonal employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Participants automatically enrolled in the Plan have their pretax deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also permits participants to roll over distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may provide a discretionary matching contribution based on a percentage of a participant's contribution to the Plan. For 2022, the Company made discretionary matching contributions of 50% of the first 6% of participants' elective deferral contributions (including catch-up contributions). Rollover contributions are not matched. The Company may also make a discretionary profit sharing contribution at the end of each plan year that is allocated to participants based on each participant's eligible compensation as a percentage of total eligible compensation for the plan year. No discretionary profit sharing contributions were made in 2022.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and charged with an allocation of expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. Participants vest at the rate of 10% per year for the first two years of service and 20% per year thereafter, becoming fully vested after six years of service.

### **Note 1: Description of Plan (Continued)**

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one note outstanding at any time. Note terms range from one to five years unless the proceeds of the note are used for the purchase of a principal residence, in which case the note term shall not exceed 10 years. The notes are secured by the balance in the participant's account and bear interest at a rate charged for similar notes by lending institutions. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Plan benefits are available upon retirement, death, disability, or termination of employment with vested interests. Benefits are paid either as a lump sum distribution, a partial distribution, or installments. In addition, hardship distributions out of the participant's deferral contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2 as well as distributions from a participant's rollover account at any time.

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. At December 31, 2021, forfeited nonvested accounts totaled \$695. These accounts are used to reduce Company contributions or to pay expenses of the Plan, at the discretion of the Company. For the period from January 1, 2022 to December 14, 2022, forfeitures of \$7,154 were used to pay Plan expenses and \$23,211 were used to reduce Company contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 14, 2022 and December 31, 2021. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses and Investment Management Fees**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment loss. Certain fees incurred by the Plan for investment-related services are allocated proportionately to plan participants based on their respective account balances and are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable and benefit payments are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2023, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

There were no assets or liabilities to be measured at fair value at December 14, 2022, due to the plan merger discussed in Note 1, which was effective December 14, 2022.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Common/collective trust fund:* This is a stable value fund that is composed primarily of fully-benefit-responsive investment contracts and valued at the net asset value ("NAV") of units of the common/collective trust fund. This NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust fund, the issuer reserves the right to temporarily delay the withdrawal from the trust for up to 12 months in order to ensure the liquidations will be carried out in an orderly business manner. There are no other significant restrictions as to the redemption of this fund or unfunded commitments as of December 31, 2021. This fund is able to be redeemed by participants with written notice on a daily basis.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### **Note 4: Information Prepared and Certified by Trustees**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments at fair value and notes receivable from participants held at December 14, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022 to December 14, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Great-West Trust Company, LLC (along with Great-West) and Fidelity Management Trust Company (Fidelity), the trustees of the Plan.

### **Note 5: Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity, a trustee of the Plan and, therefore, transactions with Fidelity qualify as party-in-interest transactions. Fees paid directly by the Plan to Fidelity for administrative services amounted to \$31,915 for the period from January 1, 2022 to December 14, 2022. Certain fees incurred by the Plan for investment-related services are included in net depreciation in fair value of investments, as they are paid to Fidelity through revenue sharing rather than a direct payment.

Sage View Advisory Group, LLC (Sage View) is the investment advisor for the Plan and, therefore, fees paid to Sage View also qualify as party-in-interest transactions. Fees paid directly by the Plan to Sage View for investment management services amounted to \$37,993 for the period from January 1, 2022 to December 14, 2022.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Tax Status**

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan document has been amended since receiving the notification letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
