We have performed audits of the accompanying financial statements of Viverant PT, LLC 401(k) Plan, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 28, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period/year then ended, and the related notes to the financial statements.

Our opinion is not modified with respect to that matter.

**Note 1 DESCRIPTION OF THE PLAN**

The following description of Viverant PT, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all employees of Viverant PT, LLC (the Company) who have completed 30 days of service and are age 21 or older. The Plan excludes employees covered by collective bargaining agreements and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2022, the board of Viverant PT, LLC approved a resolution to terminate the Plan. See further discussion in Note 6.

**CONTRIBUTIONS**

Each year, participants may contribute up to 100 percent of their eligible annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may elect to make discretionary matching contributions. The Company made no discretionary matching contributions in 2023 and 2022. Contributions are subject to certain IRS limitations.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions is based on years of continuous service. A participant is 100 percent vested in discretionary matching contributions after 6 years of credited service. Effective January 15, 2023, the accounts of all participants became 100 percent vested.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Loans shall bear interest at the current prime rate, plus 2 percent. The term of the loan cannot exceed five years unless the loan is for the purchase of the participant's primary residence. Principal and interest are paid ratably through payroll deductions.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum or partial payment distribution. If a participant terminates employment with a participant account balance between \$1,000 and \$5,000, and consent or direction is not received, the balance will be rolled to an IRA selected by the administrator. If a participant terminates employment with an account balance no greater than \$1,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Active participants may withdraw their employee contributions under the hardship provision as defined by the Plan. In-service distributions are allowed for participants who are age 59½ or older. Distributions of the participant's account balances due to the Plan's termination were made in lump sum payments on March 28, 2023.

**FORFEITURES**

At December 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$5,288 respectively. These accounts will be used to reduce future Company contributions, additional Company contributions or to pay Plan administrative expenses. In 2023, \$3,402 of forfeited nonvested accounts were distributed to plan participants and \$1,896 was used to reduce administrative fees.

**Note 2 SUMMARY OF ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared on the liquidation basis of accounting as of March 28, 2023 and December 31, 2022.

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes, therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 28, 2023 and December 31, 2022. Delinquent participant loans are recorded as a benefit payment based on the terms of the Plan agreement.

#### PAYMENT OF BENEFITS

Benefits are recorded when paid.

#### ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation/depreciation of fair value of investments.

#### SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 28, 2023, the date the financial statements were available to be issued.

### **Note 3 CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at March 28, 2023 and December 31, 2022 and net appreciation/depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period/year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America & Great-West Life & Annuity Insurance Company (the asset custodians of the Plan).

### **Note 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities that the Plan can access at the measurement date.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Mutual funds:* Valued at quoted prices in active markets.

**Note 5 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Annuity Insurance Company of America & Great-West Life & Annuity Insurance Company. Empower Annuity Insurance Company of America & Great-West Life & Annuity Insurance Company are the asset custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management services are included in net appreciation/depreciation in fair value of investments. Certain other expenses related to the Plan's operations are paid directly by the Company. Notes receivable from participants and transactions with the Company also qualify as party-in-interest transactions. Fees paid by the Plan was \$25,376 for the period ended March 28, 2023 and \$31,313 for the year ended December 31, 2022.

**Note 6 PLAN TERMINATION**

On January 9, 2023, Plan participants were notified that the Plan would be terminated effective January 15, 2023 due to the termination of the Plan. All participants became fully vested upon termination. Final plan assets were distributed March 28, 2023.

**Note 7 TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
