## INDEPENDENT AUDITORS' REPORT

To the Administration of  
St. Martin's in the Pines Tax Deferred Annuity Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of St. Martin's in the Pines Tax Deferred Annuity Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of St. Martin's in the Pines Tax Deferred Annuity Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of the year ended December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of St. Martin's in the Pines Tax Deferred Annuity Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about St. Martin's in the Pines Tax Deferred Annuity Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

## **St. Martin's in the Pines Tax Deferred Annuity Retirement Plan Notes to Financial Statements**

### **Note 1: DESCRIPTION OF PLAN**

The following description of the St. Martin's in the Pines Tax Deferred Annuity Retirement Plan (the "Plan") provides only general information. Refer to the Plan documents for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan established under the provisions of Section 401 of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 403(b) of the IRC. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan covering all full-time employees of the Episcopal Foundation of Jefferson County (the "Company", "Sponsor", "Employer", or "Plan Administrator").

The Plan's Trustee and Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Trustees. Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by American United Life Insurance Company (AUL), the custodian and qualified instruction for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by management, and provides certain recordkeeping services. Martin, Martin, Randall & Associates, Inc. acts as the third-party consultant for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

The Plan covers substantially all full-time employees of the Plan Sponsor who are eighteen and older, excluding non-resident aliens who have no earned income from sources within the United States, independent contractors and illegal aliens. The employees join the Plan as an active participant on the day in which they become an employee. The participants' agreement to start or change deferrals may only be effective on the first day of the pay period following the entry date or the first day of January, April, July or October.

## St. Martin's in the Pines Tax Deferred Annuity Retirement Plan Notes to Financial Statements

### Note 1: DESCRIPTION OF PLAN (Continued)

#### **Contributions**

Each year, participants may defer a percentage of pretax annual compensation up to a maximum permissible pursuant to the Internal Revenue Code (\$20,500 for 2022 and \$19,500 for 2021), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (up to \$6,500 in 2022). A special catch-up election applies for certain long-term employees who have completed at least 15 years of service with the same eligible 403(b) employer (up to \$3,000). Both catch up provisions may apply for an employee over the age of 50 and eligible for the 15-year service catch up contribution rule. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, for each participant who made contributions during the plan year, the employer will make a matching contribution equal to the participant's deferral, not to exceed 4% of total compensation. Additional amounts may be contributed at the option of the Sponsor's board of directors.

During the year ended December 31, 2022, the Company contributed \$123,356 in employer matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon. A participant's account becomes fully vested upon the participant's death, total disability, or attaining normal retirement age. Vesting in the Employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is vested in these contributions as follows:

### **Note 1: DESCRIPTION OF PLAN (Continued)**

#### ***Notes Receivable from Participants***

Participant loans are not allowed under the Plan provisions.

#### ***Receivables***

Contributions receivable include those pursuant to formal commitments based on the Plan's adoption agreement. Evidence that a formal commitment existed was based on criteria that (a) the contribution is based on participant compensation that existed for the current plan year and (b) the plan terms require a contribution to be made for the current plan year.

#### ***Benefit Payments***

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or one of the annuity options offered by the Plan. Participants may elect any optional form of annuity that is offered at the time of purchase. Available annuity options always include life annuity and survivorship annuity. The minimum amount which Participants may apply to purchase is \$10,000.

#### ***Forfeitures***

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Nonvested forfeited matching contributions may first be used to pay plan expenses, with remaining forfeitures used to offset employer's matching contributions. There were no amounts forfeited in 2022 and \$1 in earnings during 2022. This resulted in an accumulated forfeitures ending balance of \$32 and \$31 at December 31, 2022 and 2021, respectively.

#### ***Hardship Withdrawals***

As permitted by the IRC, and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

#### ***Plan Amendments***

There were no significant Plan amendments during the year.

#### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

##### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV.

The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Payments of Benefits***

Distributions to participants are recorded when paid.

##### ***Excess Contribution Payable***

At December 31, 2021, amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants during 2022. There are no excess contributions payable as of December 31, 2022.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances. During the year ended December 31, 2022, expenses of \$8,398 were paid by the Plan and allocated to participant accounts.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 3, 2023, and determined there were no events that occurred that require disclosure. No events occurring after this date have been evaluation for inclusion in these financial statements.

### **Note 3: INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by the qualified institution:

- a) Total investments, at fair value, included in the Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021.
- b) Investment depreciation information included in the Statement of Changes in Net Assets Available for Benefits, for the year ended December 31, 2022.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All information included in the supplemental schedule, the Schedule of Assets (Held at End of Year) as of December 31, 2022.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Pooled Separate Accounts:* Assets of a pooled separate account are pooled with funds of other investors and invested in securities, collective trusts, and mutual funds. When discussing the value of a separate account, it will be discussed as a unit value or price per unit. While the separate account's unit value is affected by the underlying mutual fund's fair value, its unit value will differ from the underlying mutual fund's fair value because of one or more of the following factors: initial value assignment, dividends and capital gains, and charges. The separate accounts offered as investments in the retirement plan are available only to employer-sponsored retirement plan investors. Because the separate accounts are not available as publicly traded funds, the performance and unit values are not published. Due to the factors noted, the pooled separate accounts will be valued as net asset value (NAV) as a practical expedient to fair value and are exempt from classification within the fair value hierarchy.

*Stable Value Funds:* The stable value funds are measured at net asset value under the practical expedient. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The stable value fund's investment choices may be comprised of or may invest indirectly in annuity or investment contracts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### **Note 5: TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

During the years ended December 31, 2022 and 2021, American United Life Insurance Company was the custodian for the Plan and Martin, Martin, Randall & Associates, Inc. was the third-party consultant for the Plan. The custodian of the Plan provides investment services to the Plan and also manages and invests contributions and other cash received as directed, records interest and dividend income, and makes distributions to participants. Investments of the Plan were invested in pooled separate accounts and two stable value funds of the custodian at December 31, 2022 and 2021.

In general, the administrative expenses for the Plan are paid from the Plan's assets. From time to time certain expenses of the Plan, including legal and accounting fees, are paid by the Plan Sponsor. In addition, certain services to the Plan by the Plan Sponsor were performed at no charge.

### **Note 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
