Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Metal-Matic, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Metal-Matic, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on February 1, 1997 by Metal-Matic, LLC (the Employer) and is a defined contribution plan. The Plan was last restated effective July 31, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees not covered by a collective bargaining agreement and who are not covered by the Metal-Matic, Inc. Salaried Employee Profit Sharing Plan, are generally eligible to participate in the Plan. Employees become eligible on the first day of the month immediately following or coinciding with the day they attain the age of 18, and have worked for three consecutive months. Employees become eligible for Employer discretionary contributions on the first day of the first or seventh month of the Plan year following or coinciding with the day they attain the age of 18, and have worked 12 consecutive months.

Contributions

Participants may contribute up to 100% of their eligible compensation, as defined by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. The Employer makes discretionary profit sharing contributions for participants that have worked 1,000 or more hours during the Plan year and are employed on the last day of the Plan year. Allocations of Employer contributions are based on participant compensation, as defined in the Plan. Allocations of Employer contributions are based on the classification of participants, as defined in the Plan. Employees may also contribute amounts representing distributions from other qualified plans. Participants over the age of 50 may make an additional catch up contribution. Contributions are subject to certain limitations.

Vesting

Participants are immediately fully vested in their deferral and rollover contributions plus actual earnings thereon. Participants vest in Employer contributions over a period of six years based on a graded vesting schedule. Participants also become 100% vested in Employer contributions upon retirement, death, or disability.

Forfeitures

Forfeited nonvested accounts totaled \$-0-, \$46,195, and \$49,361 at February 17, 2023, December 31, 2022 and 2021, respectively. Forfeited accounts can be reallocated to participants in the same manner as Employer contributions. Forfeitures of \$49,539 and \$18,303 were reallocated to participants during the years ended 2022 and 2021.

Participants' Accounts

Participants' accounts are credited with employee deferrals, Employer contributions, rollover contributions, and an allocation of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are valued daily.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in various investment options. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest equal to the prime rate plus 2%. All notes must be repaid within five years unless used to purchase a primary residence which must be repaid within 15 years. Principal and interest are paid ratably through payroll deductions.

Distributions

Under the terms of the Plan, participants may receive distributions in the form of a lump sum upon termination of employment, retirement, disability, or death. Automatic distributions greater than \$1,000 without the participants consent will be paid in a direct rollover to an Individual Retirement Account (IRA). The Plan also permits in-service distributions at age 62 for salary deferral contributions or vested Employer contributions only as defined in the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments in the collective funds are valued based on the net asset value (NAV) of units, which is based on the observable prices of underlying assets, held by the Plan at year-end. Investments in the mutual funds are valued at the NAV of shares held by the Plan at year-end. NAV is a readily determinable fair value and is the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value of Financial Instruments

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Fair Value of Financial Instruments (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at February 17, 2023, December 31, 2022 and 2021.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

Benefit Payments

Benefit payments are recorded upon distribution.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2023, the date the financial statements were available to be issued.

The Plan is placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 5 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. A portion of these fees were paid through a revenue sharing program and are shown net on the statements of changes in net assets available for benefits.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
