We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the Vox Network Solutions Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Vox Network Solutions Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Vox Network Solutions Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes at December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN:

The following description of the Vox Network Solutions Retirement Plan (the "Plan"), is provided for general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan providing retirement benefits for all employees of Vox Network Solutions ("the Company") who are eighteen years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and section 401(k) of the Internal Revenue Code. The Plan was established on September 1, 2006, restated on January 1, 2015, and most recently restated on January 1, 2021 to bring the Plan into compliance with the legislative and regulatory changes as set forth by the Internal Revenue Service 6 year pre-approved plan restatement cycle.

Amendments

On March 27, 2020 the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") was signed into law. Beginning in April 2020, as permitted by the CARES Act, the Plan opted in to implement the provision whereby required minimum distributions for calendar year 2020 were waived for retired and retirement age participants and beneficiaries unless the participant or beneficiary chose to receive the distribution.

The Plan has retroactively included this provision as an amendment to the Plan which was executed on August 5, 2022.

Effective June 1, 2022, the Plan became a frozen Plan to which no contributions may be made. As a frozen Plan, the employer will not make any contributions with respect to Plan compensation earned after such date and no participant will be permitted to make any contributions to the Plan after such date. In addition, no employee will become a participant after the Plan has been frozen. As of December 31, 2022, the Plan continued to remain frozen.

Contributions

Eligible employees of the Company may elect to contribute up to the applicable limits allowed under the Internal Revenue Code. Eligible employees may elect to defer up to 100% of eligible annual compensation, as defined in the Plan, on a pre-tax basis, an after-tax (Roth) basis, or a combination of both, not to exceed the maximum statutory amount. Participants who are age 50 or older can elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Each year, the Company may make a discretionary contribution to the Plan of an amount determined by the Plan Sponsor. No employer contributions were made during 2022.

NOTE 1 - DESCRIPTION OF PLAN (Continued):

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of plan earnings or losses. In addition, administrative expenses are charged to each participant's account. Allocations of Plan earnings and losses are credited or charged to participant accounts based on individual participant investment choices. All contributions/investments are participant directed. Participants are able to direct the investment of their account into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Discretionary contributions made by the Company are vested at 20% per year over five years. A participant is 100% vested after six years of credited services, after reaching normal retirement age, or upon death or disability.

Forfeitures

Forfeited amounts of unvested Company discretionary contributions from terminated participant accounts totaled \$793 and \$782 at December 31, 2022 and 2021, respectively. Amounts accumulated in the forfeiture accounts can be used to reduce future Company discretionary contributions and administrative fees. Forfeitures were not used to reduce Company discretionary contributions and administrative fees during the year ended December 31, 2022.

Benefits

On termination of service due to death, disability or retirement, a participant (or participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various options as defined in the Plan. Similar options are available upon termination of employment. The Plan permits a hardship distribution to a participant prior to and after separation from service in accordance with the Plan's hardship policies.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate based on the rates available for similar loans from commercial lending institutions. The outstanding notes receivable from participants at December 31, 2022 have interest rates ranging from 4.25% to 6.00%. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants in the financial statements are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as other administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated its December 31, 2022 financial statements for subsequent events through October 9, 2023, the date that these statements were available to be issued. Vox Network Solutions was acquired by Waterfield Technologies in May 2022. Beginning in January 2023, the assets of the Vox Network Solutions Retirement Plan are being transferred to the Waterfield retirement plan.

NOTE 3 - FAIR VALUE MEASUREMENTS:

Accounting principles recognized in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are thus assigned input level 1.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued):

The methods described above may produce a fair value calculation that may or may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - VOYA FIXED ACCOUNT:

The Plan maintains an investment contract as part of the Voya Fixed Account that meets the criteria to be considered fully benefit-responsive and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Voya maintains the contributions in a general account. Contract values, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of Voya or otherwise. The Plan is credited with an annual interest rate of no less than 1% for as long as the contract remains in force. Each calendar year, Voya will set a floor interest rate which will be declared in writing, to the contract holder prior to its effective date. As of December 31, 2022, the current rate was 1.5%.

NOTE 4 - VOYA FIXED ACCOUNT (Continued):

Voya may terminate the contract after the completion of five contract years by providing the Plan a 90 day written notice to pay out the full value without fees, charges, or Market Value Adjustment ("MVA").

Certain events may limit the ability of the Plan to transact at contract value with Voya. No surrender charge is assessed against contract withdrawals taken for reasons of participant retirement, severance from employment, death, disability, hardship, loan or in-service withdrawals after age 59 1/2. There are restrictions on transfers to and from the Voya Fixed Account and a positive or negative MVA may apply if the contract is terminated by either Voya or the Plan sponsor. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

NOTE 5 - SUMMARY OF INFORMATION CERTIFIED BY THE TRUSTEE - UNAUDITED:

The Plan's investments are held and administered by Voya Retirement Insurance and Annuity Company, as trustee. The trustee of the Plan has provided a certification that the following information, which is contained in or used to develop the accompanying financial statements, is complete and accurate:

Investments as of December 31, 2022 and 2021.

Investment income for the year ended December 31, 2022.

Schedule of Assets Held for Investment Purposes as of December 31, 2022.

NOTE 6 - TAX STATUS:

The Internal Revenue Service has determined and informed the Company that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the original determination, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES:

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS:

Plan investments are managed by the custodian and are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions set forth in ERISA and the Internal Revenue Code. In the event of Plan termination, participants will become 100% vested in any employer contributions that have been allocated to their accounts and the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.
