For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information. In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Plan Description**

The following description of CreativeLive, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan established by CreativeLive, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC). All employees become eligible to participate in the deferral and matching provisions of the Plan upon commencing employment and attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Employees may elect to defer up to 100% of their compensation as pre-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

The Company may make discretionary employer matching contributions. For the year ended December 31, 2022, the Company elected to match 50% of a participant’s elective deferrals up to 6% of eligible compensation. The Company may also make discretionary profit sharing contributions. Participants must be employed on the last day of the plan year to be eligible to receive discretionary profit sharing contributions. There were no profit sharing contributions made for the year ended December 31, 2022.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts** - Each participant’s account is credited with an allocation of (a) Company contributions, if any; (b) deferral contributions; and (c) plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company’s matching and profit sharing contributions is based on years of continuous service as follows:

**Forfeitures** - Forfeitures may be used to reduce future Company contributions to the Plan. The Plan used \$0 in forfeitures to offset employer matching contributions for the year ended December 31, 2022. At December 31, 2022 and 2021, unallocated forfeitures were not significant to overall plan balances.

#### Note 1 - Continued

**Payment of Benefits** - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan does not allow for hardship withdrawals.

**Notes Receivable From Participants** - A participant may borrow the lesser of \$50,000 or 50% of his or her vested balance, with a minimum loan of \$1,000. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The interest rate is set at the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Transaction based fees for loans and distributions are charged directly to participant accounts. The Company may elect to pay other expenses related to the Plan's administration.

**Subsequent Events** - The Plan's management has evaluated subsequent events through October 6, 2023, the date on which the Plan's financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds and Money Market Fund - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Note 4 - Certified Investments**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2022 and 2021, and investment income or loss for the year ended December 31, 2022, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, the recordkeeper of the Plan, as an agent for Ascensus Trust Company. Ascensus Trust Company has authorized Ascensus to act as its agent for this purpose pursuant to a written agreement between the two parties.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### **Note 5 - Party-in-Interest Transactions**

Plan investments include shares of mutual funds managed by Vanguard. Vanguard provides recordkeeping and administrative services to the Plan and has retained Ascensus as a subcontractor to provide certain recordkeeping and administrative services on its behalf. Therefore, Vanguard is considered a party-in-interest and transactions with the Plan's investments managed by Vanguard and fees paid from the Plan to Vanguard qualify as party-in-interest transactions which are exempt from prohibited transaction rules. The Plan also issues loans to participants, which are party-in-interest transactions.

#### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### **Note 7 - Tax Status**

The Company adopted a prototype plan document that received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and Uncertainties**

The Plan provides for various investment fund options, which in turn invest in a combination of investment securities such as stocks, bonds, and others. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Delinquent Contributions**

The Company determined there were instances during 2022 in which participant deferral contributions and loan repayments were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$16,275 of deferral contributions and loan repayments were identified as delinquent. The Company is currently working to calculate and remit lost earnings associated with these delinquent deposits.
