NOTE 1 - DESCRIPTION OF PLAN

The following description of the AMLI Residential Properties 401(k) Plan (the "Plan") is provided for general information purposes. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of AMLI Residential Properties, L.P., and affiliates in which AMLI Residential Properties, L.P. owns a majority of the economic values (collectively referred to as the Company) who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan allows for both employee and employer contributions. All employees may elect to defer up to 100% of their compensation, subject to various limits established for tax-deferred contributions under the Internal Revenue Code (IRC). The Company's matching contribution is equal to 50% of the participant's deferrals up to maximum of \$3,000. The plan also has an Auto Enrollment and Auto Escalation provision. Participants are auto-enrolled into the Plan at a deferral percentage of 5% and are auto-escalated by 1% every year up to 8%.

Investment Options: Participants may invest in one or more investment funds offered by the plan. Each of the funds represents a mix of various investments. The investment mix chosen by the participant will apply to employee and Company matching contributions.

Participant Accounts: Each participant's account is credited with (a) the participant's contribution, (b) each participant's portion of the Company's contribution, and (c) an allocation of the Plan's earnings or losses based upon each participant's account balance. Forfeitures arising from the termination of participants who are not fully vested at the time of their termination are used to reduce employer contributions. The forfeiture amounts used to reduce employer contributions were approximately \$177,000 in 2022.

Vesting and Forfeited Accounts: Participants are immediately vested in their voluntary contributions and earnings thereon. Participants fully vest in their employer matching and discretionary contribution after three years of service, as defined by the Plan. At December 31, 2022 forfeited non-vested accounts totaled \$207,571. These accounts are to be used to reduce future employer contributions.

Notes Receivable from Participants: The Plan allows for participants to borrow up to 50% of their vested account balance subject to a statutory maximum. Loan terms require periodic payments through payroll deductions over a reasonable period of time not to exceed five years except for those situations specifically stated by the Plan. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 8.00%. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Administrative Expenses: The Plan pays certain Plan administrative expenses, plan recordkeeping and trustee fees including expenses associated with the annual audit and employee education expense. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accounting principles and procedures followed by the Plan conform to accounting principles generally accepted in the United States of America. The financial statements of the Plan are prepared under the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for investment options in various mutual funds and certain other investments. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 9, 2023, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompany financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation/depreciation of fair value of investments interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as completed and accurate by Newport Trust Company from January 1, 2022 through February 28, 2022 and Empower Annuity Insurance Company of America and Empower Trust Company from March 1, 2022 through December 31, 2022, LLC (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in the principal or most advantageous market for an asset or liability in an orderly transaction between market participants at the measurement date. Fair value is based on the assumptions that management believes market participants would use when pricing an asset or liability. Fair value measurement and disclosure guidance established a three-level fair value hierarchy that prioritizes the use of inputs used in valuation methodologies. The three-level fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are quoted prices, unadjusted, for identical assets or liabilities in active markets. A quoted price in an active market provides the most reliable evidence of fair value and shall be used to measure fair value whenever available. A contractually binding sales price also provides reliable evidence of fair value.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; or inputs that utilize model-based techniques for which all significant assumptions are observable in the market.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement; utilize model –based techniques for which significant assumptions are not observable in the market; or require significant management judgment or estimation, some of which may be internally developed.

In determining fair value measurements, management assesses whether the volume and level of activity for an asset or liability have significantly decreased. In such instances, management determines whether recent quoted prices are associated with illiquid or inactive markets. If management concludes that quoted prices are associated with illiquid or inactive markets, adjustments to the quoted prices may be necessary or management may conclude that a change in valuation technique or the use of multiple valuation techniques may be appropriate to estimate an asset or liability's fair value.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: The fair values of participation units in the collective trust fund are based upon the net asset values of such fund, after adjustments to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation techniques and inputs are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Internal Revenue Service ("IRS") issued an opinion letter dated March 31, 2014, indicating that the volume submitter plan document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended from the original volume submitter document, plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 5 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST AND RELATED PARTIES

Parties in interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. ERISA requires the disclosure of party-in-interest transactions. The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

Empower Trust Company, LLC, is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain Plan investments are managed by Empower Trust Company, LLC, the trustee of the Plan. Any purchases and sales of investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transaction under ERISA. Notes receivable from participants amounted to \$1,080,115 and \$1,022,548 at December 31, 2022 and 2021, respectively. Notes receivable from participants also qualify as party-in-interest transactions.
