INDEPENDENT AUDITORS' REPORT

To the Participants of
Robert W. Sullivan, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Robert W. Sullivan, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Robert W. Sullivan, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2022 AND 2021

1. DESCRIPTION OF PLAN

The following description of the Robert W. Sullivan, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Robert W. Sullivan, Inc. (the Company) for the benefit of its eligible employees and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan adopted The Angell Pension Group Inc.'s Volume Submitter Profit Sharing Plan. Voya Retirement Insurance and Annuity Company (Voya) serves as Custodian and record keeper. The Angell Pension Group, Inc. provides third-party administrative services. The Company is the Plan Administrator and a director of the Company serves as Trustee of the Plan.

Participation

The Plan includes all employees of the Company who have attained age twenty-one. Eligible employees electing to be participants contribute to the Plan through payroll deductions at a specified percentage of their base compensation subject to limitations established by the Internal Revenue Code. If it is determined prior to the end of the plan year that the Plan may not satisfy the Actual Deferral Percentage Test for the plan year, the employer may require that the amount of the elective deferral contribution being allocated to the accounts of the highly compensated employees be reduced to the extent necessary to prevent excess contributions from being made to the Plan. Participants direct their contribution into various investment options offered by the Plan.

The Plan permits catch-up contributions for eligible participants who are 50 years or older by the end of the calendar year and who are currently making deferral contributions.

The Plan adopted a qualified after-tax Roth contribution program. Under the program, participants may elect to treat all or a portion of compensation that would otherwise be eligible to defer as pretax contributions, as designated after-tax Roth contributions.

1. DESCRIPTION OF PLAN (Continued)

Company Contributions

Company matching contributions to the Plan are based on participants' pretax contributions at a rate determined at the discretion of the Company. If it is determined prior to the end of the plan year that the Plan may not satisfy the Actual Contribution Percentage Test for the plan year, the employer may require that the amount of matching contributions being allocated to the accounts of highly compensated employees be reduced to the extent necessary to prevent excess aggregate contributions from being made to the Plan.

The Company matched 40% of the participants' contributions up to 6% of the base compensation, subject to the limitations of Section 401(k) of the Internal Revenue Code (IRC).

The Company may elect to make a non-elective profit sharing contribution to the Plan on a yearly basis at the discretion of the Company's Board of Directors. A participant is eligible to receive a profit sharing contribution if (a) at least 1,000 hours were worked during the Plan year and (b) participant was employed on the last day of the Plan year. The Company did not make a profit sharing contribution for the year ended December 31, 2022.

Participant Accounts

Each participant's account is credited with (a) the participant's elective deferral contribution, (b) an allocation of the individual Company's contribution, and (c) plan earnings based on the participant's account balances. Investment fund management fees are also charged and reduce participant investment return.

Other Income

In 2022, the Plan received other income from Voya of \$6,166 that was deposited into an account and held as an asset of the Plan. Other income is excess revenue generated by the Plan through fund revenue or plan fees.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions, plus investment earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service. Credited service is earned for each plan year in which the participant completes at least 1,000 hours of service.

In the event of death, retirement, or permanent disability, participants become 100% vested in all account balances.

Forfeitures

Upon termination, participant accounts which are less than 100% vested are forfeited. Forfeitures are used to either (a) restore participant forfeitures (in the event a terminated employee is rehired), (b) pay administrative expenses, or (c) reduce future employer contributions to the Plan.

1. DESCRIPTION OF PLAN (Continued)

Payment of Benefits

Benefits are payable to eligible participants upon disability, death, early retirement, normal retirement at or after age 65, or termination of employment.

Benefit payments are made in a single lump sum payment, except for required minimum distributions which must commence no later than the attainment of age 72 and are made in installments.

In-Service Withdrawals

Participants may withdraw funds upon certain hardship situations defined by the Plan or upon attainment of age 59-1/2.

Notes Receivable from Participants

Participants may borrow up to the lesser of (a) 50% of their vested account balance or (b) \$50,000. In addition, the amount available to the participant will be reduced by the greatest outstanding loan balance within the previous 12 months. The Plan permits a maximum of two participant loans at one time. Loans are due over a maximum of 5 years.

Administrative Expenses

Administrative expenses consist of (a) financial advisory fees paid from the other income held in an account within the Plan. In the event the monies held in the account is not sufficient to cover these fees, the Plan sponsor will absorb such fees, (b) audit fees paid by the forfeited amounts of nonvested accounts, and, (c) processing fees for distributions charged directly to individual participant accounts. For the year ended December 31, 2022, financial advisory fees were \$19,990 and administrative fees were \$400.

All other administrative costs, including legal, audit and tax preparation fees of the Plan are paid by the Company.

Plan Amendment and Termination

The Plan may be amended at any time by the Board of Directors of the Company, provided that no such amendment may deprive participants of their vested benefits.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate that Plan subject to the provisions of ERISA. In the event of termination of the Plan, the participant accounts would become fully vested and the assets would be distributed to participants in accordance with the terms set forth in the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events Review

In preparing its financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through October 3, 2023, the date the financial statements were available to be issued.

Investment Valuation, Methodologies and Income Recognition

The Plan's investment in pooled separate accounts are variable annuities valued at fair value using the net asset value (NAV) per share, as a practical expedient, as determined by the issuer based on current fair values of the underlying assets. The pooled separate accounts own and hold the underlying mutual funds which are valued daily at their NAV. The Plan holds "units of participation" in the pooled separate accounts. Shares are valued based on quoted market prices in an active market, which represent the net asset values of shares held by the Plan at year end. Unrealized appreciation or depreciation resulting from market changes is added to, or subtracted from, net assets.

Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investment in the Voya Fixed Account is a benefit responsive investment contract. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contributions to Voya under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk. There are no unfunded commitments. Under the terms of the contract, the Plan sponsor must provide a minimum of 90-day notice to Voya prior to redemption of the contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis as earned.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are loans valued at their unpaid principal balance plus any accrued but unpaid interest.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate and credit risks and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect the amounts reported in the financial statements.

Benefit Payments

Benefit payments are recorded when paid.

3. INCOME TAX STATUS

The Plan was adopted in the form of a Volume Submitter Plan sponsored by The Angell Pension Group, Inc. (see Note 1) that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified in accordance with applicable sections of the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. Subsequent to receiving the opinion letter, the Plan was amended. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting standards require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

4. RELATED PARTY TRANSACTIONS

The Plan's investments represent funds managed by Voya, Custodian of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

5. INFORMATION CERTIFIED BY TRUSTEE (Unaudited)

The following is a summary of the unaudited information included in the Plan's financial statements that was prepared by Voya Retirement Insurance and Annuity Company, Custodian of the Plan (see Note 1), and furnished to the Plan Administrator. 
