Independent Auditors' Report

To the Participants and Plan Administrator
American Student Assistance

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the American Student Assistance Employee 401(a) Retirement Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021 (in liquidation), the related statement of changes in net assets available for benefits for the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of Massachusetts Higher Education Assistance Corporation and Other Organizations d/b/a American Student Assistance, the Plan’s sponsor, voted on March 10, 2021 to terminate the Plan. In accordance with accounting principles generally accepted in the United States of America, the Plan uses the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the American Student Assistance Employee 401(a) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established on December 31, 1985 by the Massachusetts Higher Education Assistance Corporation and Other Organizations d/b/a American Student Assistance (“ASA” or the “Employer”) for the benefit of its employees and was amended and restated in its entirety on January 1, 2015. The Plan is a non-contributory defined contribution plan consisting of discretionary retirement incentive contributions made by ASA. All employees who have attained age 21 and have completed at least 1,000 hours of service are eligible to participate in the Plan as of the first day of January or July following the fulfillment of the eligibility requirements (the “Participants”). Independent contractors, temporary employees, employees covered by collective bargaining agreements and nonresident aliens are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). In accordance with the trust agreement, ASA administers the Plan. Substantially all investments are participant-directed.

Plan Termination and Liquidation

ASA has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. On March 10, 2021, ASA elected to terminate the Plan subject to ERISA provisions and the Plan was amended on May 28, 2021 to terminate the Plan effective June 30, 2021, and accordingly, liquidation was determined to be imminent at that time. The Plan was fully liquidated as of December 31, 2022. Accordingly, the Plan’s financial statements have been presented using the liquidation basis of accounting. The Plan received an IRS determination letter dated July 19, 2022 for the termination of the Plan.

Participant Rollover Contributions

Subject to approval by the Plan administrator and prior to the decision to terminate the Plan, participants were able to contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

Employer Retirement Incentive Contributions

Prior to the decision to terminate the Plan, ASA was permitted to make an annual discretionary contribution as of the last day of the Plan year. The contribution was allocated among the participants’ accounts who were employed at the end of the Plan year based on each participant’s eligible compensation, as defined by the Plan, as a percent of the total eligible compensation. Participants were able to make changes to their investment allocation at any time. There was no discretionary contribution for the year ended December 31, 2022.

Note 1 - Description of the Plan (Continued)

Participant Accounts

Each participant's account was credited with an allocation of the Employer's contribution, if any, Plan earnings, forfeitures of terminated participant's nonvested accounts, and charged with loan disbursement fees and an allocation of administration fees. Allocations were based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account.

Vesting

Prior to the decision to terminate the Plan, for any participant's employment that began after January 1, 2006, vesting began after completion of one year of service and were fully vested after five years of service. Due to the decision to terminate the Plan, all participant accounts became fully vested.

Forfeitures

Prior to the decision to terminate the Plan, upon termination of service, any nonvested portion of the account was forfeited as of the date on which the participant has 5 consecutive one-year breaks of service. Any amount forfeited by a Participant or former Participant was allocated among the Employer contribution accounts of the eligible employees as of the end of the Plan year in which the forfeiture becomes allocable in accordance with the Plan, and any such amount was offset against a portion of the Employer contributions determined to be contributed to the Plan for such Plan year. At December 31, 2021, there was \$5,447 of forfeitures available to reduce future Employer contributions and pay Plan expenses. During 2022, the entire amount of forfeitures was used for Plan expenses.

Payment of Benefits

Upon death, disability, retirement or termination, a participant could have elected to: (1) receive a lump-sum amount equal to the value of his or her account, (2) receive installment payments, or (3) roll the vested balance into an IRA or an Employer-sponsored retirement plan. Vested account balances that do not exceed \$5,000 will be automatically distributed in a lump-sum payment as soon as practicable following termination of employment.

In-Service Withdrawals

In-service withdrawals from a participant's account were permitted only due to financial hardship.

Notes Receivable from Participants

Prior to the decision to terminate the Plan and subject to approval of the Plan administrator, participants were able to borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years (or longer for the purchase of a principal residence). Participants could only have one loan outstanding at a time. The loans are secured by the balance in the Participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Upon termination of service, the entire outstanding principal and accrued interest was immediately due and payable. As part of the Plan termination, approximately \$24,443 of notes receivable from participants were transferred to ASA's 403(b) Plan.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid by ASA and not reported in the accompanying financial statements. Investment related expenses are included in net depreciation in fair value of investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

As management determined that liquidation of the Plan was imminent in March 2021, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis in 2021. This change in basis of accounting required the Plan to record assets and liabilities at expected cash proceeds upon liquidation, less any selling costs, which may be different from fair value. The Plan's assets did not have any substantial difference in value between these bases of accounting.

Investments, Investment Valuation and Income

Investments through December 31, 2021 were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid

Benefits were recorded when paid.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were charged to expenses as incurred. No allowance for credit losses has been recorded as of December 31, 2021. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could vary from the estimates that were used.

Subsequent Events

The Plan administrator has evaluated subsequent events through September 28, 2023, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during that evaluation.

Note 3 - Information Certified by Trustee and Custodian

Plan investments were held in mutual fund accounts by the Plan's trustee and custodian, Charles Schwab Trust Bank. The fair value of investments and notes receivable from participants as of December 31, 2021 and all investment transactions for the year ended December 31, 2022, including interest and dividends, and net depreciation in fair values are certified as complete and accurate and reported to the Plan by Charles Schwab Trust Bank.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level II - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III - Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The mutual fund investments held by the Plan as of December 31, 2021 amounted to \$13,143,838, and based on the fair value hierarchy, have been classified as Level I as of December 31, 2021.

Note 5 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict that could have an impact on investment securities.

Note 6 - Related-Party Transactions and Party-In-Interest Transactions

Plan investments included shares of mutual funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee and Milliman Benefits is the record keeper, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to Charles Schwab Trust Bank and Milliman Benefits totaled \$15,441 for the year ended December 31, 2022. Notes receivable from participants are also considered party-in-interest transactions. During the Plan year ended December 31, 2022, the Plan received revenue credits of \$1,363 from Charles Schwab Trust Bank which was utilized to pay Plan expenses during the year.

Note 7 - Tax Status

The Internal Revenue Service (“IRS”) has determined and informed ASA by a determination letter dated October 18, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan continues to qualify under Section 401(a), and the related trust continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
