Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AMMEGA 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1: Description of the Plan

The following description of AMMEGA 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Belting Holdings, Inc. (the “Company”) for the benefit of its employees age 18 or older with at least one month of service, except those who are covered by a collective bargaining agreement or leased employees.

On January 1, 2021, the Midwest Industrial Rubber, Inc. 401(k) Plan merged with the Megadyne America LLC 401(k) Profit Sharing Plan and the Ammeraal/Chemprene 401(k) Plan. The surviving plan name is the AMMEGA 401(k) Plan.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Empower Trust Company, LLC, formerly known as Great-West Company, LLC, serves as Plan trustee.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan has an automatic enrollment feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature increases by 1% each year on January 1, up to a maximum of 10%.

For the years ended December 31, 2022 and 2021, the Company contributed a safe harbor contribution equal to 100% of each participant’s elective deferrals not exceeding 1% of the participant’s compensation, plus 50% of each participant’s elective deferrals in excess of 1% but not in excess of 6% of the participant’s compensation.

Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available included various mutual funds and a common collective trust fund. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Interest on the loans is 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of their account. Partial distributions will be allowed only if the Participant is subject to lifetime required minimum distributions. Following severance from employment, the Plan will make a mandatory distribution of any account with a vested balance less than \$5,000. Balances less than \$1,000 are paid direct to the participant. Balances between \$1,000 and \$5,000 are paid to an IRA in the participants' name.

Vesting

Participants are immediately vested in their voluntary contributions, including Roth deferrals and catch-up contributions, as well as prior safe harbor contributions, plus earnings thereon. Effective January 1, 2021, the Plan was amended and vesting in the employer's contribution portion of their accounts plus earnings thereon is based a two-year cliff vesting schedule with the following exceptions.

For employees of the former Midwest Industrial Rubber, Inc. 401(k) Plan whose entry dates are on or after February 2, 2018, employer contributions are subject to a three-year graded vesting schedule. Employees of the former Midwest Industrial Rubber, Inc. 401(k) Plan whose entry dates are prior to February 2, 2018, are 100% vested in nonelective contributions at all times.

For employees of the former Megadyne America LLC 401(k) Profit Sharing Plan, prior nonelective contributions are subject to a six-year graded vesting schedule. Merging employer match balances in the Megadyne America LLC 401(k) Profit Sharing Plan made prior to January 1, 2021, will be 100% vested at all times.

For employees of the former Ammeraal/Chemprene 401(k) Plan, employer matching and nonelective contributions are subject to a three-year cliff vesting schedule. Prior employer matching and nonelective contributions for participants of the Ammeraal/Chemprene 401(k) Plan will be 100% vested at all times.

Any nonvested balance is forfeited upon termination of service. Forfeitures may be used to reduce Company contributions or pay Plan expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$204,442 and \$162,514, respectively. These accounts will be used to pay administrative expenses or reduce employer contributions. Also, in 2022 and 2021, \$72,899 and \$66,695 of forfeited nonvested accounts were used towards administrative expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan also holds an interest in a common collective trust fund, which is valued daily utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3: Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits and related disclosures at December 31, 2022 and 2021.
- Investment income (loss) and interest income from notes receivable from participants as shown in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2022 and 2021.
- Investment information and notes receivable from participants included in the accompanying Schedule of Assets (Held at End of Year) at December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets

- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. There were no Level 2 or 3 investments identified.

Note 5: Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

Certain Plan investments are managed by Great-West Trust Company, LLC. Great-West Trust Company, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Company provides certain administrative services at no cost to the Plan.

Note 6: Plan Amendments and Plan Transfers

On January 1, 2021, the Plan was amended and restated to merge the Megadyne America LLC 401(k) Profit Sharing Plan and the Ammeraal/Chemprene 401(k) Plans into the Midwest Industrial, Inc. 401(k) Plan. The surviving plan name is AMMEGA 401(k) Plan. Total plan assets transferred to the AMMEGA 401(k) Plan are \$52,992,169.

Note 7: Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
