INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the First Manhattan Co. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of First Manhattan Co. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control–related matters that we identified during the audit.

Other Matter

Notes to Financial Statements December 31, 2022 and 2021

NOTE A - DESCRIPTION OF THE PLAN

The following description of the First Manhattan Co. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

[1] General:

The Plan was established effective October 1, 1983. The Plan is a defined-contribution plan which covers all employees and Senior Managing Directors of First Manhattan Co. (the "Company" or "FMC"). Full-time employees and Senior Managing Directors are eligible to participate on the first calendar day of the month concurrent with or following the completion of six months of service. Part-time employees are eligible to participate in the Plan if they meet the eligibility criteria specified in the Plan documents, concurrent with or following the completion of twelve months of service. Employees and Senior Managing Directors receive credit for the first month of service if employed on the first business day of the month in which they were hired. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). These financial statements are prepared in conformity with U.S. generally accepted accounting principles.

The Company is the Plan sponsor and administrator. Fidelity Management Trust Company ("Fidelity") is the trustee and record-keeper of the Plan.

[2] Contributions:

Participants may contribute from 1% to 75% of pre-tax annual compensation, as defined by the Plan. Employee contributions are made through payroll deductions and Senior Managing Directors' contributions are made through monthly distributions. The contribution limit was \$20,500 in 2022. In addition, participants may contribute up to 75% of after-tax compensation, as defined by the Plan. The Plan also permits participants to make after-tax contributions. Participants 50 years of age or older by the close of the Plan year had the option of contributing an additional \$6,500 to the Plan in 2022. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for the Company to match 100% of an eligible employee's contributions up to 4% of the employee's annual compensation, not to exceed \$100,000. Additional discretionary matching contributions may be made at the option of the Company. In 2022, the Company's additional discretionary matching contributions were up to 8% of a participant's annual compensation up to \$100,000. To be eligible for discretionary and non-discretionary matching contributions, a participant must be employed on the last day of the Plan year. The Company also has an option to make a non-elective employer contribution for employees who have worked 60 days and were employed at the last day of the year. The Company did not make any such contributions in 2022.

Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an elective escalation feature whereby the deferral rate would increase each year by 1% up to a maximum of an incremental increase of 3%.

[2] Contributions: (continued)

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and non-elective employer contributions, (b) Plan earnings, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[3] Forfeitures:

Forfeited nonvested accounts may be used to reduce future Company contributions and pay Plan expenses. There were no nonvested forfeited accounts available at December 31, 2022 and 2021. There were \$65,752 of forfeitures used to offset the 2022 employer contribution and \$67,514 of forfeitures used to offset employer contribution in 2021. Additionally, at December 31, 2022 and 2021 there were unallocated balances of \$57,053 and \$114,431, respectively, which represent unvested balances for employees who have separated but have not yet had five consecutive one-year breaks in service. These unallocated balances will be used at the point in which they are forfeited.

[4] Notes receivable from participants and hardship withdrawals:

Upon application of any participant, the Plan may provide for a general purpose loan from a participant's salary reduction contribution account and vested matching contribution account. All loans during the previous twelve-month period are limited to the lesser of a maximum balance of \$50,000 or 50% of the participant's vested interest in his or her accrued benefits. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Loan terms range from one to five years; however, terms may exceed five years for loans, the proceeds of which are used for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 2%, as defined. Interest rates on outstanding loan balances range from 5.25% to 9.0% at December 31, 2022 and 2021, respectively. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[5] Vesting:

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and non-elective employer contribution portion of their accounts, plus actual earnings thereon, is as follows:

[6] Payment of benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments under a systematic withdrawal plan. Involuntary distributions of \$5,000 or less that are Eligible Rollover Distributions, as defined, will be made to terminated participants in a lump sum distribution.

[7] Termination of the Plan:

Although it has not expressed any intent to do so, the Company has the right under the Plan documents to discontinue all contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination or partial termination of the Plan, or upon the complete discontinuance of the Company's contributions to the Plan, the right of all affected participants to benefits accrued to the date of such termination or partial termination, to the extent then funded, shall be fully vested and non-forfeitable.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[3] Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

[4] Interest and dividends:

Dividend income is recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

[5] Payment of benefits:

Benefits are recorded when paid.

[6] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of all investments, related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, the statement of changes in net assets available for benefits for the year ended December 31, 2022 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2022.

NOTE D - MEASUREMENT OF INVESTMENTS AT FAIR VALUE

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

NOTE D - MEASUREMENT OF INVESTMENTS AT FAIR VALUE (CONTINUED)

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value:

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are classified as Level 1. The fair value of mutual funds at December 31, 2022 and 2021 was \$91,119,630 and \$110,132,093, respectively.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - TAX STATUS

As of October 14, 2019, the Plan has adopted a Volume Submitter Profit Sharing Plan with CODA sponsored by Fidelity Management & Research Company. On March 31, 2014, the Internal Revenue Service ("IRS") stated in an advisory letter that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

NOTE E - TAX STATUS (CONTINUED)

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual funds managed by Fidelity. Therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

Expenses incurred on behalf of individual participants and paid by the Plan to Fidelity were \$3,311 for the year ended December 31, 2022.

NOTE G - MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus are not separately identifiable as an expense.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2022 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2023, the date these financial statements were available for issuance. Effective on January 1, 2023, the Plan Sponsor effected an internal reorganization and changed its name to FMC Group Holdings LP. In addition, as a result of the Plan Sponsor reorganization, the Plan name was changed to First Manhattan 401k Plan. During the period January 1, 2023 through October 10, 2023, there were no additional subsequent events that have occurred that would require disclosure in the financial statements or accompanying notes.
