Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Evenflo Company, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A – DESCRIPTION OF PLAN

The following description of the Evenflo Company, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information. The Plan was effective July 1, 2000. In conjunction with the change in Trustee, noted below, the Plan was amended and restated effective January 19, 2022.

Plan Merger

On September 24, 2022, the Benefits Committee voted and approved to merge the Plan with the Evenflo Company, Inc. Savings Plus Plan, a related-party. The net assets of the Plan, totaling approximately \$7.2 million, were transferred out of the Plan on December 27, 2022. The final transfer of assets, totaling \$74, occurred on January 20, 2023. Each covered employee who was eligible to participate in the Plan immediately prior to the merger date was eligible to participate in the Evenflo Company, Inc. Savings Plus Plan as of the merger date.

General Information

The Plan is a defined contribution plan covering substantially all hourly employees of Evenflo Company, Inc. (the Company) who have 30 days of service and have attained age 21. Temporary employees must have one year of service or 1,000 hours of service. The Benefits Committee of the Company controls and manages the operation and administration of the Plan. Matrix Trust Company served as the trustee of the Plan until January 18, 2022, and effective January 19, 2022, Schwab Retirement Plan Services, Inc. began serving as the trustee of the Plan (collectively, the Trustees). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed into law. The CARES Act provided certain provisions, which, if adopted by the Plan, would provide plan participants with expanded distribution and loan opportunities. Plans were permitted to adopt these provisions immediately provided the plan document is retroactively amended on or before December 31, 2025. Plan management elected to adopt the following provisions:

On or after March 27, 2020, and before December 31, 2020, any qualified individual, as defined in the CARES Act, was permitted to request a distribution from his or her vested account in the Plan, up to a maximum of \$100,000. Active employees who receive a coronavirus-related distribution from the Plan (or from any other eligible retirement plan) may repay all or any portion of the distribution to the Plan within the three-year period beginning on the date after the distribution.

Qualified individuals with outstanding loans on or after March 27, 2020 were permitted to request that their loan payments be deferred through December 31, 2020. Where payments were deferred, the loan was re-amortized in January 2021 to reflect interest accrued during the delay, and payments recommenced for the remainder of the loan period, plus one year.

The normal loan limits were increased from \$50,000 to \$100,000, and from 50% to 100% of the vested account balance, for qualified individuals taking loans on or after March 27, 2020 and before September 23, 2020.

All required minimum distributions (RMD) for 2020 were waived.

Contributions

Each year, participants may contribute up to 75% of their pre-tax annual compensation, as defined in the plan document, subject to certain Internal Revenue Code (the Code) limitations. Plan provisions include automatic enrollment at 3%. The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan each pay period, which is not to exceed 3% of the employee base compensation. Effective January 19, 2022, there is an additional match on catch-up contributions. The Company's matching contributions for the year ended December 31, 2022, were \$204,671. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and plan earnings and forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed; however, the Benefits Committee of the Company has control over the investment offerings made available to plan participants.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. If a participant is employed on the last day of a plan year, then the participant becomes fully vested in the Company's matching contributions for that respective plan year and all previous plan years. A participant is 100% vested after three years of credited service. Additionally, upon retirement, death, or disability, a participant immediately becomes 100% vested.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

At December 31, 2022 and 2021, forfeited non-vested accounts were \$0 and \$6,783, respectively. These accounts are used to reduce future employer contributions or plan expenses. During the year ended December 31, 2022, employer contributions were reduced by \$4,866 from forfeited non-vested accounts.

Payment of Benefits

Upon retirement, death, or other interruption of continuous service, a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments. Upon termination, benefits relating to a participant's contributions and vested employer contributions are distributed.

Notes Receivable – Participant Loans

With exception of the CARES Act provisions noted within Note A, participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates equal to the Trustees' prime rate determined as of the time the application for the loan is made. The participant loans must be repaid over a period not to exceed five years, unless the purpose of the loan is to acquire, construct, or substantially rehabilitate a dwelling that is to be used as a principal residence for the participant, in which case the loan period may not exceed 15 years. Principal and interest is paid ratably through payroll deductions. As a result of the plan merger, previously noted, the balance of the outstanding loans, totaling \$284,558 at December 27, 2022, were transferred to the Evenflo Company, Inc. Savings Plus Plan, therefore, there were no outstanding loans as of December 31, 2022.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board's Accounting Standards Codification.

Contributions

Participant contributions are recognized when withheld. Employer matching contributions are recognized concurrently with participant contributions.

Payment of Benefits

Benefits are recorded when approved. There were no approved but unpaid benefits at December 31, 2022 or 2021.

Investment Valuation and Income Recognition

The Plan's participant-directed investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTE C – INVESTMENTS AND INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2022 and 2021, net depreciation in fair value of investments, and dividends and interest for the year ended December 31, 2022, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustees.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D – FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets of the Plan. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Stated at fair value as defined by observable quoted prices in active markets (Level 1).

NOTE D – FAIR VALUE MEASUREMENTS (CONTINUED)

Collective investment fund: Stated based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the Trustees, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The collective investment fund is a fully benefit responsive investment contract with the Trustees and plan contributions are maintained in a general account. The account is credited with earnings on the underlying investments. The objective of the fund is to maintain safety of principal while generating a level of income generally exceeding that of a money market fund. The fund seeks to maintain a stable \$1.00 net asset value, although this is not guaranteed.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. As noted in Note A, substantially all of the Plan's assets were merged into the Evenflo Company, Inc. Savings Plus Plan on December 27, 2022, with the final assets transferred on January 20, 2023, and the Plan was terminated.

NOTE F – PARTY-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of collective investment funds and registered investment companies managed by the Trustees and therefore, these transactions qualify as party-in-interest. However, they are exempt from the prohibited transactions rules under ERISA.

Certain administrative services are provided by the Company at no cost to the Plan. Administrative expenses paid by the Plan were \$48,530 for the year ended December 31, 2022.

NOTE G – INCOME TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (the IRS) dated September 21, 2020, stating that the form of the Plan is qualified under Section 401 of the Code, and therefore, the related trust is tax exempt. In accordance with Revenue Procedure 2002-6 and Announcement 2001-77, the plan sponsor has determined that it is eligible for, and has chosen to rely on, the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) of the Plan if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan has no uncertain tax positions that require adjustment to the financial statements.

NOTE G – INCOME TAX STATUS (CONTINUED)

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

NOTE I – SUBSEQUENT EVENTS

In connection with the preparation of the Plan's financial statements for the year ended December 31, 2022, events and transactions subsequent to December 31, 2022 through October 9, 2023 have been evaluated by the plan administrator for possible adjustment and/or disclosure. Except as disclosed in Notes A and E, no other subsequent events requiring financial statement adjustment and/or disclosure have been identified.
