## Independent Auditors' Report

To the Plan Administrator and Plan Custodians  
Haskell Lemon Construction Savings Incentive Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Haskell Lemon Construction Savings Incentive Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 6, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period of January 1, 2022 to June 6, 2022, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of June 6, 2022 and December 31, 2021, and for the period of January 1, 2022 to June 6, 2022, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

As discussed in Note G to the financial statements, on June 6, 2022, all Plan assets were transferred to another plan. In accordance with accounting principles generally accepted in the United States of America, the financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of the Haskell Lemon Construction Savings Incentive Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Employees of Haskell Lemon Construction Company and the related companies of General Materials, Inc., A&A Trucking, Inc. and Central Oklahoma Turf (collectively the "Plan Sponsor") are allowed to participate in the Plan. The Plan is a defined contribution 401(k) and profit-sharing plan with a cash or deferred arrangement covering all employees who have six months of service, as defined in the Plan agreement. The Plan was amended and restated effective December 1, 2019, via the adoption of the Minnesota Life Insurance Company Volume Submitter 401(k) Profit Sharing Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each participant can make pre-tax contributions up to the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$20,500 for 2022. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$6,500 to the Plan for 2022. The Plan also permits participants to make rollover contributions from other qualified plans.

During each Plan year, the Plan Sponsor may make a matching contribution to the participants' accounts. Although it is the intent of the Plan Sponsor to continue making such contributions, the Plan Sponsor is not required to do so. The Plan Sponsor has the right to revoke, suspend, or modify its obligation to make matching contributions upon giving proper notice to all participants at any time during the Plan year. During 2022, the Plan Sponsor matched 5% of the amount contributed by a participant.

In addition to the matching contributions, the Plan Sponsor may make a discretionary profit-sharing contribution that will be allocated using a uniform points allocation-based ratio. Participants receive two points for each year of service, determined in the same manner as the Plan Sponsor contributions vest to the participants. During the period of January 1, 2022 to June 6, 2022, the Plan Sponsor made profit-sharing contributions of \$149,800.

Participant Accounts and Investment Options: Participants direct the investment of their contributions into various mutual funds and a guaranteed investment contract fund offered by the Plan. Each participant's account is credited with the participant's contribution, an allocation of the Plan Sponsor's contributions and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participant contributions to the Plan and earnings thereon are fully vested at all times. Vesting of Plan Sponsor contributions is based upon the years of service with the Plan Sponsor as follows:

Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six years or more	100%

Forfeitures of nonvested employer contributions are used to pay expenses of the Plan. There was approximately \$1,300 of forfeitures incurred during the period of January 1, 2022 through June 6, 2022. The Plan held \$0 in forfeitures as of June 6, 2022 as the entire forfeiture account balance of approximately \$20,000 was transferred to the new plan. See Note G.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest or may rollover their vested account balance into an individual retirement account, individual retirement annuity or another employer's tax qualified plan. If the participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$5,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty.

Upon retirement at age 65, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance. All participants must begin receiving benefit payments upon reaching age 70 ½. Such benefits may be paid in a single lump sum or as an annuity, based on the terms defined in the Plan agreement.

Participants that are employed with the Plan Sponsor that have reached age 59 ½ may receive an in-service distribution of their account balance that is attributable to the participant's contributions to the Plan. Contributions from the Plan Sponsor are not eligible for an in-service distribution. In-service distributions are limited to one per year and must be for a minimum of \$1,000.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On June 6, 2022, due to the Company being acquired by another entity, all Plan assets were transferred to another plan. See Note G.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when paid.

Administrative Expenses: Certain administrative functions of the Plan are performed by employees of the Plan Sponsor. Neither the employees nor the Plan Sponsor receive any compensation from the Plan for these services. Certain administrative expenses of the Plan are paid by the Plan Sponsor. Account transaction costs are deducted from participant accounts. Administrative fees for services are first paid with available forfeitures, with any fees in excess of forfeitures paid from the assets of the funds and therefore reduce the overall return offered by the funds.

Income Tax Status: The Plan Administrator believes the Plan is designed and is currently operated in compliance with applicable requirements of the Internal Revenue Code and therefore is qualified and its related trust tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if an uncertain position more likely than not would fail to be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events: Subsequent events have been evaluated through October 3, 2023, which is the date the financial statements were available to be issued. There were no subsequent events requiring accrual or disclosure.

#### NOTE C--GUARANTEED INVESTMENT CONTRACT

At December 31, 2021, the Plan had a fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company ("Minnesota Life"). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### NOTE D--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### NOTE D--FAIR VALUE MEASUREMENTS--CONTINUED

The following is a description of the valuation methodologies used for assets measured at fair value:

*Guaranteed investment contract:* This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

*Pooled Separate Accounts - mutual funds:* Investments represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are investment vehicles valued using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The underlying investments consist of mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient are not required to be classified in the fair value hierarchy.

#### NOTE E--INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Minnesota Life, the custodian of the Plan for the period of January 1, 2022 through June 6, 2022 and for the year ended December 31, 2021, certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of June 6, 2022 and December 31, 2021.
- Investment income, as shown in the statement of changes in net assets available for benefits for the period of January 1, 2022 through June 6, 2022.

NOTE E--INFORMATION CERTIFIED BY THE CUSTODIAN--CONTINUED

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per the custodian's certified statements to the related information included in the financial statements.

NOTE F--TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments were managed by Minnesota Life, which also served as the Plan's custodian and, therefore, these transactions qualify as party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

NOTE G--TRANSFER OF PLAN ASSETS

In 2022, the Company and an unrelated company, Superior Bowen, were acquired by Legacy Infrastructure Group. As part of this acquisition, the Plan's assets of \$5,562,498 as of June 6, 2022 were transferred to the existing Superior Bowen 401(k) Plan. There was no Plan activity subsequent to June 6, 2022, and the Plan, though not formally terminated, ended on that date.

The late filing of the 5500 was a result of reorganization of the entities involved in addition to staff turnover. In June 2022, the assets of the 401k plan in question were transferred to a new plan. That new plan received an audit for 2022 that was originally planned to include the old plan (Haskell Lemon Construction Co. Savings Incentive Plan). The previous Controller was coordinating the audit, but left unexpectedly in June 2023. As a result, it was not communicated to the new Controller that a separate audit for the 5500 in question was required. In late August 2023, the new Controller took over responsibilities of coordinating an audit and contacted an external auditor immediately to complete any needed procedures for the Form 5500 being filed. From the time the new Controller was made aware of the issue to when an engagement letter was signed with a separate audit was one week (signed in early September 2023). The urgency to complete this audit was made a priority. We hope this will be taken into consideration.
