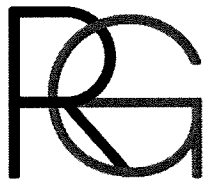

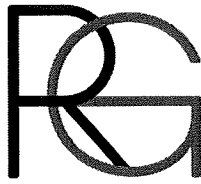

INDEPENDENT AUDITOR'S REPORT

To the CM3, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CM3, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 28, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended December 28, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CM3, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 28, 2022 and December 31, 2021, and for the period ended December 28, 2022, stating that the certified investment information as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of CM3, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financials statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CM3, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of CM3, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about CM3, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of plan

The following description of the CM3, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established by CM3, Inc. (the "Company") under the provision of Section 401(a) of the IRC, which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed three months of service, as defined, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Merger

During 2022, the owners of CM3, Inc. approved the merger of the Plan into the Pooled Employer Plan, LPE/CM3, Inc., (OpenPEP) effective December 28, 2022. As a result, all investments were transferred from the Plan into the OpenPEP on that date (see Note 9).

Contributions

Eligible employees may contribute up to 75 percent of their pretax annual compensation as defined by the Plan, subject to the IRC limits of \$20,500 and \$19,500 in 2022 and 2021, respectively. Participants who attain the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 25% of the first 6% of base compensation that a participant contributes to the plan. Participant contributions are remitted weekly and employer matching contributions are remitted monthly.

Participant accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions as well as allocations of plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Each participant's account is increased or decreased for its share of the change in the fair value of each fund in which it has invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer matching contributions and the earnings thereon is based on years of continuous service. A participant vests according to the following schedule:

Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six years	100%

Plan administration

John Hancock Life Insurance Company (U.S.A.) is the third-party administrator and recordkeeper of the Plan and is responsible for the custody and management of the Plan's assets.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan nor is the Company reimbursed for any related expenses incurred by it.

Payment of benefits

Upon termination of service, participants with a vested account balance in excess of \$5,000 may elect to defer distribution of their vested balance and remain in the Plan or elect to withdraw up to 100% of such balance. Vested participant balances less than \$5,000 will be distributed upon termination. In addition, a participant may elect to distribute all or a portion of vested account balances upon attainment of age 59 ½ or all or a portion of elective deferrals for financial hardship. A participant may elect to withdraw his or her rollover account at any time.

Forfeited accounts

Forfeitures may be used to reduce employer matching contributions or pay administrative fees. No forfeitures were used to reduce employer matching contributions during 2022 and 2021. Forfeitures of \$3,620 were used to pay administrative fees during 2022. No such fees were paid during 2021.

2. Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Plan did not hold any direct investments in fully benefit-responsive investment contracts as of December 28, 2022 and December 31, 2021.

As described in Note 1, all Plan assets were transferred to a pooled employer plan on December 28, 2022. Therefore, these financial statements reflect the financial position of the Plan as of December 28, 2022 and the Plan activity for the period then ended.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines investment valuation based on information provided by John Hancock Insurance Company (U.S.A.). See Note 4 for discussion of fair value measurements.

Due to a plan merger, all Plan assets were transferred to a pooled employer plan before the close of business on December 28, 2022. (See Note 1.)

Investment transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits. Other fees, including professional fees, are paid by the Company.

Payment of benefits

Benefits are recorded when paid.

Subsequent event evaluation

Management has evaluated events through September 27, 2023, which is the date the financial statements were available to be issued. No subsequent events were identified for recognition or disclosure at December 28, 2022.

3. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology are observable market based inputs or unobservable inputs that are corroborated by market data.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

At December 28, 2022 and December 31, 2021, the Plan's investments were held by John Hancock Insurance Company (U.S.A.), and related financial information was certified as complete and accurate (see Note 9). The following table sets forth by level, within the fair value hierarchy, the Plan's Investments at fair value as of December 28, 2022 and December 31, 2021:

4. Related-party transactions and party-in-interest transactions

At December 28, 2022 and December 31, 2021, Plan investments included mutual funds managed by John Hancock Life Insurance Company (U.S.A.). These transactions qualified as exempt party-in-interest transactions.

Administrative fees related to the third-party administrator and recordkeeper's administration of the Plan are paid by the Plan.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Tax status

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service (IRS) stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's income tax filings generally are subject to potential examination by various taxing authorities for three years from the date of filing. As such, the Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2018.

7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Information prepared and certified by the qualified institution

John Hancock Insurance Company (U.S.A.) provided certifications that apply to the investments on the Statements of Net Assets Available for Benefits and the investment income on the Statement of Changes in Net Assets Available for Benefits. John Hancock Insurance Company (U.S.A.) certified the financial information as complete and accurate in accordance with 29 CFR Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

9. Blackout period

Due to a plan merger, the Plan's assets were transferred to a pooled employer plan on December 28, 2022. A blackout period was initiated on December 19, 2022 to facilitate the merger. During the blackout period, employees were unable to direct or diversify their assets and CM3, Inc. (sponsor) was unable to remit participant and employer contributions. CM3, Inc. subsequently remitted these contributions to the pooled employer plan on January 4, 2023. These are included in contributions on the statement of changes in net assets available for benefits. (See Note 10.)
