### ***NOTE 1: Description of the Plan***

The following description of the Dondelinger Chevrolet and Cadillac, Inc. (“the Company”) 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants and other interested readers should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established by the Company to provide retirement benefits to substantially all employees of the Company and its affiliated companies, including Grand Rapids Automotive, Inc., Abra Auto Body & Glass, and DV Aviation, Inc. dba NorthPoint Aviation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has appointed John Hancock Life Insurance Company (USA) (“the Custodian”) as custodian of the Plan. The Custodian is responsible for holding the investment assets of the Plan and making distributions according to the Plan’s provisions. In addition, the Custodian provides recordkeeping and reporting services for the Plan.

To be eligible to participate in the Plan, an employee of the company must be 18 years old and have completed 250 hours of service in a three-month period. The Plan allows eligible participants to enter the Plan on the first day of each month upon reaching eligibility. The Plan provides for 4% automatic enrollment. Employees covered by a collective bargaining unit and nonresident aliens are excluded from eligibility.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation (salary reduction contributions), as defined in the Plan and subject to IRS regulations. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan allows participants age 50 and older to make catch-up contributions.

The Company’s matching contribution is an amount equal to 25% of the participant’s contribution, not to exceed 4% of the participant’s annual compensation as defined under the Plan, subject to the Internal Revenue Service limitations. Eligibility for employer matching contributions is the same as that for employee participation. Additional Company profit sharing contributions may be contributed at the discretion of the Company’s Board of Directors (non-elective). No profit-sharing contributions were made for the years ended December 31, 2022 and 2021.

#### **Participant's Accounts**

Each participant's account is credited with the participant's salary reduction contributions, employer matching contributions, rollover contributions and an allocation of the Plan earnings (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balance, as defined in the Plan. A participant's investment allocation for current and future contributions can be changed on any business day at the discretion of the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their salary reduction contributions and any rollover contributions plus actual earnings thereon. Participants, who leave the Plan because of death, early or normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested. The Company's matching contributions, profit sharing contributions, and earnings thereon vest in accordance with provisions on the Plan as follows:

6 years and above	100%

For purposes of determining the extent to which a participant is vested, a year of service is a consecutive twelve-month period in which the participant is credited with 1,000 hours of service.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are determined by the Plan administrator but may not exceed five years. These loans are secured by the balance in the participant's account. The loans bear interest at 4.25% - 8.00% at December 31, 2022, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions. There were no loans in default at December 31, 2022 and 2021, respectively.

### **Payment of Benefits**

Benefits may be paid to the participant or beneficiary upon reaching age 59½, death, disability, normal retirement, termination of employment, or financial hardship, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or installments. Participants may withdraw a portion of their account balance for hardship and in certain "in-service" situations, as defined in the Plan

If a participant terminates employment and their vested balance is less than or equal to \$5,000 it will be distributed to the participant in a lump sum as soon as administratively feasible after termination of employment. There were no amounts allocated to a participant that elected to withdraw from the Plan but had not been paid as of December 31, 2022.

### **Forfeited Accounts**

At December 31, 2022 and 2021 forfeited nonvested accounts totaled \$15,998 and \$3,366, respectively. Forfeitures (unvested benefits) from terminated participants' accounts are used to reduce the Company's matching contributions, subject to the terms of the Plan. No forfeitures were used to reduce contributions for the years ended December 31, 2022 and 2021.

## ***NOTE 2: Summary of Significant Accounting Policies***

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to

transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/ (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses may be included in appreciation of fair value of investments.

#### **Subsequent Events**

The plan has evaluated subsequent events through June 12, 2023, the date the financial statements were available to be issued. Plan operational errors were identified during the 2022 plan audit. See Note 10.

#### ***NOTE 3: Information Certified by the Plan's Custodian***

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2022 and 2021, was

obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian. The contract value of the guaranteed investment contract was certified by the Custodian.

### ***NOTE 4: Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are adjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2      Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Pooled separate accounts:* Investments consist of pooled separate accounts made up of sub-accounts. Each sub-account invests solely in shares of a mutual fund (“the underlying fund”) which is stated at fair value based on the latest quoted market prices obtained by John Hancock Life Insurance Company. Investments are valued at the net asset value (NAV) of units of participation held by the plan at year end with indirectly observable prices for the underlying funds. Fair value of shares of an underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund.

#### **NOTE 5: Group Annuity Contract with John Hancock Life Insurance Company**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company (USA) (John Hancock) totaling \$42,139 and \$16,013 for 2022 and 2021, respectively. John Hancock maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. John Hancock is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed periodically for resetting. The crediting rates as of December 31, 2022 and 2021 were 0.53% and 0.35%, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at Contract Value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain withdrawal limitations are imposed on participant-initiated transfers between funds occurring within a twelve-month period. If the investment contract with the Custodian is discontinued, the value of the accounts will be paid at adjusted market value and liquidation charges may apply (liquidation value).

#### ***NOTE 6: Related-Party and Parties-In-Interest Transactions***

Certain Plan investments are shares in pooled separate accounts and annuity insurance contracts managed by the custodian of the Plan. Accordingly, any related transactions qualify as party-in-interest transactions. The custodian provides certain administrative services to the Plan and receives revenue from investment activity. The revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan.

If the revenue received by the custodian exceeds the amount owed under the custodial agreement, the custodian remits the excess to the Plan. The Plan or Plan Sponsor may make payment to the custodian for administrative expenses not covered by revenue sharing. The Plan may make direct payments to the third-party administrator and investment advisors which are not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the plan's operations.

#### ***NOTE 7: Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

### ***NOTE 8: Tax Status***

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, The Plan Administrator and the Plan’s tax counsel believe that the Plan, as amended, is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***NOTE 9: Risks and Uncertainties***

The Plan invests in various investments in guaranteed interest accounts and pooled separate accounts. These investments are subject to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### ***NOTE 10: Operational Error***

Plan operational errors were identified during the 2022 plan audit when the provisions of the Plan document were not properly applied and the Plan Administrator erroneously failed to implement several employees’ requested deferral percentages on a portion of the participants’ earnings and forfeited employer contributions in error. The Plan Administrator determined the effect and quantified the error, including lost earnings. The accompanying financial statements reflect receivables for Qualified Non-elective Employer Contributions of \$7,937 as of December 31, 2022, to correct these operational errors. In addition, contributions were remitted in error for the October 31, 2022 payroll cycle. This error is being corrected and reflects a receivable for those participants requiring additional contributions and a forfeiture liability for those that were overfunded. The net impact of the error was an overfunding of \$1,167.
