Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nesnah Management Corporation Employees Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Note 1: Description of Plan

The following description of the Nesnah Management Corporation Employees Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, excluding those that are leased, union members, and nonresident aliens, of Nesnah Management Corporation, Burrachos LLC, La Crosse Scale LLC, Star Blends LLC, WIScale LLC, Rogan Scale LLC, and CodaBow LLC, (collectively the "Employer") who are age 21 (age 18 beginning January 1, 2023) or older and have been employed for six months, during which time they complete a minimum of 500 hours of service. If the 500 hours of service requirement is not met, participants become eligible after one year of continuous service. Participants enter the plan quarterly. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants are allowed to make pretax, after-tax, or a combination of pretax/after-tax contributions to the Plan up to their full eligible compensation as defined by the Plan, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

For the year ended December 31, 2022, the Employer matched 50% of the participant's elective deferrals, not to exceed 6% of the participant's compensation, for a maximum possible contribution of 3% of a participant's compensation. The discretionary match is awarded once annually. In addition, the Employer may make a discretionary profit-sharing contribution to eligible Participants. In 2022, the Employer declared matching contributions of \$212,652 (which were funded during 2023) and no discretionary profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions and allocations of the Employer's discretionary profit-sharing contribution (if any), and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting and Forfeitures

A participant is fully and immediately vested in their contributions and rollover contributions, plus actual earnings thereon. A participant is vested in the Employer's matching and discretionary profit-sharing contributions and earnings thereon according to the following schedule:

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$27,032 and \$3,289, respectively. Forfeitures of nonvested participant balances are used to reduce Employer contributions or pay Plan expenses in accordance with the plan document. For the year ended December 31, 2022, \$8,500 of Plan expenses were paid from forfeited nonvested accounts.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, or upon separation from service with the Employer, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account or may receive required minimum distributions as required by the IRS. In-service withdrawals are also permitted from all vested accounts except for rollovers, provided the participant has attained age 59 ½.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income (Loss) Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Other expenses of maintaining the Plan paid by the Employer are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2023, which is the date the financial statements were available to be issued. Effective January 1, 2023, the Employer match payout was changed from a one-time annual contribution to a per pay period approach.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective investment trusts: Valued at the net asset value (NAV) of units of an investment trust fund. The NAV, as provided by the fund, is used to estimate fair value and is based on the fair value of the underlying assets and liabilities of the fund. Fund unit sales and repurchases occur on a daily basis at the NAV per share determined at close of each business day. As of December 31, 2022 and 2021, there were no unfunded commitments.

Note 4: Information Prepared and Certified by Plan Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and cash equivalents held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (RTC), the Custodian of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Transamerica Financial Life Insurance Company (TFLIC), the third-party administrator of the Plan; therefore, these transactions qualify as party-in-interest transactions. Direct fees incurred and paid by the Plan to TFLIC for certain investment management and administrative services were \$35,575 for the year ended December 31, 2022. The plan audit fee of \$8,500 was also paid by the Plan during 2022. Fees were offset by revenue sharing agreements in the amount of \$38,731.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer matching and discretionary profit-sharing contributions.

Note 7: Tax Status

The Employer adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
