Management has obtained a certification from Fidelity Management Trust Company, the trustee, as described in Note 1, as of December 31, 2022 and December 31, 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Basis for Opinion**

All plan assets were transferred from the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan to the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan by December 31, 2022. Our opinion has not been modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### **Note 1. Description of the Plan**

The following description of the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Ogletree, Deakins, Nash, Smoak & Stewart (the "Firm") who are full-time of counsel or associate attorneys or are employees of Ogletree Government Affairs, Inc., a subsidiary of the Firm, who are at least eighteen years of age. The Plan's entry date is the first day of any full pay period coincident with or following the date the employee satisfies rules for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Fidelity Management Trust Company (the "trustee").

#### Plan amendments

Effective January 1, 2022, the Plan was amended to include hardship distributions on account of a disaster declared by the Federal Emergency Management Agency (FEMA), pursuant to final Treasury Regulation Section 1.401(k)-1(d)(3).

#### Plan merger and transfer of plan assets

During 2022, the Plan transferred \$1,291,433 of funds from the Ogletree, Deakins, Nash, Smoak & Stewart 401(k) Savings Plan in conjunction with certain associate attorneys becoming shareholders during the year. These funds were placed into individual participants' accounts in the Plan based on their respective investment elections at the time of the transfer. During 2022, the Plan also received \$40,771 funds to the Ogletree, Deakins, Nash, Smoak & Stewart 401(k) Savings Plan.

Effective December 31, 2022, the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan was merged with the Ogletree, Deakins, Nash, Smoak & Stewart 401(k) Savings Plan. All plan assets totaling \$46,119,931 were transferred from the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan to the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan as of December 31, 2022.

#### Contributions

Each year, participants may contribute up to 50 percent of their eligible compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Firm may elect to make a discretionary contribution to the Plan. There was no discretionary contribution for the year ended December 31, 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Note 1. Description of the Plan, Continued

#### Participant accounts

Each participant's account is credited with the participant's contributions, Firm contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings. Vesting in the Firm's discretionary contribution portion of their accounts is based on years of service. A participant is 100 percent vested after one year of credited service.

#### Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The loans are secured by the balance in the participant's account. The loan interest rate is one percent above the prime rate. Principal and interest is paid ratably through payroll deductions.

#### Payment of benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 1/2. Account balances of less than \$1,000 will automatically be paid in a lump-sum distribution upon termination.

#### Forfeited accounts

The Plan requires that forfeited non-vested accounts first be used to reinstate previously forfeited account balances of retired former participants, if any. Then, the remaining forfeitures may be applied to pay the Plan's administrative expenses for the Plan year and further to reduce the Firm's discretionary contributions for the Plan year during which the forfeiture occurs. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$0, respectively. For the year ended December 31, 2022, there were no forfeitures used to reduce Firm contributions or used to pay administrative expenses.

#### **Note 2. Summary of Significant Accounting Policies**

##### *Basis of accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

##### *Payment of benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

#### Subsequent events

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

#### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

### Note 5. Related-party and Party in Interest Transactions

Certain Plan investments are managed by an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Certain fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator and investment advisor totaling \$21,074 which were not covered by revenue sharing. The Firm pays directly any other fees related to the Plan's operations.

### Note 6. Plan Termination

As discussed in Note 1, the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan merged into the Ogletree, Deakins, Nash, Smoak & Stewart 401(k) Savings Plan effective December 31, 2022. All plan assets were transferred from the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan to the Ogletree, Deakins, Nash, Smoak & Stewart Attorneys' 401(k) Savings Plan as of December 31, 2022. The merger does not impact participant benefits as the benefit provisions were incorporated in the Ogletree, Deakins, Nash, Smoak & Stewart 401(k) Savings Plan.

#### **Note 7. Tax Status**

The IRS has determined and informed the Firm by a letter dated January 21, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The plan administrator believes the Plan and trust are operating in a manner that does not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2022 statement of net assets available for benefits.

#### **Note 9. Plan Errors**

During 2022 and 2021, the Company inadvertently failed to deposit \$5,795 and \$11,144, respectively of participant contributions within the required timeframe as required by the DOL. The Company is correcting these remittances through the DOL's Voluntary Fiduciary Correction Program. The Company intends to file Form 5330 with payment of the applicable excise tax, which will be paid from the Company's general assets.
