We have performed audits of the financial statements of ECO Enterprises, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2022, and period August 1, 2021 through December 31, 2021, and the related notes to the financial statements.

December 31, 2022 and 2021

1. Plan Description

The following description of the ECO Enterprises, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution Plan covering all eligible employees of Eco Enterprises, LLC (“Eco” or “Company”). The Plan became effective on August 1, 2021. The Plan Administrator controls and manage the operations of the Plan. Reliance Trust Company (“Trustee”) is the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 “ERISA”, as amended.

Eligibility

Employees are eligible to participate in the Plan as of the first day of the next month following the employee’s completion of three months of service as defined in the Plan document.

Contributions

The Plan includes a 401(k) provision, which allows qualified employees to make contributions (through payroll deductions) to the Plan, thereby deferring taxation on the portion of their earnings contributed to the Plan. Employees can defer up to 100% of their annual compensation subject to Internal Revenue Code (“IRC”) maximum limitations. Employees who have attained age 50 before the end of the Plan year may also make additional catch-up contributions, subject to IRC limitations.

For each Plan year, the Company may contribute to the Plan, on behalf of each eligible participant, a matching contribution equal to a percentage of the eligible participant’s elective deferrals made. The Company shall determine the amount, if any, of the matching contribution. For the Plan year ended December 31, 2022, the Company made matching contributions totaling \$1,505. For the Plan period from August 1, 2021 to December 31, 2021, the Company made no matching contributions.

The Company, by action of its Board of Directors, may also make a discretionary profit-sharing contribution. Profit-sharing contributions are allocated to all participating employees credited with at least 1,000 hours of service in the Plan year, based on the ratio that the participant’s compensation bears to the total compensation of all eligible participants for the Plan year. No profit-sharing contributions were made during 2022 or 2021. Contributions are subject to certain limitations.

Notes Receivable from Participants

The aggregate amount of any loan to a participant may be, at a minimum, \$1,000 and may not exceed \$1,000. Participants may not have more than two loans outstanding at any one time. Loan terms vary, except when used for the purchase of a participant's principal residence, in which case the repayment period may extend to no more than 15 years. The participant's account balance secures the loan and bears interest at a rate commensurate to regional bank rates for similar loans. The participant pays principal and interest through weekly payroll deductions. The Plan treats loans to terminated participants and loans in default as distributions to the participant. Current loan policy limits the number of outstanding loans at any point in time to no more than two. At December 31, 2022 and 2021, the Plan had no loans to participants.

Vesting and Benefits

Participants are fully vested in contributions they make and the earnings thereon. Participants fully vest in the Company's matching contributions, and profit-sharing contributions, if any, and earnings thereon at the rate of 20% per year of service when the participant has worked at least 1,000 hours of credited service during the Plan year. A participant is always fully vested in prior matching contributions, which includes contributions that were made either (i) to the Plan under provisions that are no longer in effect or (ii) to another plan that merged into the Plan.

Upon retirement, death, or disability, participants or their beneficiaries are fully vested in all contributions and earnings. Retirement benefits are paid to the participant in a single, lump-sum payment. Hardship withdrawals by Plan participants may be made upon written request to and approval by the Plan administrator.

Investments

Reliance Trust Company ("Reliance Trust") is the trustee of the Plan. Reliance Trust invests Plan contributions and holds the assets of the Plan. Contributions are invested in various diverse mutual funds available to the participants of the Plan. Participant accounts are credited with their contributions allocated among the funds as requested. Employer contributions are invested based on the participant's allocation directions.

Participant Accounts

Each participant's account is credited with the participant's contributions and matching contributions by the Company. Plan investment results are allocated based on participant contributions, individual fund earnings or account balances, as defined. Forfeited, non-vested balances are used to reduce Employer contributions or pay qualified Plan expenses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Plan Termination

See Note 8 for a subsequent event relating to the termination of the Plan. Upon termination of the Plan, each participant becomes fully vested in the value of his or her account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. The preparation of financial statements on the modified cash basis requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets, additions to net assets, deductions from net assets and liabilities and disclosures of contingent liabilities, if any. Actual results could differ from those estimates and assumptions. Contributions are recorded when received, investment income is recorded as it is collected, and benefit payments and expenses are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The shares of mutual funds are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. The fair value of the participation units in common collective trusts is based on quoted redemption values on the last business day of the Plan's year-end. Participant loans, if any, are valued at their unpaid balances, which approximate fair value. Purchases and sales of securities are reflected on a trade-date basis. Interest income and dividends are recorded as received.

Administrative Expenses

Administrative expenses of the Plan are generally absorbed by the Plan. Fees for the years ended December 31, 2022 and 2021 were not significant.

3. Income Tax Status

The Plan was created by inclusion in a non-standardized pre-approved profit sharing/money purchase plan with cash or deferred arrangement ("Pre-Approved Plan"), which obtained its latest determination letter from the Internal Revenue Service on June 30, 2020. This latest determination letter stated that the Pre-Approved Plan, as then designed, was in-compliance with the applicable requirements of the IRC. The Pre-Approved Plan has been amended since receiving the determination letter. However, our Plan administrator and our Plan's tax counsel believe that the Pre-Approved Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in these Plan financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

4. Fair Value Measurements

ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2022 and 2021.

Mutual/Money Market Funds: Values are determined based on quoted market prices in active markets.

Common/Collective Trust Fund: The T. Rowe Price Stable Value Fund is held in common collective trust funds, which consist of investments in mutual funds, collective trusts and pooled separate accounts. The Principal Stable Value Fund, held in a common collective trust fund, invests in fully benefit-responsive guaranteed investment contracts. These investments are valued at their net asset values ("NAV") per share as of the close of business on the valuation date. The NAV is quoted on a private market that is not active; however, the unit price is based on the value of the underlying investment assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. There are no unfunded commitments, and the units may be redeemed on a daily basis. These investments are valued at the NAV of the units held by the Plan. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The Plan currently has no nonfinancial assets or liabilities that are recognized or disclosed at fair value on a recurring basis. Changes in fair value of investments held at the end of the period are reported in net depreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2022 and period from August 1, 2021 to December 31, 2021, the net amounts reported were depreciation of \$1,357 and \$22, respectively.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2022 and 2021. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

5. Party-in-Interest Transactions

For the periods ended December 31, 2022 and 2021, T. Rowe Price acted as a third-party administrator, providing services such as recordkeeping, participant account reporting and other administrative services. As such, T. Rowe Price is considered to be a party-in-interest to the Plan.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Subsequent Events

Plan Merger

Effective October 2, 2023, the Plan was merged into the PGT Savings Plan (the "PGT Plan"). Contemporaneously with the merger, the Plan was terminated. The PGT Plan is a defined contribution Plan covering substantially all eligible employees of PGT Innovations, Inc. ("PGTI"). Eco Enterprises, LLC, the sponsor of the Plan, is an indirectly wholly-owned subsidiary of PGTI.

Evaluation of Subsequent Events

The Plan Sponsor evaluated subsequent events for recognition or disclosure in the financial statements through October 4, 2023, the day the financial statements were available to be issued.
