Scope and Nature of the Erisa Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Buchanan Ingersoll & Rooney PC's Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2022 AND 2021

Note 1 - Description of Plan

The following description of the Buchanan Ingersoll & Rooney PC Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a profit sharing (defined contribution) plan, designed to be a tax-qualified retirement plan under the Internal Revenue Code, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers all eligible employees of Buchanan Ingersoll & Rooney PC (Buchanan), as defined in the Plan agreement, except for associate lawyers, Government Relations Advisors, senior attorneys, Government Relations Senior Advisors, staff attorneys, Special Counsel (AW), Special Counsel (CW), Counsel, Of-Counsel, law students employed as law clerks, nonresident aliens, leased employees, independent contractors, Government Relations Professionals, any person employed who performs an hour of service on an hourly basis on or after June 1, 2006, any person employed and classified as a temporary employee and eligible employees covered by a collective bargaining agreement. Effective March 31, 2009, the Klett Rooney Lieber and Schorling 401(k) Profit Sharing Plan (Klett Plan) was merged with the Plan. The Investment Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Plan Merger

Effective April 1, 2015, the Fowler White Boggs P.A. Profit Sharing Plan and the Fowler White Boggs 401(k) Plan (FWB Plans) were merged with the Plan. The plan sponsor for the FWB Plans became a wholly-owned subsidiary of Buchanan on March 14, 2014. Additionally effective April 1, 2015, the Plan was amended to provide for a Forfeiture Account. This account was established to account for the unapplied forfeiture balances which were merged into the Plan from the FWB Plans. This matter is further discussed in the Forfeitures section of Note 1.

Eligibility

Employees of Buchanan are eligible to participate in the Plan as soon as practicable following the date they first perform an hour of service. To receive an allocation of Buchanan’s contribution to the Plan, employees must have one year of service and attain the age of 21 with quarterly entry dates. Employment with a law firm corporate or business legal department, government service or government relations firm is credited towards the service requirement.

Contributions

The board of directors of Buchanan determines the amount (if any) of the employer profit sharing contribution. For the years ended December 31, 2022 and 2021, Buchanan elected to make discretionary contributions in an amount equal to 1% of compensation, as defined by Buchanan and the Plan document. Allocations of the employer profit sharing contribution are participant directed.

Additionally, a participant may make 401(k) contributions. After-tax voluntary contributions by participants under the Plan are permitted. Employees who are eligible to make elective deferrals under this Plan and who attain the age of 50 prior to the end of the plan year may make catch-up contributions to the Plan in accordance with IRC 414(v). Contributions are subject to certain IRS limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

A participant may elect to invest a portion of their share of plan contributions in life insurance policies.

Participant contributions and loan remittances are credited to participant accounts within the time period prescribed in Department of Labor Regulation Section 2510.3-102(b).

Participant accounts

Plan participants direct the investments of their accounts among the Plan's investment options and may at their discretion transfer amounts between such investment options. Buchanan (the Plan Sponsor) accounts for the interest of each participant in the respective funds in accordance with terms of the Plan. Each participant's account is credited with the participant's contributions as well as allocations of the Plan Sponsor's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Income and expenses of the funds are valued daily and allocated to the participants' accounts based on their interests in each particular fund. The Plan also allows for participants to have self-directed brokerage accounts. The self-directed investments include marketable securities, mutual funds, listed debt and equity securities, unique assets and life insurance policies. The qualified default investment alternative is an American Century Target Retirement Fund. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participants' (with the exception of the Klett Plan participants and the FWB Plans participants) profit sharing, 401(k) and after tax voluntary contributions are a 100% nonforfeitable vested interest in their accounts irrespective of years of service. The Klett Plan and FWB Plans participants are 100% vested after six years of service at a rate of 20% per year after the first year.

Notes receivable from participants

The Plan Administrator or designee may approve a loan to a participant in an amount not to exceed 50% of the value of such participant's accounts, with a maximum of \$50,000, as of the date of the loan. The minimum a participant can borrow is \$1,000. Interest is charged at commercially reasonable rates and is currently based on the prime rate plus 1% as determined at the time of loan application. Policy statements setting forth conditions and terms under which loans may be granted are periodically adopted by the Plan Sponsor. In the event of loan default, amounts are classified as deemed distributions and are presented as such in the deductions for net assets attributed to section of the statements of changes in net assets available for benefits. Principal and interest are paid ratably through monthly payroll deductions. The loans bear interest at various rates ranging from 4.25% to 8.00%. Loans must be repaid in level installments within five years. Repayment of the entire note receivable balance is permitted at any time. Loans are secured by participant accounts.

Rollovers

A participant may elect at the time and in the manner prescribed by the Plan Administrator to have a portion of an eligible rollover distribution paid directly to an eligible retirement plan as described in IRC Section 457(b). The Plan may receive any cash or property for the account of a participant directly from and attributable only to employer contributions under another tax-qualified retirement plan or individual retirement account. The Plan allows for transfers from qualified plans or rollover even if not yet a participant.

Benefit Payments

Upon termination of service or attainment of age 59-1/2, a participant may receive an amount equal to the value of the participant's vested account. Each participant's account will be paid to the participant or beneficiaries in a lump-sum, annuity, or installment payments upon death, disability, retirement, or other severance of employment with Buchanan. In certain circumstances, payment may be deferred. In addition, the Plan allows for hardship distributions if certain criteria are met. All requests by persons electing to withdraw their funds from the Plan were paid during the plan year. In the event that corrective distributions were made to pass Department of Labor compliance testing, they would be recorded as a reduction of contributions.

Forfeitures

Forfeitures result from participants who terminate employment before they are fully vested. The forfeitures are used to reduce future employer contributions. Forfeited nonvested plan contributions and earnings of \$1,764 were used to reduce employer contributions that were due for the plan year ending 2021 with funding occurring in September 2022.

Investment options

Upon enrollment in the Plan, a participant may direct participant contributions as well as the Company's contributions in various investment options. The Plan offers various mutual funds as well as equity securities, fixed income securities, insurance distribution fund, common trust fund, and other real estate and corporate investments. The trustee of the Plan is responsible for executing the participant directed investment transactions. Earnings are automatically reinvested into the fund or portfolio from which they were derived.

Note 2 - Summary of Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid. All requests by persons electing to withdraw their funds from the Plan were paid during the plan year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Plan expenses

Investment management fees, investment advisory fees, and operating expenses are charged to the Plan for investments in various funds that are deducted from income earned on a daily basis and are reflected as a component of net appreciation in fair value of investments.

Plan expenses (continued)

Certain administrative expenses of the Plan, including legal and insurance fees, are paid by Buchanan and, as such, are not reflected as expenses of the Plan. Administrative fees charged by the trustee are paid from the Plan and allocated to the participant accounts in accordance with the Plan document. Administrative fees paid by the Plan amounted to \$0 and \$123,624 for the years ended December 31, 2022 and 2021, respectively. Of the administrative fees, direct compensation totaling \$0 and \$54,634 for the years ended December 31, 2022 and 2021, respectively, were paid to trustees and investment advisors.

Subsequent events

The Plan has reviewed subsequent events through October 10, 2023, the date the financial statements were available to be issued. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles in the United States of America. Management has determined that there are no nonrecognized subsequent events that require additional disclosure.

COVID-19

On March 11, 2020, the World Health Organization designated COVID-19 as a global health pandemic. Various policies have been implemented by the Federal government that included the Coronavirus Aid, Relief and Economic Security Act (CARES Act). Enacted in March 2020, the CARES Act, provided for special distribution options and rollover rules for retirement plans and IRAs and expanded permissible loans from certain retirement plans.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds: The mutual funds classified as Level 1 are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Trust Fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund.

Insurance/Distribution Fund: Fair value is based on cash surrender value.

Self Directed Investments: Accounts consist of cash equivalents, mutual funds, common stocks, fixed income, hedge funds, certificates of deposit and bonds and bond funds. These investments are valued on the basis of readily determinable market prices. In addition, Self Directed Investments include certain unique assets such as partnerships, real estate, and other hard-to-value investments. Unique assets are valued using significant unobservable inputs requiring management judgment in an inactive market.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2022 and 2021, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 5 - Fiduciary Responsibility and Investment of Funds

Buchanan serves as administrator for the Plan. In accordance with its powers as Plan administrator, Buchanan has entered into trust and asset management arrangements with Newport Trust Company. Based upon participant elections, funds are invested in the various investment options. At December 31, 2022 and 2021, there were 0 and 35 self-directed participants, respectively. Newport Trust Company is responsible for preparing, maintaining, and allocating activity, to the individual self-directed participants' accounting records. Transactions with Newport Trust Company, custodian, are considered parties-in-interest transactions.

Note 6 - Plan-to-Plan Transfers

The plan-to-plan transfer is the recording of recordkeeping items between the Buchanan Ingersoll & Rooney PC Profit Sharing Plan, Pension Plan, and Retirement Savings Plan and between investment funds in the Plans and self-directed accounts.

Note 7 – Related Party Transactions and Party-in-Interest Transactions

Certain administrative functions of the Plan are performed by officers or employees of the company. No such officer or employee receives compensation from the Plan.

Note 8 - Plan Termination

Effective January 1, 2022, the following Buchanan Plans were merged into the Buchanan Ingersoll & Rooney PC Retirement Savings Plan: The Buchanan Ingersoll & Rooney PC Pension Plan and The Buchanan Ingersoll & Rooney PC Profit Sharing Plan. Following merger of all Plan assets, a resolution to terminate the Plan was adopted.

Note 9 - Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust, are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and/or DOL. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits and the changes in net assets available for benefits.
