Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Double E Company, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets Available for Plan Benefits as of December 31, 2022 and 2021, and the related Statement of Changes in Net Assets Available for Plan Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following description of the Double E Company, LLC 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution 401(k) plan covering all employees of Double E Company, LLC (the Employer), who are age 18 or older and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Ascensus Trust Company is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

Contributions

Participants may elect to contribute an amount or percentage of their compensation, not to exceed annual limitations as provided by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (participant rollovers).

The Employer, at its discretion, may make matching contributions to the Plan. The Employer provides a matching contribution of 50% of the first 2% of the participant's elective deferral of eligible compensation. During the years ended December 31, 2022 and 2021, the Employer made matching contributions to the Plan of \$119,498 and \$124,817, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's discretionary contribution and Plan earnings and losses. Allocations are based on participants' compensation or account balance, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus the allocation of Plan earnings on those contributions at the time of allocation. Participants become vested in the Employer contributions and the annual allocation of Plan earnings on those contributions as follows: 33% after one year, 66% after two years and 100% after three years.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested value of their accounts. Note terms range from 1 to 5 years or, up to 15 years for the purchase of a primary residence. The notes are secured by the participant's vested balance and bear interest at a rate ranging from 4.25% to 8.00%. Notes are repaid to the Plan through after-tax payroll deductions.

Payment of Benefits

Benefits are available for distribution upon retirement, death, disability or termination of employment with the Employer in a single lump sum distribution or, in periodic installments, as elected by the participant or beneficiary. In the event of termination for any reason other than retirement, death or disability, payment of vested benefits will be made by the Plan Administrator in accordance with the procedures described in the Plan. Hardship withdrawals from the Plan are also permitted subject to the applicable Internal Revenue Service (IRS) laws.

Forfeitures

When termination of participation in the Plan occurs, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are generally used to reduce future Employer contributions or pay Plan expenses. As of December 31, 2022 and 2021, forfeited non-vested accounts totaled \$15,740 and \$11,626, respectively. During 2022 and 2021, there were no forfeitures used to reduce Employer contributions or pay administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan invests in the Invesco Stable Value Retirement Fund (Invesco) common collective trust fund. The Plan's interest in the Invesco fund is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust at year end. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan Administrator and trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Contributions

Participant contributions are recorded bi-weekly when the Employer remits the payroll deductions for investment into the Plan.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Plan Termination

The Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts. On June 1, 2023, the Plan was merged into the Aon Pooled Employer Plan (Note 8).

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Fund: The Plan invests in the Invesco Stable Value Retirement Fund of Invesco Trust Company, a collective trust fund that invests in fully-benefit responsive investment contracts, government securities, pooled separate accounts and other investment companies. The fund is valued at the NAV of units of a collective trust. The NAV, as provided by Invesco Trust Company, is used as a practical expedient to estimate fair value.

The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Unit values are determined daily by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan; however, there is up to a 24-month redemption notice period for this investment at the Plan level.

As of December 31, 2022 and 2021, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Income Tax Status

In a letter to the Employer dated June 30, 2020, the IRS informed the Employer that it has determined that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been subsequently amended since receiving this letter. The Plan Administrator and the Plan's advisors believe that the Plan is designed, and is being operated in, full compliance with all applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by Ascensus, the recordkeeper of the Plan as an agent for Ascensus Trust Company, the trustee of the Plan:

6. Differences from Form 5500

Differences between the Annual Return/Report of the Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. At December 31, 2022 and 2021, total Plan assets are in agreement.

7. Related Party Transactions

Certain Plan investments are held and managed by Ascensus Trust Company. Ascensus is the recordkeeper of the Plan, as an agent for Ascensus Trust Company. Ascensus Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payment to Ascensus for investment management services of \$19,574 and \$15,720 for the years ended December 31, 2022 and 2021, respectively. Participant notes receivable also qualify as party-in-interest transactions.

8. Subsequent Events

On June 1, 2023, the Plan was merged into the Aon Pooled Employer Plan. In conjunction with the merger, total assets of approximately \$9,490,000 were transferred into the new plan, which included approximately \$92,000 of participant notes receivable.

The Plan Administrator has evaluated subsequent events through October 4, 2023, which is the date these financial statements were available to be issued.
