We have performed audits of the financial statements of GutCheck 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

**(1) Description of Plan**

The following description of the GutCheck 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of Brainyak, Inc. dba GutCheck (the “Company” and the “Plan Sponsor”), who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to the maximum amount allowed under the law based on pre-tax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a fixed interest investment option and various mutual funds as investment options for participants.

The Company may make discretionary matching and profit-sharing contributions to the Plan. There were no discretionary matching or profit sharing contributions during 2022. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant’s account. In 2022, the annual loan interest rate was 4.5%. Principal and interest is paid ratably through semi-monthly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or a direct rollover to another qualified retirement plan. In addition, hardship and in-service distributions are permitted if certain criteria are met. Corrective distributions are paid in the event a participant makes excess contributions to the plan during the year.

**(2) Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan were prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2022, distributions requested but not paid to withdrawing participants were \$0.

**Investment Valuation and Income Recognition**

The Plan's mutual fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Withdrawal fees and investment advisor fees are also charged directly to the participant's accounts and included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

**( 4 ) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**(5) Fully Benefit Responsive Investment Contract**

The Standard Stable Asset Fund is a guaranteed investment contract and meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The investment contract is recorded on the Statement of Net Assets Available for Benefits as investment at contract value.

**(6) Tax Status**

The Internal Revenue Service (IRS) has issued an opinion letter on the non-standardized pre-approved plan dated June 30, 2020, which states that the plan document is in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan, as amended, is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax exempt.

**(7) Related Party Transactions and Party in Interest Transactions**

Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment to the third party administrator of \$14,652 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**(8) Plan Termination**

In October 2022, the Plan Sponsor was acquired by Toluna, Inc., the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Plan management intends to transfer the Plan's assets to the acquirer. However, as of October 3, 2023 the Plan remained active. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**( 9 ) Commitments, Contingencies, Risks, and Uncertainties**

**Risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**( 10 ) Subsequent Events**

The plan has evaluated subsequent events through the date of the auditor's report which is the date the financial statements were available to be issued. Management determined there were no events or transactions that require recognition or disclosure in the financial statements.
