Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Tailored Companies, et. al. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tailored Companies, et. al. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by Massachusetts Mutual Life Insurance Company and Empower Annuity Insurance Company of America, qualified institutions, agrees to or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of Financial Statements section of our report. We are required to be independent of Tailored Companies, et. al. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

December 31, 2022 and 2021

(1) Plan Description

The following description of the Tailored Companies, et. al. Retirement Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all eligible employees of Tailored Chemical Products, Inc. and related entities ("Companies"). The related entities covered by the Plan are Tailored Foam, Inc., Southern Resin, Inc., Structural Materials, Inc., Stuart Forest Products, LLC, and Universal Finance, Inc. Newly eligible employees are eligible to enter the Plan on January 1 or July 1 after eligibility requirements are met coinciding with or next following the completion of 1,000 hours of service within twelve consecutive months of service and at least 21 years of age. Employees who have previously entered the Plan may change their deferrals at any time. The Plan was established in 1984 and was revised effective 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for the oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitors investment performance.

(b) Contributions

Participants elect to make contributions up to \$20,500 of their eligible compensation, as defined by the Plan. Participants can change or revoke their deferral percentage at any time. The Company may make a discretionary matching contribution that is determined each year. The matching contribution is a uniform percentage of salary deferrals. The Company may also make an additional discretionary profit sharing contribution each year. The discretionary profit sharing contribution is allocated based on compensation. During the years ended December 31, 2022 and 2021 the Company made a \$60,000 and a \$43,000 profit sharing contribution to the Plan, respectively.

(c) Participant Accounts

Each participant's account is credited with the employee's contribution, the employer's contribution, and an allocation of the plan earnings. Allocation of earnings is based on fund investments. Earnings are allocated on an annual basis. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions and earnings thereon. Vesting in the employer's matching contribution account plus earnings thereon is based on years of service as follows:

(e) Payment of Benefits

Upon separation of service, due to termination of employment, death, disability or retirement, a participant may receive a distribution in several forms. If the participant's account balance exceeds \$5,000, they may receive a distribution in a lump sum or in partial payments of not less than \$500 per payment. If the participant's account balance is less than \$5,000, they must receive a lump sum payment.

(f) Forfeitures

Upon termination of service, the nonvested portion of a participant's account becomes a forfeited amount. Forfeitures may first be used to pay any administrative expenses of the Plan. Any remaining forfeitures attributable to profit sharing contributions will be reallocated based on compensation, as defined by the Plan. Forfeitures attributable to matching contributions are used to reduce future matching contributions. Non-vested forfeitures used to reduce administrative expenses for the years ended December 31, 2022 and 2021, were \$1,537 and \$13,051, respectively. Unused forfeitures as of December 31, 2022 and 2021 were \$1 and \$2,616, respectively.

(g) Administrative Expenses

Administrative expenses of the Plan are paid out of Plan assets.

(1) Plan Description, Continued

(h) Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' balances will be distributed in accordance with the Plan document.

(2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Payment of Benefits

Benefit claims are recorded as expenses when they have been approved for payment and paid by the Plan. There were no benefits payable at December 31, 2022 and 2021.

(e) Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2022 and 2021 and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Massachusetts Mutual Life Insurance Company (“MassMutual”) and Empower Annuity Insurance Company of America (“Empower”).

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

(3) Fair Value Measurements, Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. These are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These investments are deemed to be actively traded.

(4) Investment Contract with Insurance Company

The Plan has investments in a fully benefit-responsive investment contract with MassMutual and Empower. MassMutual and Empower maintain the contributions in an unallocated fund. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

(4) Investment Contract with Insurance Company, Continued

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract value of the Empower investment contract at December 31, 2022 was \$81,398. The contract value of the MassMutual investment contract at December 31, 2021 was \$61,713. Contract value, as reported to the Plan by MassMutual and Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(5) Income Tax Status

The Plan adopted a standardized form of a prototype plan sponsored by Ascensus LLC. The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Internal Revenue Code (the "Code") to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

(7) Related Party Transactions

At December 31, 2022, Plan assets included investments in funds managed by Empower. Empower is the Plan's current custodian and, as such, transactions with the custodian qualify as party-in-interest transactions under ERISA. At December 31, 2021, Plan assets included investments in funds managed by MassMutual. MassMutual was the Plan's custodian as of December 31, 2021, and, as such, transactions with the custodian qualify as party-in-interest transactions under ERISA. Personnel and facilities of the Company have been used to perform administrative services for the Plan at no charge to the Plan.

(8) Nonexempt Transactions

During the year ended December 31, 2020, the Company inadvertently failed to remit one pay period of employee contributions to the Plan within the required time period as stated by the United States Department of Labor (DOL), and these late remittances were corrected during 2021. The following table summarizes the late contributions.

The Department of Labor considers late deposits to be prohibited transactions. The Plan sponsor filed Form 5330 and paid the applicable excise tax. The excise tax payments were made from the plan administrator's assets and not from the assets of the Plan. Lost earnings were remitted to the Plan by the Plan Sponsor.
