Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Smith & Howard, P.C. 1. DESCRIPTION OF THE PLAN

The following description of the Smith & Howard, P.C. Salary Deferral Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution 401(k) plan covering substantially all eligible employees of Smith & Howard, P.C. (the Plan Sponsor) (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Under the Plan, all employees become eligible when they reach the age of twenty-one, excluding those covered by a collective bargaining agreement, non-residents of the United States, leased employees, self-employed individuals, union employees and interns who have not completed one year of service. The Trustees and Plan Oversight Committee are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Plan Administrator.

b. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows for participants to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their accounts into various investment options offered by the Plan.

The Company may make both discretionary contributions and qualified discretionary contributions, which are subject to different vesting criteria.

Employees are eligible for the Company's discretionary non-elective employer contribution upon completion of 1,000 hours of service in the year and being employed at the end of the year. The Company's discretionary non-elective employer contribution for the year ended December 31, 2022, was approved as 9% to owners of the Company and 3% to non-owners of the Company. The Company made a discretionary non-elective employer contribution of \$729,889 for the year ended December 31, 2022.

Discretionary matching contributions match a portion of a participant's elected contribution, which is determined annually by the Trustees and Plan Oversight Committee, if the participant is employed at the end of the year. The Company did not make any discretionary matching contributions for the year ended December 31, 2022. The Company also did not make any discretionary qualified matching contributions or discretionary qualified non-elective employer contributions for the year ended December 31, 2022.

c. Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, if any, as well as allocations of the Company's discretionary non-elective employer contribution, the discretionary qualified matching contributions, discretionary qualified non-elective employer contributions, an allocation of Plan earnings and losses, and depreciation of investments, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are 100% vested in their own contributions, rollover contributions, discretionary qualified matching contributions, discretionary qualified non-elective employer contributions and earnings (losses) thereon. Participants vest in the Company's discretionary matching contribution and discretionary non-elective employer contributions based on years of service as follows:

2 years of service	20%
3 years of service	40%
4 years of service	60%
5 years of service	80%
6 or more years	100%

Participants become fully vested upon attainment of normal retirement age, death or disability.

e. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account. A participant may only have one loan outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, which can be up to 15 years. Interest rate is due on the outstanding principal balance at the prime rate plus one percent. Principal and interest are paid ratably through bi-weekly payroll deductions.

f. Payment of Benefits

Upon normal retirement at age 65 or termination of services, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance or leave their balance in the Plan if the balance is over \$5,000. The Plan requires balances up to \$5,000 be rolled over to an individual retirement account (IRA). There are also retirement benefits available upon disability or death.

f. Payment of Benefits (Continued)

The Plan allows in-service withdrawals upon attainment of age 59½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

g. Forfeitures

Forfeitures represent non-vested discretionary Company contributions forfeited by participants who terminate their employment or who withdraw from the Plan before completing six years of service. Forfeitures are retained by the Plan and are used to reduce future Company contributions and Plan expenses. The Plan had unallocated forfeitures of \$10,497 and \$17,115 as of December 31, 2022 and 2021, and used \$17,115 of forfeitures to reduce Company contributions during the year ended December 31, 2022. Subsequent to year end, the Plan Sponsor used \$19,850 of forfeitures to reduce the 2022 Company profit sharing contribution.

h. SECURE Act 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0 was executed. SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2022 financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's pooled separate accounts are stated at fair value. The guaranteed investment contract is reported at contract value. Units held by the Plan in the pooled separate accounts are based on each fund's daily net asset value (NAV), which is considered by the Plan Administrator to be the best approximation of fair value. Gains and losses are recognized as incurred upon sale or maturity of investments based on market value changes during the period. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the qualified institution. See Note 4 for disclosure of fair value measurement.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the participant's account and are included in administrative fees. Investment-related expenses are included in net depreciation of investments.

Subsequent Events

Subsequent events have been evaluated through October 9, 2023, which is the date the financial statements were available to be issued. Subsequent to year end, the Plan Sponsor adopted a restated non-standardized, pre-approved plan document, which changed the Plan name to the Smith and Howard Advisory LLC 401(k) Profit Sharing Plan, and changed the Plan's year end to October 31, 2023. There were no other events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.) (John Hancock), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2022, and the related investment transactions and investment income (loss) and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2022.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENT (Continued)

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled separate accounts: The pooled separate accounts are stated at the market value which equals the number of participation units owned in the subaccount multiplied by the unit value of the participation unit. The unit values of participation units in the subaccounts are determined by the qualified institution based on the value of the underlying mutual fund held in the subaccount, minus the fund's liabilities, which are the contract charges imposed by the qualified institution, divided by the number of participation units outstanding. This value is also commonly referred to as the NAV of the participation units, which is considered by Plan management to be a practical expedient to determine fair market value. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the pooled separate accounts will be sold for an amount different from NAV. As of December 31, 2022 and 2021, the Plan has no plans to sell the pooled separate accounts at an amount different from NAV. The daily charges imposed on these subaccounts for any valuation period are equal to the daily mortality and expense risk charge and the daily administrative charge multiplied by the number of calendar days in the valuation period. The value of each accumulation unit is published on the qualified institution's website each business day. There are no unfunded commitments from participants in the Plan who invest in these accounts.

There has been no change in the methodology used at December 31, 2022 and 2021.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Company believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) These funds are managed to meet a certain risk tolerance rather than a specific target date. These funds are generally labeled as conservative, moderate, and aggressive.
- (b) These funds invest mostly in common stocks of large capitalized companies, foreign securities, and derivative instruments. These funds also may invest in other securities, including convertibles, warrants, preferred stocks, corporate and government debt, bank loans and options.
- (c) These investments seek to allocate assets among equity, bond and money market funds based on its predetermined glide path as the fund approaches its target date, becoming more conservative prior to retirement, as time elapses.
- (d) These funds typically invest primarily in bonds or other debt securities. These funds generally seek to pay a distribution on a fixed schedule, though the payment amount is not guaranteed, may vary, and may be zero.
- (e) The primary objective of the funds is to maximize long-term total return by investing a broad range of equity, fixed income alternative asset classes in the U.S. and other markets throughout the world, both developed and emerging.
- (f) These funds invest in one type of industry or sector.
- (g) These funds invest primarily in common stocks of established U.S. companies that have above-average potential for capital growth. These funds also may invest in other securities, including convertibles, warrants, preferred stocks, corporate and government debt, bank loans and options.
- (h) The majority of these funds invest in small capitalization companies that are included in the S&P Small Cap 600 Index or Russell 2000 Index at the time of purchase.
- (i) These funds invest in a combination of equity securities and debt securities to achieve a long-term rate of return and capital appreciation.
- (j) The funds invest in real estate properties, other real estate-related investments, and securities. Underlying securities are generally priced using values obtained from independent pricing sources.

5. GUARANTEED INVESTMENT CONTRACTS

The Plan has guaranteed investment contracts with John Hancock. John Hancock maintains the contributions in a general account. The accounts are credited with participant contributions and investment income and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts' issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported by the qualified institution, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value. The contracts limit the percentage of the investment for periodic elective transfers to variable investments within the Plan during any twelve-month period.

The contracts are guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on the ability of John Hancock to meet its financial obligations from the general assets of John Hancock. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contracts do not permit John Hancock to terminate the agreement prior to the scheduled maturity date.

6. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

7. **PARTY-IN-INTEREST TRANSACTIONS**

Sections 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution, fees paid to the Plan's third-party administrator, and notes receivable from participants are considered party-in-interest transactions. During Plan year 2022, there were \$54,539 of administrative expenses paid to the qualified institution and third-party administrator by the Plan.

8. **TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated March 31, 2014, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the accompanying statements of net assets available for benefits.
