### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Accelaron Pharma Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – liquidation basis as of December 16, 2022 and December 31, 2021, the related statement of changes in net assets available for benefits – liquidation basis for the period from January 1, 2022 through December 16, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 16, 2022 and December 31, 2021 and for the period from January 1, 2022 through December 16, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Basis for Opinion**

**Emphasis of Matter**

As discussed in Note 6 to the financial statements, the Board of Directors of Acceleron Pharma, Inc., the Plan's sponsor, voted on November 11, 2021, to terminate the Plan, and management determined liquidation is imminent as of the effective date of November 18, 2021. As a result, the Plan is presented on a liquidation basis used in presenting both the 2022 and 2021 financial statements. Our opinion has not been modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. #### Note 1. Description of Plan

The following description of the Acceleron Pharma Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of Acceleron Pharma, Inc. (the Company or Sponsor). The Plan was originally established May 1, 2004 and was most recently amended effective January 1, 2020 to remove the service requirement for participants to qualify for the employer matching contribution. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA). The Compensation and Benefits Manager serves as the Plan Administrator (Plan Administrator).

Management of the Sponsor communicated the Plan termination to participants in November 2021 and fully vested all participants effective November 18, 2021. As such, management determined that the liquidation of the Plan was imminent. Therefore, the Plan's 2022 and 2021 financial statements are presented in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification 205, Presentation of Financial Statements: Liquidation Basis of Accounting. Final distributions were completed by December 2022.

**Eligibility requirements:** All employees of the Sponsor having attained the age of twenty-one (21) and who are not classified as nonresident aliens, leased employees, interns, or co-op employees are eligible for participation. To be eligible for the employer discretionary matching contribution and any profit sharing contributions, employees must attain the age of twenty-one (21).

**Participant contributions:** Each year, participants may contribute to the Plan a percentage that is equal to at least 1% of their compensation but not in excess of 100% of their compensation, as defined in the plan document and subject to limitation in accordance with federal regulations. Such contributions are deducted from the participant's pre-tax or post-tax earnings, whichever elected. Participants may subsequently elect to increase or decrease the rate of contributions at any time during the plan year. Participant contributions are subject to certain limitations as defined in the plan documents and in accordance with applicable regulations. As disclosed in Note 3, the Plan was frozen effective November 18, 2021. At such time, participant contributions ceased being accepted by the Plan.

**Employer contributions:** The Sponsor, at the discretion of the Sponsor's board of directors, may contribute discretionary matching and profit sharing contributions. For the period January 1, 2022 through December 16, 2022, there were no contributions made to the Plan. For the year ended December 31, 2021, the Company made a qualified matching contribution in an amount equal to 120% of employee contributions up to the first 10% of an employee's eligible compensation that an employee contributes, provided that the maximum contribution to any employee shall not exceed \$10,000.

Employer contributions are subject to certain limitations as defined in the plan documents and in accordance with applicable regulations. As disclosed in Note 3, the Plan was frozen effective November 18, 2021. At such time, employer contributions ceased being accepted by the Plan.

**Rollovers:** With the approval of the Sponsor, a participant may rollover or transfer any amounts held under other qualified plans provided that receipt of amounts does not adversely affect the qualified tax status of the Plan. A participant is 100% vested in his rollover contributions at all times and may withdraw these funds from the Plan at any time. As disclosed in Note 3, the Plan was frozen effective November 18, 2021. At such time, rollover contributions ceased being accepted by the Plan.

#### Note 1. Description of Plan (Continued)

**Participant accounts:** Each participant's account is credited with the participant's contribution, the matching employer contribution, profit sharing contributions and an allocation of plan earnings. Plan earnings are allocated based on the underlying investments in a participant's account. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** A participant's contributions, matching contributions, and earnings thereon are fully vested at all times. Under normal vesting circumstances, the profit-sharing contributions are 25% vested after one year of service, and an additional 25% vested each subsequent year until 100% vested after four years' service, as defined in the plan document. Any participant automatically becomes fully vested upon death, disability or attainment of age 65. As a result of the Plan termination, participants became 100% vested in their profit-sharing contribution balances effective November 18, 2021.

**Investment elections:** Each participant shall direct the investment of his or her own individual account and may select from several mutual funds and a collective trust. Each participant has the ability to change his or her investment allocations at any time.

**Benefit payments:** Upon termination of service due to retirement or disability, a participant may elect to receive either a lump-sum distribution equal to the value of his account or to defer receipt of his account balance, provided a distribution is made or commences no later than April 1 following the end of the calendar year in which the participant attains age 72. In the event of death, a participant's entire account balance will be distributed to his beneficiary. Distributions to participants who otherwise terminate employment will be deferred until age 65, unless the participant elects immediate payment or the participant's vested account balance is less than \$5,000. In such cases, the participant will receive a lump-sum distribution equal to the vested amount of his account. In-service withdrawals are permitted for certain financial hardships or when a participant attains age 59½.

In connection with the Plan termination, participants were able to elect a lump sum cash distribution, an eligible rollover to a qualified account such as an Individual Retirement Account (IRA) or a combination of a lump sum cash distribution and an eligible rollover. For participants that do not make an election by May 2, 2022, any account balances under \$1,000 were sent a cash distribution, and any account balances over \$1,000 were rolled over into an IRA.

**Forfeitures:** The non-vested portion of a participant's profit sharing contributions is tentatively forfeited after one year of severance, as defined in the plan document. If the participant is reemployed prior to five years of severance and repays the Plan an amount equal to the total distribution, the tentatively forfeited amounts without investment income will be reinstated. Amounts not reinstated serve to reduce future employer matching contributions are then to pay plan expenses. For the period from January 1, 2022 through December 16, 2022 and for the year ended December 31, 2021, no amounts were forfeited and there were no forfeitures available for use by the Sponsor.

**Notes receivable from participants:** A participant may borrow against their vested account balance. A participant's loan is limited to one-half of the value of their vested account balance not to exceed \$50,000. The minimum loan amount is \$1,000. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate equal to the prime rate as defined by the Wall Street Journal plus 1%, which is credited to the participant's account. A loan is required to be repaid through after-tax payroll deductions over a period not to exceed five (5) years, unless the purpose of the loan is to acquire a primary residence.

#### Note 1. Description of Plan (Continued)

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the Plan's Sponsor. No such officer or employee receives compensation from the Plan. The Plan's Sponsor pays all general administrative expenses of the Plan, except for the investment administrative costs associated with participant activity such as loan and distribution requests.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan have been prepared in accordance with accounting standards set by the FASB. The FASB sets U.S. generally accepted accounting principles (GAAP) to ensure net assets available for plan benefits and changes in net assets available for plan benefits are consistently reported. References to GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (FASB ASC).

As disclosed in Note 1, in connection with the termination of the Plan, the Plan's December 16, 2022 and December 31, 2021 financial statements are presented in accordance with FASB Accounting Standards Codification 205, Presentation of Financial Statements: Liquidation Basis of Accounting.

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition:** All investments in the statement of net assets available for plan benefits - liquidation basis as of December 16, 2022 and December 31, 2021 are reported at liquidation value due to the Plan termination discussed in Note 1. For all investments, fair value approximates the amount the Plan expects to collect at liquidation. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion on fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income is recorded on the liquidation basis. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 16, 2022 and December 31, 2021, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Income taxes:** GAAP requires plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2019.

#### Note 3. Plan Termination

Acceleron Pharma, Inc. was acquired by Merck & Co., Inc. on November 22, 2021. It was voted on November 11, 2021 and made effective November 18, 2021 for Acceleron Pharma, Inc. to terminate the Plan. At this time, the Plan Sponsor provided the trustee with a formal notice to liquidate the Plan and all elective deferral contributions made on behalf of participants or other employer contributions ceased and the plan became frozen. Upon termination, all participants became fully vested in their balances. The majority of the assets were liquidated in May 2022, however it was not fully completed due to a 12-month redemption period on the collective trust fund. The Plan was fully liquidated as of December 16, 2022.

#### Note 4. Information Prepared and Certified by Plan's Trustee

The following is a summary of the Plan's asset information as of December 16, 2022 and December 31, 2021 and the period from January 1, 2022 through December 16, 2022, included in the Plan's financial statements, that was prepared by or derived from information provided by the Fidelity Management Trust Company, the trustee. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements related to the following assets:

The trustee also certified to the completeness and accuracy of \$5,071,722 of net depreciation in fair value of investments, \$25,838 of interest and dividends related to the aforementioned plan investments and \$213 of interest earned on notes receivable from participants for the period from January 1, 2022 through December 16, 2022.

#### Note 5. Investments and Fair Value Measurements

**Fair value measurements:** GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 16, 2022 and December 31, 2021.

**Mutual funds:** Mutual funds are valued at quoted market prices. These securities are categorized as Level 1 as they are actively traded and no valuation adjustments have been applied.

**Collective trust:** These investments are valued using the net asset value (NAV) provided by the administrator of the fund based upon audited financial statements. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

In addition, the collective trust permits participant directed exchanges on a daily basis provided that the exchanges are not directed into a competing collective trust (money market fund and certain fixed income funds). With a competing collective trust, exchanges must be held in a non-competing investment option for 90 days before transfer into a competing collective trust can occur. #### Note 6. Party-in-Interest Transactions

Certain investment options are managed by Fidelity Management Trust Company, which also serves as the Plan's recordkeeper and trustee. Therefore, these transactions qualify as exempt party-in-interest transactions. Generally, investment options (other than mutual funds and publicly offered securities) may qualify as party-in-interest transactions if the issuer, investment manager, or trustee of the investment option is a plan fiduciary or service provider. The Sponsor pays certain administrative expenses of the Plan. The Plan issues loans to participants, which are secured by the balances in the participants' accounts, which also qualify as party-in-interest transactions.

#### Note 7. Tax Status

The Plan is a Fidelity Management Trust Company prototypical plan and is designed to operate in compliance with the applicable requirements of the IRC. The Plan obtained its latest opinion letter on March 31, 2014 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended and terminated since receiving this determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and is tax exempt.
