We have performed audits of the financial statements of The Daland Companies Employees' Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 3, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to October 3, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Daland Companies Employees' Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of the Plan

General

The following description of The Daland Companies Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by the Daland Corporation (the Plan Sponsor) for the benefit of its employees and its adopting affiliates who have at least 1,000 hours of service during the year and are at least 21 years of age. Related employers who also participate in the Plan include Captain Development Company, Inc.; Carolina Pizza Company, Inc.; Jonbro, Inc.; Mackinaw Food Service Corporation; Michigan Pizza Service Company, Inc.; Northfield Restaurant Corporation; Peru Pizza Company, Inc.; Triad Associates, Inc.; TriConn, LLC; Virginia Pizza Company, Inc.; YOLO, LLC and Kokomo Pizza, LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan's trustee is Reliance Trust Company, and the Plan custodian is Equitable Financial Life Insurance Company.

Contributions

The Plan permits eligible employees, through a salary deferral election, to have the Plan Sponsor make annual contributions of 2% up to 75% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Plan Sponsor contributions are discretionary as determined by the Plan Sponsor's Board of Directors. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, an eligible employee may elect to receive an amount equal to the value of his or her account in the form of a lump-sum payment or installments. If married, the account is required to be paid by joint and survivor annuity unless waived with mutual consent of the spouse.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less, only for circumstances documented in the Plan document. The loans are secured by the balance in the participant's account and bear interest at fixed rates of 1% above the prime interest rate published in the Wall Street Journal at the time of the loan. Principal and interest is paid ratably through payroll deductions.

Forfeited Accounts

At October 3, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$8,607, respectively. No amounts from forfeited nonvested accounts were used to reduce plan expenses and employer contributions in 2022 and 2021.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices are used to value investments. The Pooled separate accounts are valued at estimated fair value as provided by Equitable Financial Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Insurance company general account investment is valued at fair value. Fair value represents Plan's contributions and transfers to the option, plus interest, minus withdrawals and transfers out of the option, minus administration expenses.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan Sponsor or the Plan at the Plan Sponsor's discretion.

Note 3: Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Equitable Financial Life Insurance Company, the custodian of the Plan, has certified the following information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of October 3, 2022 and December 31, 2021.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period from January 1, 2022 to October 3, 2022 and for the year ended December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information except for comparing such information to the related information included in the accompanying financial statements.

Note 4: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are units of investments managed by Equitable Financial Life Insurance Company. Equitable Financial Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan Sponsor directly pays any other fees related to the Plan's operations.

The Plan paid approximately \$70,000 and \$96,000 of custodian expenses to Equitable Financial Life Insurance Company during 2022 and 2021, respectively. The Plan Sponsor provides certain administrative services at no cost to the Plan.

Note 5: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the period from January 1, 2022 to October 3, 2022 and for the year ended December 31, 2021. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy and included pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 7: Transfer of Plan Assets to Pooled Employer Plan

Effective September 1, 2022, the Plan merged into the Securian Pooled Employer Plan and Trust (Securian). At that time, Securian Financial, a business unit of Minnesota Life, started providing recordkeeping and administrative services to the Plan. On October 3, 2022, the Plan's assets were transferred out to Securian and were recorded as a transfer in the 2022 statement of changes in net assets available for benefits.

Note 8: Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Equitable Financial Life Insurance Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 9: Subsequent Events

Subsequent events have been evaluated through October 10, 2023, which is the date the financial statements were available to be issued.
