The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Select Express & Logistics 401(k) Plan and Trust – Plan B (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Established on February 1, 2019 and restated on January 1, 2021, the Plan is a defined contribution plan covering all employees of Select Express & Logistics, LLC and participating employers, which are all wholly owned subsidiaries of SEL Holdings, LLC (collectively, the Company), who are age 21 or older and have completed six consecutive months of service and are a member of the senior management team or classified as non-exempt. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The Select Express Benefits Administrative Committee (SEBAC) is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees.

Plan Merger

On December 18, 2021, AIT Worldwide Logistics, Inc. acquired the Company and in 2022, decided to merge the Plan into the AIT Worldwide Logistics, Inc. 401k Plan ("AIT Plan"). On January 3, 2023, the Plans merged into one plan under Section 414 (1) of the Internal Revenue Code of 1986, as amended, and the assets and liabilities of the Plan became assets and liabilities of the AIT Plan. Employees of the Plan have account balances equal to the balances each participant had in the Plan and the AIT Plan immediately prior to the merger. An aggregate of \$2,209,042 was transferred out of the Plan to the AIT Plan on January 3, 2023.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan, as pretax or Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a safe harbor matching contribution, discretionary nonelective contribution, and/or discretionary matching contribution each year. During 2022, the Company contributed a safe harbor matching contribution of 100% of the first three percent of compensation and 50% of the next two percent of compensation, which a participant contributes to the Plan, as defined by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of discretionary nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective and matching contribution portions of their accounts is based on years of continuous service. A participant vests

20% per year, beginning after the second year of credited service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate shall be reasonable, as defined, and range from 4.25% to 8.50% as of December 31, 2022. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as defined by the Plan. A participant who has attained the age of 59 ½ may elect to withdraw all or a portion of their account. A participant may obtain an in-service hardship withdrawal from his or her contributions subject to certain conditions and penalties as defined in the Plan.

Forfeited Accounts

As of January 3, 2023 and December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0, \$271 and \$0, respectively. These accounts may be used to pay Plan administrative expenses or to reduce future employer contributions. Also, in 2023 and 2022, no forfeited balances were used to pay Plan administrative expenses or as a reduction to employer contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. SEBAC determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 13, 2023, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2022 and 2021.

Pooled separate accounts: Valued at the net asset value (NAV) of the units of the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

4. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts managed by John Hancock Life Insurance Company of New York. John Hancock Insurance Company of New York is the custodian (see Note 8), as defined by the Plan; therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses.

5. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. As discussed in Note 1, the Plan merged with the AIT Plan on January 3, 2023.

6. TAX STATUS

The Company adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the IRS dated March 31, 2014. The letter states that the volume submitter plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The volume submitter sponsor, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company of New York (the custodian of the Plan).
