In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Millwright Employers Association/Millwright and Machine Erectors Money Purchase Pension Plan as of June 30, 2022 and December 31, 2021, and the changes in its net assets available for benefits for the six months ended June 30, 2022, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Millwright Employers Association/Millwright and Machine Erectors Money Purchase Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Plan Termination

As further discussed in note 4 to the financial statements, the Plan Trustees elected to merge the Plan with another plan, effective in June 2022. Contributions to the Plan ceased and the Plan asset were transferred to the new plan. As a result, the Plan changed its basis of accounting to the liquidation basis of accounting to present the December 31, 2021 and June 30, 2022 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Millwright Employers Association/Millwright and Machine Erectors Money Purchase Pension Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Millwright Employers Association/Millwright and Machine Erectors Money Purchase Pension Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Millwright Employers Association/Millwright and Machine Erectors Money Purchase Pension Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedule Required by ERISA**

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule Assets (Acquired and Disposed of Within the Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 – Description of Plan**

Millwright Employers Association/Millwright & Machine Erectors Money Purchase Pension Plan (the "Plan") is a defined contribution plan established by labor and employers through collective bargaining agreements and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** An employee will be eligible to become a participant in this Plan on his or her date of hire. Only those employees who are covered by the Collective Bargaining Agreement will be eligible to become participants in this plan.

**Employer Contributions:** The employer shall make contributions, which shall be credited to the participant's account in an amount specified in the collective bargaining agreement.

The effective contribution rates are \$5.00 per hour worked for the participants of Local 1607 (California), \$4.00 per hour worked for participants of Local 1914 (Arizona), and \$4.00 per hour worked for participants with Local 1607 (New Mexico).

The annual addition to the account of any participant shall not exceed the lesser of:

- a. \$61,000 as adjusted annually for increases in the cost of living; or
- b. 25% of the participants' compensation.

**Participant Contributions:** The Plan will not accept voluntary contributions from participants.

**Payment of Benefits:** The participants are fully vested at all times. Upon termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability or retirement (age 62), elect to receive installment payments monthly, quarterly, semiannually or annually. Withdrawals due to terminated participants are recorded on the date distributions are made.

**Plan Administrator:** The Plan is managed by the Plan Administrator as appointed by the Board of Trustees. The assets of the Plan are held under a custodial agreement with Pershing, LLC, a wholly owned subsidiary of the Bank of New York Mellon Corporation. The Plan has an Investment Agreement with First Republic Investment Management, Inc., under which it receives advisory services. The custodian agreement requires First Republic Bank to hold, administer and distribute the funds of the Plan in accordance with the Plan and instructions of the Plan Administrator. Most administrative expenses are paid by the Plan, and principally consist of fees paid for investment and administration services.

**IRS Determination Letter:** The Plan obtained a determination letter on November 18, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities.

**Note 1 – Description of Plan (Continued)**

**Termination Provision:** The Board of Trustees has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their account balances, and the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to participants in the order of their entitlement. See note 4,

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting:** The Plan’s financial statements have been prepared on the liquidation basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan’s investments are stated at fair value. The investments are valued at quoted market prices, which represent the net asset values of the investments held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Note 3 – Investments**

The Plan includes the investments of its participants, which are nonparticipant-directed. Investments are selected within the guidelines of the trust agreement. During the six months ended June 30, 2022, the Plan’s investments, including gain and losses on investments bought and sold, as well as the reversal of unrealized gain on loss recorded in prior years, decreased in value by \$3,079,800 as follows:

**Note 3 – Investments (Continued)**

**Fair Value Measurements:** The Company adopted ASC 820, *Fair Value Measurements and Disclosures*, effective January 1, 2008. ASC 820 does not require any new fair value measurements; instead it defines fair value, establishes a framework for measuring fair value in accordance with existing generally accepted accounting principles and expands disclosure about fair value measurements.

Assets and liabilities recorded at fair value are categorized based upon the level of judgment associated with the inputs used to measure the fair value. Level inputs, as defined by ASC 820, are as follows:

- Level 1 – quoted prices in active markets for identical assets or liabilities
- Level 2 – other significant observable inputs for the assets or liabilities through corroboration with market data at the measurement date
- Level 3 – significant unobservable inputs that reflect management’s best estimate of what market participants would use to price the assets or liabilities at the measurement date

As of June 30, 2022, the company had 0 balance in assets and liabilities.

**Note 4 – Plan Termination**

During the six months ended June 30, 2022, the Plan merged with another Plan, thus contributions ceased and the Plan assets were transferred out of the Plan, thus resulting in the Plan termination. Consequently, the Company adopted the liquidation basis of accounting.

**Note 5 – Subsequent Events**

The Plan has evaluated events occurring after the date of the accompanying statement of net assets available for benefits through September 19, 2023, the date the financial statements were available to be issued. The plan did not identify any material subsequent events requiring adjustment to or disclosures in the accompanying financial statements.
